RACE 1 : ACTION LINE MARKING HANDICAP - 1500 metres

ENKI (J. Kah) – became held up for clear running from in the vicinity of the 400 metres and thereafter approaching the 200 metres attempted a tight run between JUST A BIGGER DASH and GUNS LOADED, was unable to improve into this position as JUST A BIGGER DASH rolled in, was obliged to be steadied and shifted to the outside of JUST A BIGGER DASH to obtain clear running. Thereafter inside the 100 metres was inconvenienced by SOMETHING MORE, which shifted in under pressure. Rider explained her instructions were not to be positive early and to allow the gelding to settle in the early stages. She added that on straightening she was held up for clear running and initially considered improving to the outside of JUST A BIGGER DASH but was conscious of that gelding rolling out slightly and for that reason elected to improve to the inside of that runner, however, after doing so a run developed between JUST A BIGGER DASH and SOMETHING MORE. She further stated as she had committed to the run to the inside of JUST A BIGGER DASH, she was unable to immediately take that run and was obliged to restrain her mount shortly thereafter and shifted to the outside of JUST A BIGGER DASH to improve into that position.

SOMETHING MORE (J. Holder) – rider explained whilst he was comfortable with his position in running it was his opinion that the filly would have been better suited by a stronger pace in the early stages of the event. He added the filly finished the race off in a competitive manner. The connections have advised the filly would now be spelled. A post-race veterinary examination revealed no visible abnormalities.

JUST A BIGGER DASH (M. Poon) – rider reported the gelding laid in, in the straight.

FOREIGN FIGHTER (C. Lindop) – slow to begin losing two to three lengths.

RACE 2 : DAIMLER TRUCKS AUSTRALIA HANDICAP - 2500 metres

BULLITT COUNTY (M. Poon) – shifted out to improve approaching the 400 metres and brushed with TIME WALKER taking that gelding a little wider on the track. Rolled out approaching the 100 metres and brushed with TUNES, which rolled in.

ROBOCOP (J. Potter) – in the vicinity of the 200 metres raced in restricted room for a short distance between TIME WALKER and DUQUESSA, which shifted in.

TIME WALKER (D. Tourneur) – taken a little wider approaching the 400 metres and thereafter became held up for clear running when racing behind TUNES and to the inside of ROBOCOP and was unable to obtain clear running until in the vicinity of the 100 metres. Rider explained he was comfortable with the position he obtained in running, however, when the paced quickened inside the 600 metres, the gelding was at its top and was unable to quicken with the field. He added thereafter he had difficulty obtaining clear running in the straight for some distance. A post-race veterinary examination revealed no visible abnormalities.

DUQUESSA (E. Boyd) – re-saddled on arrival at the barriers.

Correct weight for this event was delayed to allow Stewards to view the vision over the concluding stages.

RACE 3 : ROADSIDE SERVICES AND SOLUTIONS HANDICAP - 1050 metres

SHOWPERO (M. Poon) – inside the 200 metres rolled out onto VIVALDI'S QUEST tightening that gelding onto TIME OUT, which was taken out onto GOLD DENARI, which rolled in slightly resulting in TIME OUT racing in restricted room for a number of strides having to be steadied and losing its position. Rider severely reprimanded and advised to take greater care when his mounts commence to shift ground in future.

TIME OUT (J. Holder) – tightened inside the 200 metres between VIVALDI'S QUEST and GOLD DENARI, was obliged to be steadied and unable to maintain its position.

VIVALDI'S QUEST (Z. Spain) – rider dislodged en route to the start, examined by the First Care Medical Personnel on arrival at the barriers and passed fit to ride. Contacted at the start. Rider reported the gelding hung out from in the vicinity of the 600 metres. Rolled out in the vicinity of the 500 metres contacted GOLD DENARI, turning that filly's hindquarters.

GOLD DENARI (M. Neilson) – inconvenienced at the start. Contacted in the vicinity of the 500 metres having its hindquarters turned. A post-race veterinary examination revealed no visible abnormalities.

AMATIVE (E. Boyd) – began awkwardly, shifted in contacted VIVALDI'S QUEST and thereafter shifted out onto GOLD DENARI, which was inconvenienced.

RACE 4 : PLUMBING AND PIPELINE SOLUTIONS HANDICAP - 1600 metres

IT AND A BIT (M. Poon) – raced keenly in the early stages of the event. Rider reported the gelding felt sore behind. A post-race veterinary examination revealed no visible abnormalities.

BURNRO (P. Gatt) – rider reported the gelding felt awkward in its action. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 5 : WYLIE DALZIEL RACING HANDICAP - 1050 metres

BALIGARI (D. Thornton) - a post-race veterinary examination revealed no visible abnormalities.

HOOK ME UP (C. Lindop) - a post-race veterinary examination revealed no visible abnormalities.

DEIHEROS (D. Tourneur) – raced wide without cover throughout the event.

RACE 5 : WYLIE DALZIEL RACING HANDICAP - 1050 metres (Cont'd)

MAASAI JUSTICE (E. Boyd) – rider reported the gelding was inclined to hang out during the event. A post-race veterinary examination revealed speedy cuts to the off hind hock.

RACE 6 : DELNORTH INTERNATIONAL HANDICAP – 1200 metres

MISS ADELE (P. Gatt) - slow to begin, failed to muster early speed and was unable to maintain contact with the field in the early and middle stages of the event. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Veterinary Certificate of Fitness required prior to trial or race.

BATTLE BREWING (C. Lindop) – inconvenienced near the 900 metres.

BOGGOMS (D. Tourneur) – shifted in near the 900 metres and inconvenienced BATTLE BREWING. Rider reminded of his obligations when shifting ground. Laid out over the concluding stages of the event.

BEAU RIVAGE (J. Kah) – held up for clear running from near the entrance to the straight until approaching the 200 metres, obliged to shift out to obtain clear running.

MR GOOD LOOKING (W. Kerford) - slow to begin.

RACE 7 : TONKIN CONSULTING HANDICAP - 1050 metres

The start of this event was delayed approximately nine minutes owing initially to BIG EFFORT having to be attended to by the Farrier when it lost its off hind plate at the barriers. The Farrier was unable to re-plate the gelding and was also not able to remove the near hind plate. Underwent a pre-race veterinary examination with a view to allowing the gelding to race without its off hind plate. Following the veterinary report, Stewards consulted with Trainer, Ms S Hayes and allowed BIG EFFORT to start. The race was further delayed owing to JUST PEGGY proving difficult to load.

JUST PEGGY (R. Hurdle) - Co-Trainer's Mr W. Francis and Mr G. Kent was advised a warning had been placed on the mare in relation to its barrier manners.

RACE 8: ADVANCED TRANSPORT REFRIGERATION HANDICAP - 1600 metres

RAISE A DREAM (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

SEGREGATION (M. Neilson) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

FREEDOM ROAD (R. Hurdle) – shifted out in the vicinity of the 300 metres and tightened SARAH'S WAY, which had to be steadied. Rider reprimanded and advised to take greater care when shifting ground in future.

TIA (NZ) (B. Claridge) - began awkwardly.

CHOSEN ANGEL (D. Tourneur) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Rider explained the mare did not finish the race off as expected and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

SARAH'S WAY (C. Lindop) – tightened in the vicinity of the 300 metres, had to be steadied and lost its position.
