**RACE 1 : UBET / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres**

**FILLY OF STEEL** (B. Griffiths) - a post-race veterinary examination revealed no visible abnormalities.

**SHOWMETHESUGAR** (E. Boyd) - a post-race veterinary examination revealed signs of a skin reaction consistent with an insect bite. First aid administered.

**SUSANNE'S GLEN** (A. Jordsjo) – stood flat-footed at the start. Laid in badly when placed under pressure in the vicinity of the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

**AUTUMN GRACE** (J. Maund) – over-raced in the early and middle stages of the event.

**SATELITE JEWELL** (K. Bishop) - slow to begin.

**RACE 2 : MAGIC FM/5CS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres**

**GOING NOWHERE** (Z. Spain) – over-raced in the early stages of the event.

**WITHIN RANGE** (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

**KASMARLAINE** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 3 : AIRMASTER AUSTRALIA / SABOIS MAIDEN PLATE – 1200 metres**

**LET'S TANGO** (R. Hurdle) - in the vicinity of the 100 metres was taken wider on the track by TEQUILA FLYER, which shifted out under pressure.

**WAKE UP BRIAN** (Z. Spain) - in the vicinity of the 100 metres was crowded for room by HE'S A VALLEYBOY, which shifted in.

**HE'S A VALLEYBOY** (D. Caboche) - in the vicinity of the 600 metres became awkwardly placed on the heels of QUICK BISCUIT. In the vicinity of the 100 metres laid in when placed under pressure in the straight crowding WAKE UP BRIAN in onto QUICK BISCUIT.

**TEQUILA FLYER** (T. Pannell) - in the vicinity of the 100 metres shifted out when placed under pressure. Rider reprimanded.

### **RACE 3 : AIRMASTER AUSTRALIA / SABOIS MAIDEN PLATE – 1200 metres (Cont'd)**

**QUICK BISCUIT** (L. Stojakovic) – raced wide without cover throughout the event. Laid out under pressure in the early stages of the straight. In the vicinity of the 100 metres shifted out making contact with the hindquarters of WAKE UP BRIAN. As a result, was taken back in across the heels of LET'S TANGO, which was severely hampered. FLYER. A post-race veterinary examination revealed skin laceration running down the near hind canon. First aid administered.

**WREAKED** (E. Boyd) - in the vicinity of the 100 metres was crowded for room by LET'S TANGO, which was taken out by TEQUILA FLYER, which shifted out under pressure.

### **RACE 4 : TAYLORS WINES BENCHMARK 64 HCP – 1200 metres**

**RED MENACE** (A. Jordsjo) – momentarily held up in the vicinity of the 200 metres and had to shift to the outside of FORCE OF THREE to improve into clear running.

**PROFOUND WISDOM** (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

**ASTRO VITA** (D. Tourneur) – late scratching at 8.32 am on veterinary advice.

### **RACE 5 : XXXX GOLD BENCHMARK 56 HANDICAP - 1100 metres**

**DOWNS AFTER DARK** (Z. Spain) - in the vicinity of the 800 metres had to be steadied to avoid the heels of OGUNDE, which shifted in when insufficiently clear and as a result shifted out and contacted LUNAR JOY.

**NORTH BEACH** (D. Caboche) – laid in when placed under pressure in the straight.

**OGUNDE** (D. Thornton) – in the vicinity of the 800 metres shifted in when insufficiently clear of DOWNS AFTER DARK. Rider reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**SAMBUCA SIREN** (S. Cahill) - in the vicinity of the 300 metres clipped heels and blundered after attempting a narrow run to the inside of OGUNDE. A post-race veterinary examination revealed a small skin laceration to near fore knee. First aid administered.

**GUILTY AS CHARGED** (A. Jordsjo) – laid in when placed under pressure in the straight.

**LITTLE JAY JAY** (K. Bishop) – laid in when placed under pressure in the straight.

**LUNAR JOY** (B. Griffiths) - in the vicinity of the 800 metres was hampered after DOWNS AFTER DARK shifted out when avoiding the heels of OGUNDE.

### **RACE 6 : TAMINGA HOTEL CLARE VALLEY CUP - 1800 metres**

**ONE FOR MAX** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**BEAU'S MY BOY** (D. Tourneur) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. Rider reprimanded for leaving the jockey room without permission. A post-race veterinary examination revealed no visible abnormalities.

**BOYS GETAROUND HIM** (E. Boyd) – hung out rounding the home turn and in the vicinity of the 300 metres became awkwardly placed on the heels of SAVANERO.

**RACE 7 : JIM BARRY WINES BENCHMARK 56 HANDICAP - 1800 metres**

**SHA LA LA** (S. Cahill) – when questioned rider stated he was able to take up a mid-field position in accordance with the mare’s racing pattern. He added in the vicinity of the 1400 metres the mare resented racing to the inside of CENTRE DIVIDER, which was over-racing and as a result was forced to race further back than intended. He further stated in the vicinity of the 800 metres he placed the mare under pressure but was disadvantaged in having to circle the field and cover extra distance. A post-race veterinary examination revealed no visible abnormalities.

**CENTRE DIVIDER** (E. Boyd) – over-raced in the early and middle stages of the event.

**GRAND ARROW** (P. Gatt)- began awkwardly. Held up for clear running in the vicinity of the 400 metres to inside the 300 metres.
