**Report on Race Meeting held at Morphetville Parks Racecourse  
by the South Australian Jockey Club on Saturday, 14 January 2017**

**RACE 1 : MEDALLION HOMES HANDICAP - 1950 metres**

**BARGE AND CHARGE** (A. Jordsjo) – pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$300. In determining penalty Stewards had regard for her use of the whip over the final 100 metres of the event and considered in this circumstance that they could not provide any leniency in penalty. Rider reprimanded under AR137(b) for failing to ride her mount to the line. Stewards were satisfied that A. Jordsjo's failure to ride to the line over the final two strides did not affect the placings in the race. A post-race veterinary examination revealed no visible abnormalities.

**ON A DREAM** (E. Boyd) – a post-race veterinary examination revealed no visible abnormalities.

**HAVE PLENTY** (J. Holder) – raced wide without cover in the middle stages of the event.

**BALF'S CHOICE** (T. Pannell) – rolled out approaching the 200 metres tightening SMACKWATER JACK, which was inconvenienced. Rider reminded of his obligations when shifting ground.

**SMACKWATER JACK** (M. Neilson) – inconvenienced approaching the 200 metres.

**SILENT ELATION** (J. Kah) – raced wide without cover in the middle stages of the event.

**DAWN OF HOPE** (D. Tourneur) – contacted at the start.

**SEARAVEN** (D. Caboche) – jumped away awkwardly, shifted out and contacted DAWN OF HOPE.

**RACE 2: SCHWEPPE'S MAIDEN PLATE – 1000 metres**

The start of this event was delayed approximately four minutes initially owing to the runners arriving late at the barriers and thereafter owing to MINT ON MOSELEY proving very difficult and refusing to load.

**ARTFUL JACK** (A. Jordsjo) – jumped away awkwardly, shifted out and contacted SO SKILLED. Inconvenienced shortly after the start. A post-race veterinary examination revealed no visible abnormalities.

**FROM FIFTH** (J. Cartwright) – raced greenly during the event and hung out over the concluding stages.

## **RACE 2: SCHWEPPE MAIDEN PLATE – 1000 metres (cont'd)**

**MINT ON MOSELEY** (D. Holland) – refused to load. Late scratching by order of Stewards at 2.49 pm. Trainer, Mr G. Osborne, was advised that in view of MINT ON MOSELEY's refusal to load into the barriers it was now suspended and must load to the satisfaction of Stewards in an Official Barrier Trial prior to accepting for a future race.

**PUJOLS** (T. Pannell) – held up for clear running from approaching the 400 metres until inside the 300 metres.

**SO SKILLED** (J. Holder) – jumped away awkwardly, shifted in and contacted ARTFUL JACK. Inconvenienced shortly after the start.

**ADDIE LANE** (M. Neilson) – became awkwardly placed on the heels of runners in the vicinity of the 450 metres and thereafter was held up for clear running from in the vicinity of the 400 metres until near the 300 metres and was obliged to shift out to obtain clear running.

**CERRO BLANCO** (D. Thornton) – over-raced in the early stages of the event. Raced greenly throughout the event. Blundered for no apparent reason in the vicinity of the 100 metres and was untested to the line thereafter. D. Thornton reported when the filly blundered near the 100 metres he was of the view it might have broken down and for that reason did not ride his mount out to the finish. A post-race veterinary examination revealed no visible abnormalities.

**CROSS WITNESS** (J. Toeroek) – rider reported the filly raced greenly during the event. Held up for a short distance near the 400 metres and thereafter had difficulty obtaining clear running from approaching the 200 metres until near the 100 metres.

**FLASH HUSSY** (E. Finnegan) – shifted out shortly after the start inconveniencing HARLEM CHILD, which was taken out onto ARTFUL JACK, which in turn was taken out onto SO SKILLED. Hung out throughout the event.

**HARLEM CHILD** (M. Poon) – inconvenienced shortly after the start.

**SHE'S STARSTRUCK** (D. Tourneur) – had difficulty obtaining clear running rounding the home turn.

## **RACE 3 : JOHN 'ARKWRIGHT' EDWARDS 90TH HANDICAP - 1250 metres**

**BEAUTIFUL FLYER** (E. Boyd) – slow to begin losing one to two lengths. Raced wide rounding the turn near the 1000 metres. Inconvenienced near the 700 metres. Pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$300. In determining penalty Stewards had regard for her use of the whip over the final 100 metres of the event and considered in this circumstance that they could not provide any leniency in penalty.

**NOT SO LADY LIKE (NZ)** (M. Poon) – raced wide rounding the turn near the 1000 metres. Shifted in near the 700 metres and crossed the running of BEAUTIFUL FLYER, which was momentarily inconvenienced. Rider reminded of his obligations when shifting ground.

**DEANNA JEAN** (J. Potter) – a post-race veterinary examination revealed a laceration to the front of the near hind cannon. First aid administered.

**MISS MURRA** (J. Cartwright) – contacted at the start. A post-race veterinary examination revealed no visible abnormalities.

**MOLLY THE SNIP** (J. Kah) – jumped away awkwardly, shifted in and contacted MISS MURRA.

**SOCIAL MEDIA** (A. Jordsjo) – a post-race veterinary examination revealed no visible abnormalities.

## **RACE 4 : UBET HANDICAP - 1000 metres**

**RIZIZ** (A. Jordsjo) – held up for clear running from in the vicinity of the 400 metres until near the 200 metres.

#### **RACE 4 : UBET HANDICAP - 1000 metres (cont'd)**

**HARD ROMP** (E. Boyd) – rider reported that the gelding may have jarred up during the event and did not stretch out in the straight. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr C. Maher, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**ALABAMA MISSILE** (M. Poon) – laid out over the concluding stages.

**SPATHA** (J. Kah) – which had not raced since December 2015 underwent a pre-race veterinary examination on arrival on course and was passed fit to start.

**READY SUNSHINE** (T. Pannell) – was held up for clear running from in the vicinity of the 400 metres and had difficulty obtaining clear running shortly after the entrance to the straight for a short distance. Laid in, in the straight. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

#### **RACE 5 : HUGHES CHAUFFEURS LIMOUSINES HANDICAP - 1400 metres**

**CHAPEL CITY** (A. Jordsjo) – when racing awkwardly on the heels of runners shifted out in the vicinity of the 700 metres and inconvenienced **WASABI BOB**. Rider reprimanded under AR137(a) for shifting ground when insufficiently clear. Laid in throughout in the straight and contacted **PENINSULA LINKS** just prior to the winning post becoming slightly unbalanced. A post-race veterinary examination revealed no visible abnormalities.

**WASABI BOB** (J. Holder) – inconvenienced near the 700 metres. A post-race veterinary examination revealed no visible abnormalities.

**PENINSULA LINKS** (M. Neilson) – laid out throughout in the straight. Contacted **CHAPEL CITY** just prior to the winning post and became unbalanced.

Correct weight for this event was delayed to allow A. Jordsjo, the rider of, and Mr G. Richards, the trainer of **CHAPEL CITY**, placed second, to view the vision in the straight. After doing so A. Jordsjo lodged an objection against **PENINSULA LINKS** (M. Neilson), being declared the winner on the grounds of alleged interference over the final 100 metres of the event. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

#### **RACE 6 : QUAYCLEAN HANDICAP – 1400 metres**

**SANZIO** (M. Poon) – A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr D. Saxon, advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**WISE JOURNEY** (J. Holder) – over-raced in the early stages of the event.

**SIMPATICO** (J. Potter) – held up for clear running for a short distance near the entrance to the straight and thereafter was held up again over the concluding stages.

**NUTHERBOTTLEGONSKI** (J. Toeroek) – rider reported the gelding hung out during the event. A post-race veterinary examination revealed no visible abnormalities.

**SATURDAY MAGIC** (S. Price) – rider reported the mare hung out during the event. A post-race veterinary examination revealed no visible abnormalities.

**JESTWIN** (J. Cartwright) – over-raced in the early stages of the event.

#### **RACE 7 : HOLDFAST INSURANCE HANDICAP - 1550 metres**

**PRINCE HARADA** (J. Holder) – began awkwardly.

### **RACE 7 : HOLDFAST INSURANCE HANDICAP - 1550 metres (cont'd)**

**IT AND A BIT** (M. Poon) – rider dislodged en route to the barriers. M. Poon was examined by the First Care Medical personnel on arrival at the barriers and passed fit to ride.

**MAIL IT IN** (E. Boyd) – tightened at the start and lost its position. Held up from near the entrance to the straight until approaching the 200 metres and was obliged to shift in to obtain clear running. E. Boyd explained it was her intention to settle more forward but owing to the manner in which the gelding began and being tightened shortly after the start she was obliged to settled back. She added that shortly after the entrance to the straight she was unable to obtain clear running and was conscious of the position of PRINCE HARADA to her outside and was obliged to shift in across the heels of several runners to obtain clear running. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 8 : MAC: STOP DRUG DRIVING HANDICAP - 1250 metres**

**DEBEERSONUS** (S. Price) – rider reprimanded for failing to ride his mount to the line over the concluding stages.

**GO THE JOURNEY** (M. Poon) – contacted inside the 200 metres by SENIOR COUNCIL, was severely hampered and taken out onto HOUSE OF WAX contacting that gelding.

**HOUSE OF WAX** (J. Holder) – hung out during the event. Contacted inside the 200 metres by GO THE JOURNEY, which was taken out by SENIOR COUNCIL, became unbalanced and rider became unseated for approximately three strides before regaining his seat.

**CALL ME CURTIS** (D. Thornton) – held up for clear running from in the vicinity of the 400 metres until shortly after the entrance to the straight.

**SENIOR COUNCIL** (J. Cartwright) – which had not raced since October 2015 underwent a pre-race veterinary examination and passed fit to start. Shifted out acutely from approaching the 200 metres and inside the 200 metres contacted GO THE JOURNEY, which was severely hampered and taken out onto HOUSE OF WAX, which was contacted, unbalancing that gelding and resulting in J. Holder becoming unbalanced and unseated. Rider pleaded guilty to a charge under AR137(a) for reckless riding. The particulars of the charge being that whilst riding SENIOR COUNCIL in Race 8 at Morphetville Parks on Saturday, 14 January 2017 he directed and rode his mount outwards in a reckless manner at an acute angle with the intention of making contact with runners to his outside and in doing so contacted GO THE JOURNEY inside the 200 metres, resulting in that horse being severely hampered and taken out onto HOUSE OF WAX, resulting in that horse becoming severely unbalanced and J. Holder becoming unbalanced and losing his seat, falling to the nearside of his mount before regaining his seat a number of strides thereafter. Stewards adjourned the matter on penalty for further consideration. However, J. Cartwright was stood down from all riding activity with immediate effect. A post-race veterinary examination revealed no visible abnormalities.
