STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Ceduna Racecourse
by the Ceduna Racing Club on Saturday, 14 January 2017

RACE 1 : CEDUNA CHEMPLUS / CEDUNA HOME TIMBER & HARDWARE / SABOIS MAIDEN PLATE
- 1000 metres

AL ZAFIR (W. Kerford) – rider reported the gelding was reluctant to stride out. A post-race veterinary examination revealed swelling over the lateral splint bone of the left foreleg.

ROMULUS FLIGHT (P. Roff) – shifted in on jumping away contacting WHITE LINE FEVER.

WHITE LINE FEVER (J. Huxtable) – contacted on jumping away.

CAPTAIN OASIS (J. Mamat) – inclined to lay in under pressure in the straight.

ARTFUL IGGY (C. Davies) – inclined to lay in under pressure in the straight.

ELECTIVE (D. McWhinney) – rider reported the filly resented the kick back and was reluctant to stride out. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms T. Harrison, was advised that a warning was placed on ELECTIVE for being uncompetitive.

RACE 2 : FLINDERS PORTS BENCHMARK 60 HANDICAP - 1000 metres

No report.

RACE 3 : TOYOTA AUSTRALIA FEATURE SPRINT - 1200 metres

The start of this event was delayed approximately five minutes.

COSMIC KHELEYF (J. Huxtable) – inclined to lay out under pressure in the straight.

MORADO (J. Mamat) – struck the perimeter fence en route to the barrier. Underwent a pre-race veterinary examination and passed fit to start. Inclined to lay out under pressure in the straight. Rider reprimanded under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres. In determining penalty Stewards had regard for his use of the whip over the final 100 metres of the event. Trainer, Ms T. Harrison, was advised that a warning was placed on MORADO in relation to its pre-race manners.

SWEET NEVER (C. Davies) – a post-race veterinary examination revealed an injury to the near fore tendon. Trainer, Mr C. Cox, was advised that a Veterinary Certificate of Fitness was required prior to accepting for a future trial or race.

RACE 4 ; THEVENARD IGA BENCHMARK 54 HANDICAP - 1300 metres

FINNISS MOMENT (J. Huxtable) – rider pleaded guilty to a charge under AR137(c) in that he made a celebratory gesture prior to the winning post and fined \$250.

RACE 4 ; THEVENARD IGA BENCHMARK 54 HANDICAP - 1300 metres (cont'd)

STRAVINSKA (P. Crich) – a post-race veterinary examination revealed the mare to have bled from one nostril. Trainer, Mr B. Lear, was advised that STRAVINSKA would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race in accordance with AR53A.

ROCK OUT (W. Kerford) – slow into stride.

RACE 5 : CEDUNA FORESHORE HOTEL CEDUNA CUP - 1600 metres

A CHILLER (J. Huxtable) – rider reported the mare never travelled during the event and was off of the bit from in the vicinity of the 600 metres.

VALUE AS (J. Mamat) – rider reported the gelding over-raced during the event.

THE HARD WAY (T. Zanker) – slow into stride. Rider reported the mare resented the kick back and was reluctant to improve behind runners. She added that on straightening she was able to get to the outside of the field and the mare finished off the event well.

RACE 6 ; WCT RURAL BENCHMARK 54 HANDICAP – 1600 metres

VOODOO BLACK MAGIC (P. Roff) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

TOUGH POACHER (J. Huxtable) – rider reported that the gelding resented the kick back during the event and was reluctant to improve behind runners. A post-race veterinary examination revealed no visible abnormalities.

EXALTED FEATURES (C. Davies) – rider reported the mare resented the kick back during the event and was reluctant to stride out. He further added that in his opinion the mare was not suited to today's track conditions. A post-race veterinary examination revealed no visible abnormalities.
