**RACE 1: SOUTH AUSTRALIA.COM BREEDERS' STAKES - 1200 metres**  
**(Run on the main track)**

**REDCORE** (T. Sadler) – rolled in at the entrance to the straight, contacted **SPLIT LIP** and thereafter had difficulty in obtaining clear running for a short distance. A post-race veterinary examination revealed no visible abnormalities.

**MIGHTY MICK** (J. Toeroek) – hung in, in the straight. Lost its near fore plate during the event.

**SPLIT LIP** (J. Kah) – contacted at the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**MY BAD** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 2: MAX BASHEER 90TH BIRTHDAY HANDICAP – 1400 metres**

**MUNICIPALITY** (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**CHAVUMA** (J. Holder) – over-raced in the early and middle stages of the event. Inside the 600 metres was inconvenienced and lost its momentum when awkwardly placed on the heels of **HAZY LANE**, which knuckled.

**GOOSE GREEN** (Z. Spain) – became awkward in its action behind when making the turn inside the 600 metres resulting in this horse's off hind leg making contact with the near foreleg of **HAZY LANE**.

## **RACE 2: MAX BASHEER 90TH BIRTHDAY HANDICAP – 1400 metres (Cont'd)**

**MISS JOOLIA** (R. Clark) - slow to begin. Inside the 100 metres became awkward for a stride on the heels of NEW SUMMER NIGHT as that horse rolled out. Obligated to be steadied and shifted out to improve her position.

**HAZY LANE** (J. Toeroek) – inconvenienced at the start. Inside the 600 metres was accidentally struck by the off hind leg of GOOSE GREEN, which became awkward in its action behind, resulting in HAZY LANE knuckling and being severely hampered. Thereafter was held up for clear running from approaching the 200 metres until near the 100 metres. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**BAKER'S DOZEN** (E. Finnegan) – Trainer Mr W. Clarken advised Stewards prior to the event that he would instruct his rider to attempt to obtain cover, having regard for the wide barrier and the fact that blinkers had been removed as gear from the mare.

**OLIVIA'S GOLD** (R. Hurdle) - a post-race veterinary examination revealed the mare to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**DANTE'S FINALE** (J. Fry) – rider momentarily dropped his off side rein near the 100 metres.

## **RACE 3: SCHWEPPE OAKS 6TH MAY HANDICAP - 2400 metres**

**JIM'S JOURNEY** (D. Caboche) – over-raced in the early stages of the event.

**GOLDSTREAM (ITY)** (D. Lane) – held up for clear running from inside the 500 metres until approaching the 200 metres.

**PUCCINI (NZ)** (S. Fawke) – raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**MAJESTIC MOMENT** (P. Gatt) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SASSY JO** (Z. Spain) – over-raced in the early stages of the event. Rider reported the mare hung in, in the straight.

## **RACE 4: DARLEY GOODWOOD 20TH MAY HANDICAP - 1000 metres**

**BAY ROAD** (D. Caboche) – in the vicinity of the 300 metres shifted out to improve and tightened RUGGED ANGEL onto ENTRANCING, which was inclined to lay in, resulting in RUGGED ANGEL having to be steadied. Rider was reprimanded and advised to take greater care when shifting ground.

**BRIMARVI PRINCE** (J. Toeroek) – lost its off fore plate during the event.

**FINE MIST** (J. Holder) – slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**ALABAMA MISSILE** (S. Fawke) – rider reported the mare appeared not to handle the underfoot track conditions and was off the bridle throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**ITZ INVINCIBLE** (J. Kah) – began awkwardly, shifted out and contacted CALIANCO.

**ENTRANCING** (E. Finnegan) – began awkwardly. Rider reported the mare was inclined to lay out and felt sore in the near foreleg on pulling up. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**RUGGED ANGEL** (J. Potter) – obligated to be steadied when tightened near the 300 metres and was unable to maintain its position.

#### **RACE 4: DARLEY GOODWOOD 20TH MAY HANDICAP - 1000 metres (Cont'd)**

**CALIANCO** (A. Jordsjo) – began awkwardly, shifted in and contacted ITZ INVINCIBLE. Rider reported the mare felt awkward in its action in front on pulling up. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

#### **RACE 5: UBET SA DERBY 13TH MAY HANDICAP - 1300 metres**

**CHESTNUT CHARLIE** (A. Jordsjo) – began awkwardly. Approaching the 1000 metres raced in restricted room for a short distance between ATLANTIC CITY to the inside and BELUGA BLUE to the outside.

**ATLANTIC CITY** (D. Oliver) – momentarily inconvenienced in the vicinity of the 200 metres and was obliged to alter course to the outside of BELUGA BLUE as that horse shifted in to improve. Thereafter was unable to improve its position inside the 100 metres for a short distance when racing behind SULLIVAN BAY. A post-race veterinary examination revealed no visible abnormalities.

**BELUGA BLUE** (C. Lindop) – shifted in, in the vicinity of the 200 metres to improve its position.

**BROWN BEN** (D. Thornton) – in the vicinity of the 1000 metres when being restrained, got its head up, raced ungenerously for a short distance and became awkward on the heels of AUTUMN SUNSET. A post-race veterinary examination revealed no visible abnormalities.

**COUNTER SPIN** (R. Clark) – raced wide without cover throughout the event.

**CREANCE** (J. Kah) – slow to begin.

#### **RACE 6: HOLDFAST INSURANCE CITY OF ADELAIDE HANDICAP – 1400 metres**

**KENJORWOOD** (D. Lane) – held up from near the entrance to the straight until approaching the 200 metres.

**MUBAKKIR** (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**EVANGELIST (GB)** (J. Kah) – slow to begin losing two to three lengths. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**BEST FORTUNE** (D. Thornton) – severely hampered in the vicinity of the 300 metres.

**JUST RESTING** (A. Jordsjo) – approaching the 300 metres commenced to tire, rolled in onto BEST FORTUNE, which was severely hampered.

#### **RACE 7: H C NITSCHKE STAKES - 1400 metres**

**CHAPEL CITY** (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

**FOX HALL** (D. Thornton) – Trainer Mr T. McEvoy advised Stewards prior to the event he would instruct his rider to ride the gelding more patiently from the barrier. Following the running of Race 5, Trainer Mr T. McEvoy approached Stewards and advised he wished to have the gelding revert back to its normal racing pattern and not avail himself of the change of tactics advised earlier, owing to his assessment of the racing pattern in the earlier races, and the manner in which he perceived the track was racing. Stewards acceded to his request to now instruct D. Thornton to ride the gelding positively in the early stages.

**SWIPE ME RIGHT** (Z. Spain) – inside the 1000 metres rolled out, contacted and turned the hindquarters of CAPPADOCIA and as a consequence was hampered and became severely unbalanced and lost ground. As a result, CAPPADOCIA was taken out slightly inconveniencing WEATHER CHANNEL, WATERLOO SUNSET and GOGO GRACE, which were all taken wider. Inside the 200 metres was obliged to steady when taken out by CAPPADOCIA, which shifted out to improve. As a consequence, SWIPE ME RIGHT had to alter course to the inside of CAPPADOCIA to obtain clear running. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 7: H C NITSCHKE STAKES - 1400 metres (Cont'd)**

**WEATHER CHANNEL** (D. Oliver) – inconvenienced at the start and was taken wider inside the 1000 metres.

**ZUNBAQA** (P. Gatt) – taken out over the concluding stages by WEATHER CHANNEL, which shifted out to improve and momentarily crossed the running of POSH JOURNEY.

**POSH JOURNEY** (R. Hurdle) – began awkwardly, shifted out at the start and inconvenienced WEATHER CHANNEL. Inconvenienced over the concluding stages.

**PLENTY TO LIKE** (C. Parnham) – rider reported as a consequence of his mount hanging out at various stages, he was unable to make an early run from in the vicinity of the 600 metres and had to ride patiently for a short distance before improving his position.

**WATERLOO SUNSET** (J. Holder) – taken wider inside the 1000 metres. A post-race veterinary examination revealed no visible abnormalities.

**HECTOPASCAL (NZ)** (D. Lane) - a post-race veterinary examination revealed no visible abnormalities.

**GOGO GRACE** (C. Lindop) – over-raced in the early stages and taken wider inside the 1000 metres.

**VIENNA MISS** (J. Maund) – began awkwardly, shifted in and contacted SMART MANOEUVRE.

**SMART MANOEUVRE** (T. Pannell) – contacted at the start.

**CAPPADOCIA** (B. Claridge) – inside the 1000 metres had its hindquarters turned and near the 700 metres brushed the inside running rail. Inside the 200 metres shifted out under riding and crossed the running of SWIPE ME RIGHT, which had to be steadied. Rider severely reprimanded for shifting ground when insufficiently clear.

### **RACE 8: #SEESOUTH AUSTRALIA CHAIRMAN'S STAKES - 2030 metres** **(Run on the main track)**

**MORVADA** (J. Toeroek) – at the entrance to the straight laid in and shifted in onto ANGELUCCI (NZ), which shifted in and away from that horse onto SAYONARAMOSA (NZ), which was hampered and had to be steadied. Rider reminded of his obligations when shifting ground.

**GRAND CHANCELLOR (NZ)** (N. Callow) – shifted in under riding over the concluding stages and tightened BILLET DOUX, which had to be steadied and as a consequence, was untested to the line. Rider was severely reprimanded for shifting ground when insufficiently clear.

**SCREAMARR** (J. Kah) – raced in restricted room over the concluding stages and was untested to the line. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Veterinary Certificate of Fitness required prior to trial or race.

**WAGING WAR** (C. Lindop) – began awkwardly and shifted out onto VOLATILE MIX (NZ) tightening that horse onto ADATTO (NZ), which began awkwardly and shifted in at the start. As a consequence, VOLATILE MIX (NZ) lost its position and ADATTO (NZ) became severely unbalanced and lost ground. Laid in, in the straight.

**SAYONARAMOSA (NZ)** (P. Gatt) – had to be steadied near the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

**VOLATILE MIX (NZ)** (D. Lane) – lost its position at the start.

**ADATTO (NZ)** (D. Moor) – severely hampered at the start, resulting in D. Moor becoming unbalanced in his seat and losing his position.

**NETHERFIELD (NZ)** (D. Oliver) – held up for clear running from near the entrance to the straight until near the 300 metres and thereafter over the concluding stages was untested to the line when unable to obtain clear running.

**RACE 8: #SEESOUTH AUSTRALIA CHAIRMAN'S STAKES - 2030 metres (Cont'd)**

**ANGELUCCI (NZ)** (J. Bowditch) – shifted in and away from MORVADA near the entrance to the straight.

**BILLET DOUX** (S. Cahill) – inconvenienced over the concluding stages, had to be steadied and was untested to the line.

**BARSHONTI** (E. Finnegan) – over-raced for a short distance near the 1800 metres and commenced to tire and lost ground rounding the home turn.

**DOMESTICATED** (J. Holder) – held up for clear running from near the entrance to the straight until inside the 300 metres.
