RACE 1: RAY WHITE KEATLEY SABOIS MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately two minutes.

HANLON TIGER (R. Hurdle) – in the vicinity of the 200 metres was momentarily inconvenienced as NATLIRUTH, which was racing greenly, rolled in.

AHIGA (J. Potter) - jumped away awkwardly.

ASTROBELLE (H. McKechnie) – raced greenly in the early and middle stages of the event.

JUST WANTO RUN NOW (C. Collins) – from shortly after the entrance to the straight until in the vicinity of the 200 metres was momentarily held up and shifted out wider on the track to gain clear running. Stewards questioned the rider in relation to her shifting to the outside of DISCONI, when in the opinion of Stewards there appeared to be a run to the inside of DISCONI and outside of GLENANAAR LADY. Rider explained in her opinion she had already committed to the run to the outside of DISCONI when rounding the home turn, however, that mare was inclined to roll out marginally and therefore she was obliged to go out with DISCONI. Rider was advised in future she needs to be more open minded and to ensure she allows her mounts every possible chance in the race.

NATLIRUTH (J. Luxe) – raced greenly in the straight and in the vicinity of the 200 metres rolled in onto HANLON TIGER, which was momentarily inconvenienced.

GLENANAAR LADY (J. Bowditch) - slow to begin.

RACE 2: CARAMAR BUSLINE SABOIS MAIDEN PLATE – 1400 metres

CEIBO (S. Cahill) – a late scratching at 11.34 am owing to the Trainer having difficulties transporting the gelding to the race course.

TRUVACC (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

ALLEGIANT (C. Puls) – inclined to race keenly and got its head up on a number of occasions in the early and middle stages of the event.

BRINGME THE BUTLER (K. Bishop) - a late scratching at 11.34 am owing to the Trainer having difficulties transporting the gelding to the race course.

ALI ORPHAN (NZ) (K. Walters) – bumped at the start as AUTUMN GRACE jumped away awkwardly and shifted in.

AUTUMN GRACE (A. Jordsjo) - jumped away awkwardly, shifted in and bumped ALI ORPHAN (NZ). a post-race veterinary examination revealed no visible abnormalities.

RACE 3: P & L LIVESTOCK & REAL ESTATE BENCHMARK 56 HANDICAP - 1300 metres

RUBY LANE (D. Thornton) – rider reported in his opinion the mare did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

CRYSTAL GLASS (P. Gatt) – marginally slow to begin.

TAHNEE TIARA (A. Jordsjo) - slow to begin. Rider reported in her opinion the filly did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

CAVALRY GOLD (E. Finnegan) - in the vicinity of the 100 metres was disappointed for a number of strides when attempting a tight run between JUST A SINGER and LINDSAY ALFRED.

RACE 4: COOPER'S BREWERY BENCHMARK 60 HANDICAP - 1100 metres

HELANDY (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

STAR PLANET (H. McKechnie) - a post-race veterinary examination revealed no visible abnormalities.

BROAD SHOULDERS (J. Bowditch) – inside the 1000 metres was tightened and bumped with GRETA AFFAIR as COOLIDGE shifted out.

DADDY'S LITTLELADY (J. Potter) – inside the 200 metres rider accidentally dropped his whip and was reprimanded under AR137(a) for carelessness in dropping his whip.

COOLIDGE (K. Bishop) – inside the 1000 metres shifted out and bumped BROAD SHOULDERS, which was tightened onto GRETA AFFAIR.

RACE 5: JOHN CHAY AND CO. BENCHMARK 64 HANDICAP - 1700 metres

HOLLY HOLY (NZ) (K. Walters) - a post-race veterinary examination revealed no visible abnormalities.

WICKED PROMISE (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

MYRIAD MISS (E. Finnegan) – rider reported in her opinion the mare did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: BYRNE TRAILERS - STAINLESS STEEL LIVESTOCK TRAILERS SPRINT - 1100 metres

RHYTHMATIC (R. Hurdle) – inclined to lay in under pressure in the straight.

STREETCAR VALOUR (K. Crowther) – rider reminded of her obligations in relation to riding her mounts out to the finish.

CAPTAIN PARKER (NZ) (P. Gatt) – inclined to rear on jumping away. On return to the mounting yard the gelding appeared to have blood in its mouth. When exiting the mounting yard was struck by another runner to the off foreleg. A post-race veterinary examination revealed small laceration to the off side shoulder. First aid administered.

RACE 7: 3MP STEEL ROOFING & FENCING SUPPLIES MILLICENT CUP - 2100 metres

EVENMOREACTION (S. Cahill) – inclined to lay in under pressure in the straight.

HASTA LA THOMAS (J. Bowditch) – rounding the home turn was obliged to be eased when tightened onto EVENMOREACTION as SATURDAY SORCERER shifted out. Had difficulty in obtaining clear ground from in the vicinity of the 200 metres until in the vicinity of the 100 metres.

MR JOURNEYMAN (L. Doodt) – rider pleaded guilty to a charge under AR137(c) in that she made a celebratory gesture prior to the winning post and was fined \$200.

SATURDAY SORCERER (E. Finnegan) – rounding the home turn shifted out onto HASTA LA THOMAS, which was obliged to be eased when tightened onto EVENMOREACTION. Rider severely reprimanded and advised to ensure she is sufficiently clear prior to shifting ground in future.

CASTLE HACKETT (NZ) (J. Potter) - slow to begin.

BELLA SPOSA (P. Gatt) - slow to begin.

TONS OF DASH (C. Collins) – appeared to slip on jumping away.

RACE 8: DIGIORGIO FAMILY WINES BENCHMARK 72 HANDICAP - 1400 metres

TULCEA (NZ) (K. Walters) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

ROMANEE VINCE (NZ) (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.
