Report on Race Meeting held at Clare Racecourse
by the Gawler & Barossa Jockey Club on Sunday, 14 May 2017

RACE 1: VIN'S BUSES / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

The start of this event was delayed approximately two minutes owing to BARSHONTI having to be re-plated on arrival at the barriers.

JAGARNA (J. Kah) – laid in when placed under pressure in the straight.

BARSHONTI (D. Tourneur) – had to be reshod on arrival at the barriers. Underwent a pre-race veterinary examination and passed fit to start. Laid in when placed under pressure in the straight. Lost its near front plate during the event. A post-race veterinary examination revealed no visible abnormalities.

BLAZING CHEERS (Z. Spain) – a post-race veterinary examination revealed no visible abnormalities.

CHASE THE STORM (B. Griffiths) – began awkwardly and was slow to begin.

RACE 2: TERRACE FUNCTION CENTRE GAWLER / SABOIS 2YO CLASS 1 HANDICAP – 1100 metres

BAJAN (P. Gatt) – slow to begin.

AMBISHOP (D. Thornton) – slow to begin. Raced greenly when placed under pressure in the straight.

COUNTERPLAY (B. Claridge) – laid out rounding the home turn. Raced greenly when placed under pressure in the straight.

EXALTED GLORY (B. Griffiths) – laid out rounding the home turn.

ONLINE GIRL (D. Tootell) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

DEXTINY (D. Tourneur) – momentarily held up for clear running in the vicinity of the 300 metres.

RACE 3: KINGSFORD HOTEL GAWLER / SABOIS MAIDEN PLATE - 1200 metres

AWKWARD SILENCE (A. Jordsjo) – held up for clear running on entering the straight.

THE HOFFICER (J. Potter) – in the vicinity of the 600 metres had to be restrained after improving onto the heels of AWKWARD SILENCE. Over-raced for a short distance thereafter.

RACE 3: KINGSFORD HOTEL GAWLER / SABOIS MAIDEN PLATE - 1200 metres (cont'd)

EXPLOSIVE GIFT (D. Thornton) – lost its near hind plate in running.

RHYTHM AND BLUE (B. Claridge) – when questioned regarding the improved performance of the gelding trainer, Mr C. Bieg, stated that in his opinion the gelding failed to handle the Port Augusta surface at its last start and has benefited from the addition of a senior rider.

WINTERS WAR (S. Cahill) – in the vicinity of the 600 metres shifted out abruptly hampering ADDIE LANE, after improving onto the heels of GRACEFUL INTENT.

GRACEFUL INTENT (S. Fawke) – in the vicinity of the 600 metres had to be restrained after improving onto the heels of THE HOFFICER.

ADDIE LANE (E. Finnegan) – in the vicinity of the 600 metres had to be restrained to avoid the heels of WINTERS WAR, which shifted out abruptly.

RACE 4: GOLDIN FARMS / BAROSSA CUP - 1800 metres

No report.

RACE 5: COOPERS BENCHMARK 56 HANDICAP - 1800 metres

SEEK TO DESTROY (S. Price) – laid in when placed under pressure in the straight.

DOWNUNDER PRINCE (B. Claridge) – late scratching on Veterinary Advice at 2.23 pm after being short in both front legs. Trainer, Mr G. Kluske, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

DUCHOVNY (J. Kah) – held up for clear running on entering the straight. A post-race veterinary examination revealed the horse to be lame in the off hind leg. Trainer, Mr G. Carter, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

SHADE OF GREEN (J. Potter) – over-raced in the early stages of the event.

RACE 6: COCA-COLA / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP - 1200 metres

LEAHONE (J. Maund) – over-raced in the early stages of the event. When questioned regarding the performance of the mare J. Maund stated that his mount began well but raced keen in the early stages. In the vicinity of the 800 metres when he began to place his mount under pressure he became concerned with the action of the mare and he elected not to place the mare under full pressure over the concluding stages. A post-race veterinary examination revealed blood in the right nostril of the mare. Trainer, Mr D. Magro, was advised that the mare would be required to gallop 1000 metres in the presence of a Steward prior to a future race or trial.

MAZUREK (R. Clark) – in the vicinity of the 900 metres was awkwardly placed between LEAHONE, which was over-racing, and JOY FLIPPER.

SOU SOUNI PRINCESS (B. Claridge) – a post-race veterinary examination revealed no visible abnormalities.

DUTTON BAY (J. Potter) – laid in when placed under pressure in the straight.

RACE 7: CRABB SHELLGRIT BM 56 HANDICAP - 1200 metres

MASTER BLACK (A. Jordsjo) – underwent a pre-race veterinary examination after not starting for twelve months and was passed fit to start. Laid in on entering the straight and in the vicinity of the 50 metres brushed SHA LA LA on a number of occasions.

RACE 7: CRABB SHELLGRIT BM 56 HANDICAP - 1200 metres (cont'd)

OUTLAW (S. Fawke) – hampered on jumping away. Rider pleaded guilty to a charge under AR137A(4)(c) in that he used his whip when out of contention and fined \$100.

VICTOR VICTOR (V. Wong) – began awkwardly and shifted out making contact with OUTLAW.

ROAN CHEVAL (NZ) (R. Clark) – laid in on entering the straight. Held up for clear running over the concluding stages of the event.

BOURDAIN (K. Crowther) – held up for clear running throughout the straight and was unable to be fully tested in the run to the finish.

SHA LA LA (Jemma Frew) – laid out when placed under pressure in the straight and in the vicinity of the 50 metres brushed MASTER BLACK on a number of occasions.

RACE 8: TREASURY WINES ESTATE CLASS ONE HANDICAP - 1100 metres

CAPTAIN PARKER (NZ) (P. Gatt) – laid in when placed under pressure in the straight. Raced in restricted room over the concluding stages of the event.

ROSIE LOUISE (J. Kah) – in the vicinity of the 700 metres was taken in onto CLASSY CARMEN by NAUGHTY RABBIT, which shifted in. In the vicinity of the 50 metres had to be restrained to avoid the heels of WINDSOR CUP, which shifted out when insufficiently clear. Raced in restricted room over the concluding stages.

NAUGHTY RABBIT (R. Clark) – in the vicinity of the 700 metres shifted in taking ROSIE LOUISE in onto CLASSY CARMEN. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer, Mr C. Bieg, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

WINDSOR CUP (A. Jordsjo) – laid out rounding the home turn. In the vicinity of the 50 metres shifted out when insufficiently clear of ROSIE LOUISE. Rider severely reprimanded.

GARNACHA (V. Wong) – held up for clear running in the straight.

CLASSY CARMEN (K. Bishop) – in the vicinity of the 700 metres was hampered by ROSIE LOUISE, which was taken in by NAUGHTY RABBIT.
