RACE 1: WOODSTOCK / SABOIS MAIDEN PLATE - 1050 metres

MIDNIGHT STORM (S. Price) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

OUR WITNESS (J. Kah) – inclined to lay out rounding the home turn. Pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

REWARDABLE (J. Toeroek) – slow to begin. Raced greenly in the early and middle stages of the event.

SWISS DESIGN (J. Bowditch) - pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

WHISTLING MIKADO (Z. Spain) – laid in under pressure in the straight.

RACE 2: AUSSIE RIPPER ROAST / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1400 metres

DELIVERY DAY (R. Clark) – jumped away awkwardly and shifted in bumping HOLD MY HELMET. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.

COOL FONZY (J. Holder) – performed below expectations. Underwent a post-race veterinary examination which revealed no visible abnormalities.

PUJOLS (C. Lindop) – raced keenly in the early and middle stages of the event. From the entrance to the straight for a short distance was held up for clear running.

BIG BAD BROWN (P. Gatt) – bumped on jumping away when SUPER SWOOP jumped away awkwardly and shifted out.

HOLD MY HELMET (R. Hurdle) – bumped on jumping away when DELIVERY DAY jumped away and shifted in.

SUPER SWOOP (T. Pannell) – jumped away awkwardly and shifted out bumping BIG BAD BROWN. Laid out under pressure in the straight.

UNFLYNNCHING (S. Cahill) – jumped away awkwardly. Raced ungenerously in the early and middle stages of the event. Approaching the 400 metres was momentarily inconvenienced when taking a tight run to the inside of BIG BAD BROWN. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: AUSSIE RIPPER ROAST / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1400 metres (cont'd)

BUDJIROO (B. Griffiths) – rider explained that the gelding felt awkward in its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: SAGLE CONSTRUCTIONS / SABOIS THREE-YEAR-OLD BM 64 HANDICAP - 1200 metres

BWUVA (S. Price) – inclined to lay in, in the straight. Rider reported that his mount lost its near side bubble cheeker approaching the home turn and as a result laid in severely in the straight. A post-race veterinary examination revealed no visible abnormalities.

UNRELATED (J. Toeroek) – slow to begin. Laid in under pressure in the straight.

OBLIQUE LINE (B. Griffiths) – jumped away awkwardly.

A LITTLE CHUNKY (Jemma Frew) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$400.

RACE 4: AUSSIE CIDER CLASS ONE HANDICAP - 1300 metres

HEY SAINT PETER (Z. Spain) – raced greenly in the straight.

MONS ABILA (K. Bishop) – slow to begin.

GO ARRIVEDERCI (S. Fawke) – raced keenly in the early and middle stages. Approaching the 300 metres bumped with SUPERCHIC on a number of occasions. Pled guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

SUPERCHIC (J. Kah) – approaching the 300 metres bumped with GO ARRIVEDERCI on a number of occasions.

TEQUILA FLYER (J. Bowditch) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

GIFT OF PRIMUS (D. Tourneur) – slow to begin.

RACE 5: MY BUTCHER BM 60 HANDICAP - 2200 metres

SPUR ON GOLD (A. Jordsjo) – slow to begin.

BELLA SPOSA (K. Crowther) – Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.

PRESUMPTION (D. Caboche) – stood flat-footed at the start and was very slow to begin. In the vicinity of the 900 metres shifted in marginally inconveniencing WAR POINT. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Lost its off hind plate during the event. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

FOREIGN FIGHTER (R. Clark) – in the vicinity of the 900 metres shifted out marginally inconveniencing WAR POINT.

NO LOVE (J. Huxtable) – raced keenly in the early and middle stages.

MORE THAN A ROSE (S. Fawke) – in the vicinity of the 1900 metres shifted in abruptly making contact with the rail.

RACE 5: MY BUTCHER BM 60 HANDICAP - 2200 metres (cont'd)

WAR POINT (Z. Spain) – in the vicinity of the 900 metres was inconvenienced when FOREIGN FIGHTER shifted out and PRESUMPTION shifted in.

RACE 6: ADELAIDE GALVANISING/BIRNIE SANDERS HOTEL BROKERS BM 64 HANDICAP – 1050 metres

TRUENO (D. Caboche) – jumped away awkwardly and shifted out inconveniencing FAIRY NYMPH.

AKKACAN (B. Griffiths) – approaching the 200 metres bumped FAIRY NYMPH, which shifted in. Approaching the finish shifted out bumping FAIRY NYMPH. Performed below expectation. A post-race veterinary examination revealed no visible abnormalities.

JUST PEGGY (K. Crowther) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ASHERO (A. Jordsjo) – jumped away awkwardly and shifted in bumping HOT DEMAND. A post-race veterinary examination revealed the gelding to have suffered a bi-lateral bleeding attack. Trainer, Mr G. Richards, was advised as this was the gelding's first bleeding attach, ASHERO would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

CASH IS COMING (J. Kah) – late scratching at 3.34 pm on Veterinary advice after the mare hit its head in the raceday stalls.

RED FAIRARIE (E. Finnegan) – jumped away awkwardly and shifted in inconveniencing FAIRY NYMPH. From the vicinity of the 100 metres for the remainder of the event was held up for clear running.

HOT DEMAND (D. Thornton) – bumped on jumping away by ASHERO which jumped away awkwardly and shifted in.

FAIRY NYMPH (Z. Spain) – inconvenienced on jumping away when RED FAIRARIE jumped away awkwardly and shifted in and TRUENO jumped away awkwardly and shifted out. Raced ungenerously in the early and middle stages of the event. Approaching the 200 metres shifted in and bumped AKKACAN. Approaching the finish shifted in bumping AKKACAN on a number of occasions.

ABUNDANCE OF HEART (V. Wong) – laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: COOPERS BENCHMARK 64 HANDICAP - 1600 metres

MR LIBERTY (S. Cahill) – Trainer, Mr N. Smart, advised Stewards prior to the event that he would instruct S. Cahill to settle back in the field. Slow to begin.

ANYPORTINASTORM (C. Lindop) – approaching the 600 metres had to be momentarily steadied when racing on heels. Laid in rounding the home turn. In the vicinity of the 200 metres had to be steadied and lost its position when SWEET SCHILLY shifted in marginally under pressure inconveniencing both PRESIDIUM and GRAND ARMADA, which were taken in. Held up from the vicinity of the 200 metres was held up for clear running for the remainder of the event.

PAWNEE PASS (D. Thornton) – slow to begin.

SCARLETT FOX (D. Tourneur) – laid in under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Rider also pleaded guilty to a charge under AR145 in that he weighed in, in excess of half a kilogram of the weight he weighed out and was fined \$200.

WRIST WATCH (R. Clark) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 7: COOPERS BENCHMARK 64 HANDICAP - 1600 metres (cont'd)

SHEANNA (Z. Spain) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 8: TAYLORS WINES BENCHMARK 64 HANDICAP - 1400 metres

GRAVITATIONAL (J. Huxtable) – bumped on jumping away when SATURDAY MAGIC jumped away awkwardly and shifted out. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

ABU DHABI (B. Griffiths) – laid out rounding the home turn. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RAHEEBA (R. Clark) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.

HAZY LANE (V. Wong) – from the entrance to straight to the vicinity of the 300 metres had difficulty obtaining clear running.

ROWDY RICHARD (T. Pannell) – approaching the 200 metres was inconvenienced when taken wider when SACRED DAYS shifted out.

LADY SILHOUETTE (S. Price) – raced keenly in the middles stages of the event.

SACRED DAYS (D. Thornton) – approaching the 200 metres shifted wider to improve around heels bumping ROWDY RICHARD.

SATURDAY MAGIC (R. Hurdle) – jumped away awkwardly and shifted out bumping GRAVITATIONAL.

THE OTHER GUY (D. Tourneur) – fractious in the barriers. D. Tourneur was examined by the First Care Medical personnel and ruled unfit to fulfil his engagement. Acting on this advice Stewards withdrew THE OTHER GUY at 4.56 pm.

HIGH TEC (NZ) (K. Bishop) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.
