**RACE 1: CAMPOLINA STUD HANDICAP - 1200 metres**

**BATTLE BREWING** (T. Pannell) – lost its position on jumping away when tightened by **RUGGED ANGEL**.

**COUNTER SPIN** (J. Holder) – inconvenienced at the start. Held up for clear running from the 500 metres until inside the 100 metres and was untested to the line.

**IDATWO** (S. Price) – a post-race veterinary examination revealed no visible abnormalities.

**STREETCAR VALOUR** (J. Kah) – jumped away awkwardly and was slow into stride. Held up for clear running from the entrance to straight until inside the 100 metres.

**BEAU RIVAGE** (D. Dunn) – held up for clear running from inside the 200 metres until inside the 100 metres.

**MUNICIPALITY** (D. Thornton) – held up for clear running from the entrance to the straight until inside the 100 metres.

**RUGGED ANGEL** (J. Bowditch) – shifted in on jumping away onto **COUNTER SPIN**. A post-race veterinary examination revealed the mare had suffered a bi-lateral bleeding attack. Trainer, Mr R. Irons, was advised that as this was **RUGGED ANGEL**'s first bleeding attack it is now suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

**LIBERTY HILL** (K. Bishop) – in the vicinity of the 900 metres attempted to savage **SO YOU TOO**.

**SO YOU TOO** (C. Lindop) – knuckled on jumping away. Laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 1: CAMPOLINA STUD HANDICAP - 1200 metres (cont'd)**

Correct weight for this event was delayed to allow Stewards to view the Official Vision of the start in relation to STREETCAR VALOUR and also to allow C. Lindop (SO YOU TOO) the second placegetter to view the Official Photo Image for first.

### **RACE 2: NATIONAL STAKES – 1200 metres**

**SAM'S IMAGE** (L. Meech) – inconvenienced on jumping away when contacted by MINTHA. Momentarily steadied inside the 200 metres.

**EVIL CRY** (D. Oliver) – inside the 200 metres shifted in under riding across the running line of SAM'S IMAGE, which had to be momentarily steadied. Rider reminded of his obligations. Momentarily unbalanced when contacted by I'LL HAVE A BIT approaching the 100 meters.

**PURE SCOT** (D. Dunn) – rider reported that the filly did not travel during the first half of the event; however, then picked up the bit and finished the race off well.

**BOOKER** (D. Lane) – jumped away awkwardly and shifted out abruptly contacting MINTHA. Raced keenly in the early and middle stages of the event.

**I'LL HAVE A BIT** (C. Williams) – had difficulty obtaining clear ground from the 300 metres until near the 200 metres when awkwardly placed on the heels of BOOKER. Approaching the 100 metres rolled out and contacted EVIL CRY.

**MINTHA** (D. Thornton) – lost its position on jumping away when tightened onto SAM'S IMAGE by BOOKER. Rider reported that when placed under pressure in the vicinity of the 600 metres the filly's action deteriorated and for this reason he did not ride his mount out in his normal manner. A post-race veterinary examination revealed the filly to have cardiac arrhythmia. Trainer, Mr T. McEvoy, was advised that the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the filly performing satisfactorily in an Official Barrier Trial.

### **RACE 3: MITTYS PORT ADELAIDE CUP - 2500 metres**

**HIGH CHURCH (IRE)** (D. Lane) – commenced to lay in approaching the 200 metres and inside the 200 metres shifted in abruptly despite its rider's efforts onto WAGING WAR. A post-race veterinary examination revealed no visible abnormalities.

**TIME TO TEST** (D. Thornton) – in the vicinity of the 200 metres improved into a tight run between SUPER HAZE (IRE) and WAGING WAR and as a result rolled out slightly onto WAGING WAR.

**WAGING WAR** (C. Lindop) – raced fiercely in the early and middle stages of the event. In the vicinity of the 200 metres rolled in towards TIME TO TEST and shortly after had to be checked, became unbalanced and lost its position when TIME TO TEST improved into a tight run to its inside and rolled out slightly, at the same time as HIGH CHURCH (IRE) laid in. A post-race veterinary examination revealed the gelding to be exhibiting signs of tying up in the hindquarters. First aid administered. Co-trainers, Mr L. McDonald and Mr A. Gluyas, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**LAMBORGHINI (NZ)** (J. Holder) – in the vicinity of the 400 metres became awkwardly placed on the heels of SASSY JO as that mare commenced to weaken.

**SPUR ON GOLD** (A. Jordsjo) – stood flat-footed and was slow to begin.

**DOCKER PAV** (J. Kah) – laid in under pressure in the straight, resulting in its rider being forced to stop riding and straighten on a number of occasions.

**SANIMA STAR** (B. Clardige) – a post-race veterinary examination revealed a laceration to the off hind fetlock consistent with being galloped on. First aid administered.

#### **RACE 4: UBET SA FILLIES CLASSIC - 2500 metres**

**SAVVY DREAMS (NZ)** (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

**PRETTY PUNK** (C. Lindop) – held up for clear running for a short distance in the vicinity of the 400 metres. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**CEDAR GRANDE (NZ)** (L. Nolen) – slow to begin.

**YOUNG HOSTESS** (C. Parish) – in the vicinity of the 2000 metres was hampered when tightened between PARTHESIA (NZ), which rolled out slightly, and ROSALEEN DUBH (NZ), which laid in. In the vicinity of the 600 metres improved onto the heels of ROSALEEN DUBH (NZ) and had to be steadied, and in doing so rolled in onto GRAN TRYPHENA.

**LILYMORN (NZ)** (D. Oliver) – a post-race veterinary examination revealed the filly to be lame in the off hind leg. Trainer, Mr M. Moroney, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**ALMALITA** (S. Baster) – raced keenly in the middle stages of the event.

**MOJESTIC** (L. Currie) – a post-race veterinary examination revealed no visible abnormalities.

**ROCK GISELLE** (C. Williams) – jumped away awkwardly.

**GRAN TRYPHENA** (B. Melham) – had to be steadied in the vicinity of the 600 metres when tightened onto PRETTY PUNK by YOUNG HOSTESS, which rolled in.

**ROSALEEN DUBH (NZ)** (A. Lynch) – a post-race veterinary examination revealed no visible abnormalities.

#### **RACE 5: 7 NEWS CENTAUREA STAKES - 2019 metres**

**TICK TICK BLOOM** (D. Lane) – jumped away awkwardly.

**HAVE ANOTHER GLASS** (E. Finnegan) – jumped away awkwardly and shifted out inconveniencing MISS DUBOIS (NZ). Had difficulty obtaining clear ground for a short distance at the entrance to the straight.

**TIDY PROPHET** (L. Meech) – raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the vicinity of the 500 metres until approaching the 200 metres.

**MODEL DRAGON** (L. Nolen) – jumped away awkwardly. In the vicinity of the 1900 metres became awkward when racing in restricted room between TEARS OF JOY and EXOCET. Raced keenly in the middle stages of the event. Lost its off hind plate during the event.

**TEARS OF JOY** (J. Bowditch) – raced keenly in the early and middle stages of the event.

**SAVANNAH MOON** (L. Currie) – raced wide without cover in the early stages of the event.

**LOVEITT** (D. Thornton) – raced keenly in the vicinity of the 1200 metres for a number of strides, got its head up and was ungenerous.

**MISS DUBOIS (NZ)** (M. Zahra) – inconvenienced on jumping away.

#### **RACE 6: HUGHES LIMOUSINES R A LEE STAKES – 1600 metres**

**HOOKED** (L. Nolen) – dipped shortly after the start.

### **RACE 6: HUGHES LIMOUSINES R A LEE STAKES – 1600 metres (cont'd)**

**ROYAL RUMBLE** (C. Lindop) – slow to begin. Raced keenly in the early and middle stages of the event. Inconvenienced in the vicinity of the 1400 metres by BELUGA BLUE. Approaching the 400 metres became awkward on the heels of BELUGA BLUE when racing in restricted room to that mare's inside. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**DANCES ON STARS (NZ)** (A. Jordsjo) – jumped away awkwardly and was slow to begin.

**BELUGA BLUE** (J. Holder) – slow to begin. Raced keenly in the early and middle stages of the event. In the vicinity of the 1400 metres shifted in taking ROYAL RUMBLE in, resulting in that gelding being inconvenienced. Rider reprimanded under AR137(a) for shifting ground when insufficiently clear.

### **RACE 7: DARLEY GOODWOOD - 1200 metres**

**BLACK HEART BART** (B. Rawiller) – rider explained that after jumping away well the gelding settled closer than he had anticipated and when placed under pressure had not finished off the race as well as he had anticipated. A post-race veterinary examination revealed no visible abnormalities.

**MALAGUERRA** (B. Melham) – raced in restricted room for a short distance in the vicinity of the 700 metres and had to be eased. A post-race veterinary examination revealed no visible abnormalities.

**FAATINAH** (C. Parish) – jumped away awkwardly and shifted out onto SECRET AGENDA.

**HEY DOC** (L. Currie) – shifted out and away from BASSETT (NZ) in the vicinity of the 100 metres onto LUCKY LIBERTY. Rider reprimanded and advised in future he would be required to make a greater effort to keep his mounts straight when they commence to shift ground.

**ILLUSTRIOUS LAD** (A. Darmanin) – inconvenienced in the vicinity of the 700 metres when FIRST AMONG EQUALS rolled in.

**SECRET AGENDA** (D. Oliver) – lost its position on jumping away when tightened onto VEGA MAGIC by FAATINAH.

**RAGEESE** (D. Lane) – a post-race veterinary examination revealed the horse to be lame in the off foreleg. Trainer, Mr D. Weir, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**FIRST AMONG EQUALS** (L. Nolen) – rolled in in the vicinity of the 700 metres onto ILLUSTRIOUS LAD.

**RIZIZ** (T. Pannell) – inside the 200 metres raced in restricted room between FAATINAH and KAEPERNICK, which shifted out slightly, resulting in RIZIZ losing its position.

**KAEPERNICK** (D. Dunn) – near the 200 metres shifted out and inconvenienced RIZIZ. Rider reprimanded under AR137(a) and advised to take greater care when shifting ground.

**SWEET SHERRY** (S. Baster) – knuckled shortly after the start.

**LUCKY LIBERTY** (J. Bowditch) – jumped away awkwardly. Raced keenly for a short distance inside the 500 metres when awkwardly placed on heels of runners. In the vicinity of the 100 metres had to be steadied when HEY DOC shifted out and away from BASSETT (NZ).

**LOPE DE CAPIO** (J. Kah) – accidentally dropped her whip in the vicinity of the 150 metres and was fined \$50 for carelessness under AR137(a).

### **RACE 8: UBET PROUD MISS STAKES - 1200 metres**

**SAMARA DANCER (NZ)** (N. Callow) – awkward to begin. Rider explained the filly made an abnormal respiratory noise on pulling up. A post-race veterinary examination revealed no visible abnormalities.

**RACE 8: UBET PROUD MISS STAKES - 1200 metres (cont'd)**

**RAVI** (D. Dunn) – a post-race veterinary examination revealed a laceration to the near foreleg. First aid administered.

**TELOPEA (GB)** (D. Lane) – held up for clear running from near the entrance to the straight until approaching the 200 metres and was obliged to shift out to obtain clear ground.

**FINE MIST** (S. Baster) – raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**BEAUTIFUL FLYER** (R. Clark) – inconvenienced near the 100 metres when awkwardly placed on the heels of **SCHISM**, which shifted out. Lost its near hind plate.

**SCHISM** (L. Nolen) – shifted out near the 100 metres.

**TYCOON QUEEN** (J. Kah) – severely hampered approaching the 100 metres by **ALASKAN JADE**, which shifted out abruptly.

**ENTRANCING** (E. Finnegan) – awkward to begin.

**ALASKAN JADE** (J. Maund) – rider explained that the mare raced very erratically throughout the event and shifted out abruptly approaching the 100 metres.
