Report on Race Meeting held at the Penola Racecourse by the Penola Racing Club on Sunday, 4 June 2017

RACE 1: MATTHEW MCGREGOR PLUMBING / SABOIS DISTANCE MAIDEN PLATE - 1700 metres

The start of this event was delayed approximately four minutes.

ATOMIC FLEA (C. Collins) – stood flat-footed and was very slow to begin.

CRIGAN (C. Puls) – on arrival at the barriers dislodged its rider, jumped an outside fence and galloped for a considerable distance before being recaptured. A late scratching by order of Stewards at 12.45 pm. Trainer Mr S. Fischer was advised a warning had been placed on the mare. Rider examined by the First Care Medical Personnel and ruled fit to fulfil her remaining engagements.

RACE 2: COOPERS BREWERY / SABOIS MAIDEN PLATE - 1400 metres

MOON ARROW (D. Thornton) – brushed on jumping away when LOVE LOCKDOWN jumped away awkwardly and shifted out.

HOWEXCITING (A. Boyd) - slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

ZATSO (NZ) – acting on a confirmed telephone call from Trainer W. Walters that the filly had been kicked at its stable and was lame, Stewards withdrew ZATSO (NZ) at 8.56 am.

LOVE LOCKDOWN (C. Puls) - jumped away awkwardly and shifted out brushing MOON ARROW.

RACE 3: CLASSICBET / SABOIS MAIDEN PLATE - 1100 metres

DYADAMO (S. Fawke) – laid in under pressure in the home straight.

LIGHTNING TIARA (J. Bowditch) - slow to begin.

ONE DAY OLDER (M. Julius) - raced ungenerously in the early and middle stages of the event.

RACE 4: THE MIDFIELD GROUP BENCHMARK 56 HANDICAP - 1100 metres

YOUDINI (J. Bowditch) - performed below expectations. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 4: THE MIDFIELD GROUP BENCHMARK 56 HANDICAP - 1100 metres (Cont'd)

SPARKLING SON (C. Puls) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: GABRIEL ELECTRICAL CONTRACTORS BENCHMARK 72 HANDICAP - 1300 metres

The start of this event was delayed approximately three minutes.

JARRAH TWIST (D. Bates) – lost a plate and had to be re-plated on arrival at the barriers. Underwent a pre-race veterinary examination and passed fit to race.

IMPORTANT (J. Bowditch) – raced keenly in the early and middle stages of the event. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ANY GIVEN GLASS (J. Huxtable) – in the vicinity of the 50 metres shifted out when insufficiently clear. Rider severely reprimanded.

SON OF COCO (NZ) (K. Walters) – raced ungenerously in the early and middle stages of the event. In the vicinity of the 50 metres had to be steadied and lost its position when ANY GIVEN GLASS shifted out when insufficiently clear.

FICKLE TIME (K. Bishop) – stood flat-footed and was very slow to begin.

RACE 6: BAGGIO BUILDERS CLASS TWO HANDICAP - 1400 metres

LINDSAY ALFRED (S. Fawke) - in the vicinity of the 1200 metres shifted out and raced ungenerously for a short distance inconveniencing FREDERATION. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

HASTA LA SPEC (V. Wong) – in the vicinity of the 1200 metres shifted in marginally inconveniencing FREDERATION.

FREDERATION (K. Bishop) - in the vicinity of the 1200 metres had to momentarily steady and lost its position when racing tight between LINDSAY ALFRED and QUICK BEERS.

RACE 7: PINKERTON, PALM, HAMLYN & STEEN BENCHMARK 56 HANDICAP - 1700 metres

INNUENDO (J. Huxtable) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. Rider explained the gelding jumped well and mustered early speed shortly after the 800 metres did not travelled well. A post-race veterinary examination revealed no visible abnormalities.

PILLAR OF DESTINY (A. Boyd) – bumped on jumping away when QUEENTONETTE (NZ) jumped away awkwardly and shifted in.

SUPER DELUXE (D. Thornton) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

QUEENTONETTE (NZ) (K. Walters) - jumped away awkwardly and shifted in bumping PILLAR OF DESTINY.
