# THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

# Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 10 June 2017

TRACK: Good 4 WEATHER: Fine

RAIL: (Parks track) Out 5 metres 1000 metres to 400 metres, out 3 metres remainder.

(Main track) Out 12 metres 1000 metres to Winning Post, out 8 metres remainder.

# RACE 1: GRAND NATIONAL STEEPLECHASE - 3500 metres

(Run on the main track)

**ANGELOLOGY (NZ)** (D. Horner) – raced keenly in the early stages of the event.

**SPYING ON YOU (NZ)** (P. Hamblin) – a post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**BOLD ZAMOUR (NZ)** (R. Cully) – shifted out on making jump 10 tightening LENNYBE onto ANGELOLOGY (NZ). Raced in restricted room at the entrance to the straight between the heels of MANNERTONE and ANGELOLOGY (NZ) and was obliged to alter course to obtain clear ground.

**MANNERTONE** (B. Small) – shifted out abruptly on making jump 6 inconveniencing STREET OUTLAW. Shifted out abruptly making jump 7 hampering STREET OUTLAW. Rider reported that the gelding had a tendency to lay out in today's event and in his opinion appreciated softer tracks.

**STREET OUTLAW** (A. Lynch) – inconvenienced on making jump 6. Hampered and lost its position on making jump 7. Eased out of the event at the entrance to the straight prior to making jump 11. After consideration by the Jumps Review Panel and the Stewards no action was taken in relation to the performance of STREET OUTLAW. Lost its off fore plate during the running of the event. A post-race veterinary examination revealed no visible abnormalities.

**LENNYBE** (R. David) – tightened onto ANGELOLOGY (NZ) by BOLD ZAMOUR (NZ) on making jump 10.

All horses underwent a post-race veterinary examination.

#### RACE 2: RICHARD ANGOVE TWO-YEAR-OLD MAIDEN PLATE – 1000 metres

**MODULATE** (P. Gatt) – reared on jumping away and was slow into stride.

**EMZARA** (D. Thornton) – held up for a short distance inside the 300 metres and approaching the 200 metres was obliged to alter course to obtain clear ground.

**GALCRUM** (J. Maund) – attempted to buck for a short distance shortly after the start. A post-race veterinary examination revealed minor lameness in the near foreleg. Trainer, Mr D. Reynolds, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race. Trainer was further advised that a warning had been placed on the filly.

**PURRFECT KISSES** (J. Toeroek) – jumped away awkwardly.

**TENNESSEE RAIDER** (C. Lindop) – jumped away awkwardly.

# RACE 3: KEVERN KLEMICH MEMORIAL GRAND NATIONAL HURDLE - 3500 metres (Run on the main track)

**CABLE BAY (NZ)** (L. Horner) – struck hurdle 10 and landed awkwardly. Eased out of the event at the entrance to the straight. After consideration by the Jumps Review Panel and the Stewards no action was taken in relation to the performance of CABLE BAY (NZ). Rider reported that in his opinion the gelding appreciated softer tracks.

**CELTIC PRINCE (NZ)** (P. Hamblin) – raced keenly in the early and middle stages of the event. Eased out of the event at the entrance to the straight. After consideration by the Jumps Review Panel and the Stewards no action was taken in relation to the performance of CELTIC PRINCE (NZ).

All horses in this event underwent a post-race veterinary examination.

#### RACE 4: UBET HANDICAP - 1300 metres

**CHAPEL CITY** (J. Kah) – had difficulty obtaining clear ground from the entrance to the straight and in the vicinity of the 200 metres became held up until inside the 100 metres. Approaching the finish raced in restricted room between the heels of BULLION WOLF and SWIPE ME RIGHT.

**BULLION WOLF** (Z. Spain) – had to be steadied in the vicinity of the 1000 metres.

**PERFECT COMMAND** (S. Cahill) – In the vicinity of the 1000 metres shifted in onto BULLION WOLF, which had to be steadied. Rider reprimanded.

**HUSSY'S GLOW** (R. Clark) – had difficulty obtaining clear ground from the entrance to the straight until inside the 200 metres.

**GOGO GRACE** (C. Lindop) – slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

**DOLLAR DOLLAR BILL** (P. Gatt) – slow to begin.

# RACE 5: HUGHES LIMOUSINES HANDICAP - 1950 metres

MAGIC BOY (J. Bowditch) – held up from in the vicinity of the 400 metres until near the 300 metres.

**CHESTNUT CHARLIE** (J. Toeroek) – Trainer, Mr P. Huserot, advised Stewards prior to this event that he would instruct rider J. Toeroek to attempt to obtain a position more forward than it had been ridden in its most recent starts. Held up from approaching the 400 metres until inside the 300 metres.

**HERNE'S OAK** (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

**EMMOOKI'S DASH** (Z. Spain) – had difficulty in obtaining clear ground from the vicinity of the 200 metres until near the 100 metres. Rider reported the gelding was inclined to lay in over the concluding 700 metres.

**GRAVITATIONAL** (E. Finnegan) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr P. Stokes, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

MILSON (D. Thornton) – slow to begin. Laid in under pressure in the straight.

**SOARING HIGH** (C. Lindop) – raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

**JUST LIVE ON** (T. Pannell) – a post-race veterinary examination revealed no visible abnormalities.

## RACE 6: STAN COYLE MEMORIAL HANDICAP - 1000 metres

**NEAT FEAT** (B. Griffiths) – took charge of its rider en route to the barriers and galloped several hundred metres before being restrained. Underwent a pre-race veterinary examination at the barriers and ruled unfit to start. Acting on this advice Stewards withdrew NEAT FEAT at 2.58 pm.

**VICKI'S BOY** (T. Pannell) – a post-race veterinary examination revealed no visible abnormalities.

CRYSTAL MOMENT (O. Ridge) - inclined to lay out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

### RACE 7: SCHWEPPES HANDICAP - 1250 metres

**EVANGELIST (GB)** (E. Finnegan) – stood flat-footed and was slow to begin.

**REDEEM BOUNTY** (J. Toeroek) – acting on confirmed advice from Mr D. Egan, representing Trainer, Mr R. Jolly, that REDEEM BOUNTY had injured its near fore hoof in its box at the stables and would be unfit to race Stewards withdrew the gelding at 1.47 pm.

### RACE 8: DAVID TOOTELL SENIOR 40 YEAR ANNIVERSARY HANDICAP - 1400 metres

ABU DHABI (Z. Spain) - shifted in onto SIMPATICO in the vicinity of the 1200 metres. Rider pleaded guilty to a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence at midnight Saturday, 17 June 2017 and to conclude at midnight Saturday, 24 June 2017, a period of three meetings.

AFFRAY (D. Caboche) - trainer, Mr W. Clarken, advised Stewards prior to this event that he would instruct rider D. Caboche to attempt to settle more forward than in its most recent starts. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. Rider also charged under AR137A(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$400.

**ON A DREAM** (R. Clark) – raced wide without cover throughout the event. Inconvenienced and taken wider on the home turn when SIMPATICO was taken out.

**BURNRO** (P. Gatt) – jumped away awkwardly and shifted in contacting L'AMARYBELLE.

L'AMARYBELLE (B. Griffiths) – contacted on jumping away and tightened onto SUPERCHIC.

SIMPATICO (D. Thornton) - in the vicinity of the 1200 metres had to be steadied to avoid the heels of ABU DHABI, which shifted in. Bumped in the vicinity of the 400 metres by SUDDEN WEALTH, which shifted out to improve.

**SUPERCHIC** (J. Kah) – contacted on jumping away by L'AMARYBELLE.

**SAR SAR** (C. Hall) – a post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer, Mr P. Hardacre, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**SUDDEN WEALTH** (T. Pannell) – shifted out in the vicinity of the 400 metres and bumped SIMPATICO, which was taken out onto ON A DREAM. Rider reprimanded.
