#### **RACE 1: JOHNSTON WITHERS LAWYERS / SABOIS MAIDEN PLATE - 1396 metres**

**AWKWARD SILENCE** (A. Jordsjo) – jumped away awkwardly. In the vicinity of the 150 metres was inconvenienced as TYPHON BREEZE laid in.

**TYPHON BREEZE** (J. Huxtable) – laid in under pressure in the straight and in the vicinity of the 150 metres rolled in inconveniencing AWKWARD SILENCE.

HAYAKU MISS (J. Maund) - jumped the tractor tyre marks in the vicinity of the 1200 metres and became awkward for a short distance.

ALWAYS RED (C. Davies) - reared on jumping away.

LADY BARRON (K. Bishop) – a post-race veterinary examination revealed the filly to be lame in the off foreleg. First aid administered. Trainer, Mrs N. Bruggemann, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

Correct weight for this event was delayed to allow A. Jordsjo (AWKWARD SILENCE), placed second, and Trainer, Mr B. Bogarts, to view the Official Vision in the straight.

# RACE 2: BORAL CONCRETEBENCHMARK 60 HANDICAP - 1100metres

The start of this event was delayed approximately three minutes.

**CINCINNATI** (Z. Spain) – jumped away awkwardly and as a result was slow to begin.

TOUCH OF BELLA (D. Caboche) - slow to begin.

CONQUER THE MOMENT (S. Fawke) - got its leg up in the barrier stalls. Underwent a pre-race veterinary examination and was passed fit to start. Rider reported that he placed the gelding under pressure in the vicinity of the 600 metres but in his opinion the gelding was disappointing in it's performance over the concluding stages.

# RACE 3: AUGUSTA BOTTLE & CAN RECYCLERS BENCHMARK 72 HANDICAP - 1100 metres

CHANDLERY (D. Caboche) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. T:\Stewards\STEWARDS REPORTS\2016-17 Stewards Reports\PTA110617.docx Page 1 of 3

# RACE 3: AUGUSTA BOTTLE & CAN RECYCLERS BENCHMARK 72 HANDICAP - 1100 metres (cont'd)

**ADDTINA** (K. Crowther) – underwent a pre-race veterinary examination as it had not started in 12 months and passed fit to start. A post-race veterinary examination revealed the mare had suffered a bilateral bleeding attack. Trainer, Mr T. Montgomerie, was advised as this was the mare's first bleeding attack, ADDTINA would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

# RACE 4: AUGUSTA COURTYARD MOTEL / SABOIS MAIDEN PLATE- 1100 metres

**MY FRIEND RILEY** (D J McWhinney) – underwent a pre-race veterinary examination as it had not started in eight months and passed fit to start. Rider reported that at the entrance to the straight he had elected to steer the gelding to the outside of the field as he was of the opinion that the gelding was resenting the kickback.

**IMPOSSIBLE GIRL** (D. Caboche) – reluctant to proceed to the barriers. Trainer, Mr D. Bonetti, was advised a warning had been placed on the mare regarding its pre-race behaviour.

**AZTEC PRIESTESS** (T. Zanker) – lost its near fore shoe during the running of the event.

# RACE 5: WESTSIDE VEGIE PATCH BENCHMARK 64 HANDICAP - 1396 metres

**MAGICAL TYCOON** (A. Jordsjo) – in the vicinity of the 1100 metres taken in to the running of PARTY SPIN by COMMAND THE SUN.

**PARTY SPIN** (D. Caboche) – in the vicinity of the 1100 metres was obliged to be checked to avoid the heels of MAGICAL TYCOON, which had been taken in.

**SHA LA LA** (Jemma Frew) – in the vicinity of the 1100 metres shifted in tightening COMMAND THE SUN. Rider severely reprimanded for careless riding under AR137(a). A post-race veterinary examination revealed no visible abnormalities.

**COMMAND THE SUN** (J. Huxtable) – underwent a pre-race veterinary examination as it had not started in 12 months and passed fit to start. Tightened onto MAGICAL TYCOON by SHA LA LA in the vicinity of the 1100 metres.

**IRISH MAMBO** (A. Doyle) – in the vicinity of the 900 metres became awkwardly placed between the heels of PARTY SPIN and BROOKTON ICE and was obliged to be eased. Laid out from in the vicinity of the 400 metres until 200 metres.

# RACE 6: MAX CRANES WHYALLA CUP - 1600 metres

**MOORE ALPHA** (J. Toeroek) – reared on jumping away and was slow into stride.

**HIGH TEC (NZ)** (K. Bishop) – raced keenly in the early stages of the event and in the vicinity of the 1200 metres improved onto the heels of IT'S FRED and was obliged to be steadied.

**OVERSTREET** (A. Doyle) – jumped away awkwardly. The rider reported that in his opinion the gelding resented the kickback.

**ROD'S OPINION** (T. Zanker) – a post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow the trainer of HIGH TEC (NZ), Mrs N. Bruggemann, to view the Official Image.

# RACE 7: MOTEL POINSETTIA BENCHMARK 56 HANDICAP - 1600 metres

**KARADOC KID** (J. Huxtable) – rider explained his instructions were to allow the gelding to settle comfortable from the wide barrier.

**ZOE'S GIFT** (K. Bishop) – raced keenly in the middle stages of the event. Inside the 500 metres was held up for clear running until the entrance to the straight.

**IN TAIPEI** (A. Doyle) – shifted out on jumping away and contacted VAN PERSIE. Inside the 500 metres when raced in restricted room between VAN PERSIE to its inside and CERUTTY to its outside, clipped the heels of CERUTTY and faltered. Rider eased the gelding out of the event. A post-race veterinary examination revealed the gelding had fractured its near shoulder and was humanely euthanised.

**VAN PERSIE** (Z. Spain) – laid out throughout the event. In the vicinity of the 500 metres rolled out tightening IN TAIPEI. A post-race veterinary examination revealed no visible abnormalities.

# RACE 8: SPRINGBETTS DELIVERIES BENCHMARK 56 HANDICAP - 1200 metres

**ANOTHER MARTINI** (J. Huxtable) – jumped away awkwardly and as a result was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**OBLIQUE LINE** (K. Bishop) – raced keenly in the middle stages. Held up for clear running from the vicinity of the 400 metres until the entrance to the straight.

**DUTTON BAY** (J. Maund) – laid in, in the home straight.
