Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 17 June 2017

RACE 1: WEST ADELAIDE FOOTBALL CLUB HANDICAP - 1050 metres

ECLAIR SUNSHINE (M. Neilson) - slow into stride. Inconvenienced in the vicinity of the 800 metres. Shifted out to improve at the entrance to the straight when in the opinion of Stewards there was insufficient room to do so resulting in heavy contact being made with NO REWARD. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Sunday 18 June, and to conclude at midnight on Wednesday 28 June 2017: a period of four (4) meetings.

CHEEKY AS (J. Toeroek) – inconvenienced at the entrance to the straight when NO REWARD, which had become unbalanced shifted back in onto ECLAIR SUNSHINE taking CHEEKY AS in onto the heels of FROM THE CLOUDS, which had rolled out slightly. Rider explained the gelding travelled well in the early and middle stages of the event however, after being inconvenienced at the entrance to the straight, failed to respond when placed under pressure. A post-race veterinary examination revealed minor speedy cuts to the off hind hock.

FANCY RUMBLE (J. Holder) - jumped away awkwardly. In the vicinity of the 800 metres was hampered when it shifted in and away from NO REWARD, which rolled out slightly and then raced in restricted room for a number of strides to the inside of that filly. At the entrance to the straight had to be eased off the heels of NO REWARD, which had been taken out into its running line by ECLAIR SUNSHINE. Lost its near hind plate during the event.

NO REWARD (D. Schmitt) – rolled in slightly in the vicinity of the 800 metres onto FANCY RUMBLE. At the entrance to the straight was hampered and became unbalanced when ECLAIR SUNSHINE shifted out and made heavy contact with the filly.

RACE 2: ADELAIDE IMAGE PRINTING HANDICAP – 2500 metres

DUBAI ESCAPADE (M. Neilson) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

OUR YANGTZE (GB) (D Schmitt) – rider explained the gelding travelled well in the early and middle stages of the event, however when placed under pressure failed to let down as he had anticipated. A post-race veterinary examination revealed no visible abnormalities.

CELTIC PRINCE (NZ) (S. Fawke) - slow to begin.

DUQUESSA (R. Clarke) - underwent a pre-race veterinary examination and passed fit to race.

RACE 2: ADELAIDE IMAGE PRINTING HANDICAP – 2500 metres (Cont'd)

MILSON (A. Jordsjo) – Trainer Mr G Young advised Stewards he would instruct the rider to attempt to settle in a more forward position in today's event. Rider became concerned with the action of the gelding over the concluding stages and dismounted on pulling up. A post-race veterinary examination revealed the gelding strained its off fore suspensory ligament. First aid administered.

SPUR ON GOLD (J. Bowditch) – raced extremely fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: ADELAIDE GALVANISING HANDICAP - 1600 metres

RANCHO RELAXO (R. Clark) - a post-race veterinary examination revealed no visible abnormalities.

TROGIR (M. Neilson) – held up from the vicinity of the 500 metres until the entrance to the straight.

GOGO GRACE (C. Lindop) - slow to begin.

UNRELATED (P. Gatt) - slow to begin. Laid in under pressure in the straight.

RACE 4: ALI BRYANT 50 SHADES OF FABULOUS HANDICAP - 2003 metres

SPANISH HALO (NZ) (S. Cahill) - slow to begin.

EXALTED LIGHTNING (P. Gatt) - slow to begin. Held up from the vicinity of the 500 metres until the entrance to the straight.

CONNERMARA ROSE (R. Hurdle) - jumped away awkwardly and shifted out. A post-race veterinary examination revealed no visible abnormalities.

CHOSEN ANGEL (J. Holder) - slow to begin.

ACE ATTACK (C. Lindop) – raced keenly in the early and middle stages of the event. Rider explained the gelding had raced keenly in the early and middle stages of the event and when placed under pressure in the vicinity of the 500 metres, failed to respond to her riding and did not finish the event off. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Veterinary Certificate of Fitness required prior to trial or race.

BRAIDLEY (IRE) (E. Finnegan) – rider reported the gelding hung out severely under pressure in the straight.

RACE 5: REGENCY SHOWERSCREENS & WARDROBES HANDICAP - 1100 metres

VIVALDI'S QUEST (Z. Spain) - a post-race veterinary examination revealed no visible abnormalities.

NEAPOLITAN (NZ) (B. Claridge) – lost position shortly after jumping away when tightened onto IRISH MINT by JET EXPRESS, which shifted in. In the vicinity of the 700 metres rolled out slightly onto ZALMONA. Had to be steadied momentarily near the 200 metres when EXPLODE INTO SPACE rolled in. A post-race veterinary examination revealed the filly suffered a bi-lateral bleeding attack. Trainer was advised that the filly was now suspended from racing for a period of three (3) months in accordance with AR53A.

JET EXPRESS (D. Caboche) – shifted out on jumping away onto NEAPOLITAN (NZ).

SAWAIKI (J. Bowditch) – hampered on jumping away when tightened by TIME OUT.

TWO DUCKS ARTIE (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

ZALMONA (S. Fawke) – hampered in the vicinity of the 700 metres when tightened onto JET EXPRESS by NEAPOLITAN (NZ), which rolled out slightly.

RACE 5: REGENCY SHOWERSCREENS & WARDROBES HANDICAP - 1100 metres (Cont'd)

EXPLODE INTO SPACE (M. Neilson) – rolled in slightly near the 200 metres onto NEAPOLITAN (NZ).

TIME OUT (J. Holder) – lost its off fore plate on jumping away. Shifted in on jumping away onto SAWAIKI. Rider explained it was not his intention to settle on pace however, after jumping away better than runners around him, the gelding took up a more forward position without encouragement.

RACE 6: HAPPY 95TH BIRTHDAY NOELLA GREENHAM HANDICAP – 1600 metres

CREANCE (J. Holder) – difficulty obtaining clear ground for a short distance at the entrance to the straight.

RAHEEBA (S. Fawke) – raced fiercely in the early and middle stages of the event.

MR LIBERTY (S. Cahill) – had difficulty in obtaining clear ground from the vicinity of the 500 metres until near the 300 metres.

RACE 7: DOWIE DOOLE WINES HANDICAP - 1200 metres

COUNTER SPIN (C. Lindop) - a post-race veterinary examination revealed no visible abnormalities.

ARTIE FRED (A. Creighton) - a post-race veterinary examination revealed no visible abnormalities.

CORRECT CALL (J. Holder) – improved onto the heels of COUNTER SPIN, which had commenced to weaken in the vicinity of the 200 metres and had to be steadied and altered course.

RACE 8: HAPPY BIRTHSAY JOHN LEWIS HANDICAP - 1050 metres

CLASSY JACK (D. Caboche) – shifted in, in the vicinity of the 900 metres onto TEMPTING FAITH, which shifted in and away onto CASH IS COMING. Rider reprimanded.

SIR CHARLESTON (NZ) (S. Fawke) - jumped away awkwardly.

HOT HANSEL (A. Creighton) – had difficulty in obtaining clear ground at the entrance to the straight and from the vicinity of the 300 metres until inside the 100 metres became held up.

CASH IS COMING (C. Lindop) – had to be steadied in the vicinity of the 900 metres when TEMPTING FAITH shifted in and away from CLASSY JACK.

EXALTED HONEY (B. Griffiths) - slow to begin. Inclined to lay in under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

OUR PROSPECT (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

GO ARRIVEDERCI (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

TEMPTING FAITH (R. Hurdle) – shifted in and away from CLASSY JACK in the vicinity of the 900 metres onto CASH IS COMING.

ESPRESSO LASS (Z. Spain) – inclined to rear on jumping away.
