#### RACE 1: NARACOORTE RADIATORS / SABOIS MAIDEN PLATE- 1000 metres

**DANDY MANDY** (E. Finnegan) – laid in when placed under pressure in the straight.

SANDHILL HALO (J. Huxtable) - a post-race veterinary examination revealed no visible abnormalities.

STRATHBYRNE (L. Doodt) - began awkwardly, shifted out and made contact with MOODY MISS.

**MOODY MISS** (A. Jordsjo) – hampered when jumping away.

**WRIGHT DASH** – a late scratching at 12. 44 pm after refusing to load. Trainer Ms Murphy was advised the filly would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial or Official Jump Out prior to accepting for a future race.

**GRACE OF BLUE** (H. McKechnie) – when questioned regarding the performance of the mare, the rider stated that after beginning well she placed the mount under pressure, however GRACE OF BLUE failed to respond to her riding and was disappointed in its finishing effort. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 2: TENDER CUTS / SABOIS MAIDEN PLATE - 1430 metres

**MOON ARROW** (J. Potter) – hampered on jumping away.

**SAN GREGORIO** (A. Jordsjo) – rider reported the gelding hung out throughout the event. In the vicinity of the 500 metres shifted out despite the efforts of its rider taking ZATSO (NZ) out onto ALI ORPHAN (NZ), which was taken out across the heels of TILLRAIDER, which blundered.

MISTA KNOWITALL (S. Fawke) – hampered on jumping away.

MAPPINGA ROSE (B. Griffiths) - a post-race veterinary examination revealed no visible abnormalities.

**MY GIDDY AUNT (NZ)** (J. Huxtable) - underwent a pre-race veterinary examination after competing at Gawler on Wednesday 14 June 2017 and passed fit to race. Rider reported his mount hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**PRESS ON** (E. Finnegan) – began awkwardly shifted out abruptly taking MISTA KNOWITALL out onto MOON ARROW.

## RACE 2: TENDER CUTS / SABOIS MAIDEN PLATE - 1430 metres (Cont'd)

**ALI ORPHAN (NZ)** (K. Walters) - in the vicinity of the 500 metres clipped the heels of TILLRAIDER after MISTA KNOWITALL shifted out carrying ZATSO (NZ) out onto ALI ORPHAN (NZ) and as a result blundered.

**ZATSO (NZ)** (L. Doodt) – in the vicinity of the 500 metres was taken out by SAN GREGORIO onto ALI ORPHAN.

#### RACE 3: SOUTH KILLANOOLA HAMPY'S BENCHMARK 56 HANDICAP - 1200 metres

**ARCHWAY TO HEAVEN** (J. Potter) – began awkwardly. In the vicinity of the 900 metres shifted out abruptly for no apparent reason. A post-race veterinary examination revealed no visible abnormalities.

**RUBY LANE** (K. Julius) - a post-race veterinary examination revealed no visible abnormalities.

ANGUS CAROLUS (A. Jordsjo)- raced in restricted room in the vicinity of the 200 metres.

**BUNUMBURT** (J. Bowditch) - underwent a pre-race veterinary examination after making contact with the gate on entering the course and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

ADIOS ATLANTIS (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

**NORLANE (NZ)** (S. Fawke) – laid in on entering the straight.

KAYJAYEM (NZ) (K. Walters) - slow to begin.

#### RACE 4: SCULLION FARMING BENCHMARK 56 HANDICAP - 1430 metres

**VON COSTA GLASS** (H. McKechnie) - underwent a pre-race veterinary examination as the gelding had not raced in the past 12 months and passed fit to race. Held up for clear running on entering the straight.

SHA LA (Jemma Frew) – began awkwardly with its head in the air and was slow into stride.

GREEN BACK DOLLAR (A. Jordsjo) - raced wide without cover throughout the event.

#### RACE 5: BUSHMANS'S ARMS HOTEL BENCHMARK 64 HANDICAP - 1100 metres

**DADDY'S LITTLE LADY** (J. Potter) – stood flat footed as the start was effected and was slow to begin.

SHE'S GOT MAGIC (D. Bates) - a late scratching at 2.25 pm due to track downgrade.

SHE'S ALL POWER (C. Collins) – raced wide without cover throughout the event.

# RACE 6: FRANCES HOTEL MOTEL BENCHMARK 72 HANDICAP - 1430 metres

**ANY GIVEN GLASS** (J. Huxtable) – over-raced in the early and middle stages of the event.

#### RACE 7: FB LOCK AND SONS BENCHMARK 64 HANDICAP - 2000 metres

ATHOS (V. Wong) - in the vicinity of the 150 metres shifted out abruptly under pressure.

**SURFACE TO AIR (NZ)** (E. Finnegan) – a late scratching at 4.08 pm after dislodging its rider en route to the barriers. Rider examined by the First Care Medical Personnel and was stood down from her riding engagements.

**HOLLY HOLY (NZ)** (K. Walters) - a late scratching at 2.19 pm due to track downgrade.

#### RACE 7: FB LOCK AND SONS BENCHMARK 64 HANDICAP - 2000 metres (Cont'd)

THE FLIPSIDE (NZ) (L. Doodt) - a late scratching at 2.19 pm due to track downgrade.

**SPECTRUMS BITE** (K. Julius) – raced in restricted room in the early stages of the event. In the vicinity of the 700 metres had to be restrained after improving onto the heels of LITTLE RED DEVIL (NZ).
