## RACE 1: COCA-COLA COLTS GELDINGS & ENTIRES MAIDEN PLATE - 1200 metres

**FAMILJA** (D. Caboche) – hung out severely when placed under pressure in the home straight. A post-race veterinary examination revealed no visible abnormalities.

**HOLY TRILOGEY** (J. Toeroek) – slow to begin.

**RED SCIMITAR** (P. Gatt) – underwent a pre-race veterinary examination following it being a late scratching on Veterinary Advice on Monday, 12 June 2017, and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

**SAMSTAG** (Z. Spain) – over-raced in the middle stages of the event.

**THE HOFFICER** (R. Hurdle) – rider reported that he was concerned with the action of the gelding in today's event. A post-race veterinary examination revealed no visible abnormalities.

**GREY PIRANHA** (E. Finnegan) – a post-race veterinary examination revealed no visible abnormalities.

## RACE 2: WOLF BLASS WINES / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 metres

**LANNISTER GOLD** (A. Jordsjo) – held up for clear running from in the vicinity of the 500 metres until inside the 300 metres.

**MAPPINGA STAR** (K. Bishop) – hampered on jumping away.

**MY GIDDY AUNT (NZ)** (J. Huxtable) – hampered on jumping away.

**ARCTIC BLAZE** (J. Maund) – jumped away awkwardly, shifted in abruptly taking MY GIDDY AUNT (NZ) in onto MAPPINGA STAR. Had to be restrained whilst over-racing in the vicinity of the 800 metres when MISS JANE shifted in when insufficiently clear.

**FIRE 'N' VICE** (J. Toeroek) – had to be restrained in the vicinity of the 800 metres when MISS JANE shifted in when insufficiently clear.

**MISS JANE** (J. Kah) – in the vicinity of the 800 metres shifted in when insufficiently clear of ARCTIC BLAZE and FIRE 'N' VICE. Rider reprimanded under AR137(a) for careless riding.

#### RACE 3: YOUNG GUNS DAY SATURDAY 8TH JULY / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1400 metres

**KING TOMLOLA** (R. Hurdle) – underwent a pre-race veterinary examination after not racing for 12 months and was passed fit to start.

**RHYTHM AND BLUE** (S. Fawke) – over-raced in the early and middle stages of the event. Laid out when placed under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

**ZAALADD** (T. Pannell) – held up for clear running from in the vicinity of the 500 metres until inside the 400 metres.

**CALL ME SACHI** (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

**IDOLWISE** (R. Clark) – a post-race veterinary examination revealed the filly had suffered a bi-lateral bleeding attack. Trainer, Mr J. Hickmott, was advised that as this was the filly's first pleading attack IDOLWISE would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

## RACE 4: GOLDIN FARMS BENCHMARK 60 HANDICAP - 1400 metres

**BRIMMING** (J. Toeroek) – underwent a pre-race veterinary examination after not racing for 12 months and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

**RAISE A DREAM** (A. Jordsjo) – underwent a pre-race veterinary examination after competing at Murray Bridge on 12 June 2017 and was passed fit to start. Rider lost her near side iron on jumping away before regaining the use of her iron shortly thereafter. Laid out when placed under pressure in the straight.

**WESTERN HEIR** (D. Tootell) – slow to begin.

**MARCO POLO** (D. Caboche) – laid out when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**SLIPPERY MOSS** (R. Hurdle) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr B. Holtham, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

## RACE 5: GAWLER SOUTH BAKERY BENCHMARK 60 HANDICAP - 1400 metres

**HOUSE OF WAX** (D. Caboche) – in the vicinity of the 400 metres shifted out to improve when insufficiently clear taking ROAN CHEVAL out onto KIRCHNER. Rider reprimanded under AR137(a) for careless riding.

**GROOVE WITH ME** (S. Cahill) – laid in when placed under pressure in the straight.

**ROAN CHEVAL (NZ)** (J. Bowditch) – hampered in the vicinity of the 400 metres when taken out onto KIRCHNER by HOUSE OF WAX, which shifted out when insufficiently clear.

**KIRCHNER** (E. Finnegan) – hampered in the vicinity of the 400 metres after HOUSE OF WAX shifted out taking ROAN CHEVAL out.

## RACE 6: COOPERS BENCHMARK 64 HANDICAP - 1200 metres

**ROTHMOORE** (R. Hurdle) – late scratching at 1.01 pm due to the track upgrade.

# RACE 6: COOPERS BENCHMARK 64 HANDICAP - 1200 metres (cont'd)

**DAPPER AFTER DARK** (A. Jordsjo) – when questioned regarding the performance of the gelding A. Jordsjo stated that she was instructed to race in a forward position; however, the gelding was slow into stride and failed to muster any early speed. In the vicinity of the 800 metres she placed the gelding under pressure but DAPER AFTER DARK failed to respond to her vigorous urgings and she was disappointed it the gelding's finishing effort. When questioned Trainer, Mr M. Vassallo, confirmed the instructions given to A. Jordsjo and stated that DAPPER AFTER DARK had pleased in its work leading up to today's event. A post-race veterinary examination revealed no visible abnormalities.

**NEVER BE DISCREET** (J. Huxtable) – rider reported the filly hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**IXCATAN** (E. Finnegan) – late scratching at 1.00 pm due to the track upgrade.

## RACE 7: WOLF BLASS RASCALS CLUB TROPHY - 2100 metres

**BEACH GOD** (J. Bowditch) – late scratching at 1.30 pm on confirmed veterinary advice from Trainer, Mr J. Hyam, that the gelding had injured itself in its box. Mr Hyam was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**FASTER LOGIC** (D. Tootell) – slow to begin.

THE BIG CHEESE (D. Caboche) - laid out under pressure in the straight.

**JAGARNA** (J. Kah) – Trainer, Mr C. Bieg, advised Stewards prior to the event that he would instruct J. Kah to attempt to ride the gelding further back with cover than it had at its most recent starts. Settled mid-field. A post-race veterinary examination revealed no visible abnormalities.

**HIPPOGRIFF** (B. Claridge) – held up for clear running from the vicinity of the 500 metres until inside the 400 metres.

**SLINKY TYCOON** (K. Bishop) – laid in under pressure in the straight. Lost its near hind plate during the running of the event.

**COSMIC IVY** (A. Jordsjo) – raced intractably throughout the event. Trainer, Mr T. Doudle, was advised the filly would be required to trial tractably to the satisfaction of Stewards prior to a future race start. A post-race veterinary examination revealed no visible abnormalities.

## RACE 8: MCEVOY MITCHELL RACING CLASS ONE HANDICAP - 1200 metres

**HIDDEN FORTUNE** (J. Toeroek) – laid in under pressure in the straight. Rider accidentally dropped his whip in the vicinity of the 80 metres and was reprimanded under AR137(a).

**RED QUIRINA** (A. Jordsjo) – began awkwardly.

**CERRO BLANCO** (Z. Spain) – laid out under pressure in the straight.

**THE GEE TRAIN** (D. Caboche) – late scratching at 2.06 pm due to transport difficulties.
