**STIPENDIARY STEWARDS' REPORT**

**Report on Race Meeting held at Gawler Racecourse**  
**by the Gawler & Barossa Jockey Club on Wednesday, 28 June 2017**

**WEATHER:** Overcast

**RACE 1: MITAVITE / SANDERS FODDER / SABOIS DISTANCE MAIDEN PLATE - 2100 metres**

**DELIVERY DAY** (R. Clark) – when questioned regarding the performance of the gelding R. Clark stated that after beginning well she was able to take up a forward position as per her instructions, but in the vicinity of the 1400 metres DELIVERY DAY began to make audible noises and she became concerned with how the gelding was travelling and from the vicinity of the 500 metres she elected not to place the gelding under any pressure and allowed it to run to the line untested. A post-race veterinary examination revealed the gelding have atrial fibrillation. Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

**JAGARNA** (J. Kah) – in the vicinity of the 1800 metres had to be momentarily steadied to avoid the heels of DIVINE BLISS, which shifted in when insufficiently clear.

**SLINKY TYCOON** (K. Bishop) – when questioned regarding the mare leading in today's event K. Bishop explained that after being trapped wide in the early stages of the event she elected to push forward and attempt to find cover.

**CALL ME SACHI** (P. Gatt) – trainer, Mr S. Theodore, advised Stewards prior to the event that he would advise his rider to attempt to lead in today's event differing from its most recent race start. Led. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed the filly to be lame in the off foreleg. Trainer, Mr S. Theodore, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**CHASE THE STORM** (B. Claridge) – late arrival on course. Trainer, Ms R. Day, pleaded guilty to a charge under LR8.9.2 and was reprimanded. Over-raced in the early stages of the event.

**DIVINE BLISS** (B. Griffiths) – bounded when making the crossing in the vicinity of the 1700 metres. In the vicinity of the 1100 metres shifted in making contact with the running rail.

**RACE 2: TREASURY WINES ESTATES MAIDEN PLATE – 1400 metres**

**HOLY TRILOGEY** (J. Toeroek) – in the vicinity of the 1000 metres had to be checked to avoid the heels of EXPLOSIVE GIFT.

**ENEMY OF THE STATE** (P. Gatt) – in the vicinity of the 1000 metres was hampered by AMBER DIAMONDS, which was taken in by KING TOMLOLA, which shifted in when insufficiently clear. In the vicinity of the 100 metres had to be restrained to avoid the heels of KING TOMLOLA.

**EXPLOSIVE GIFT** (D. Thornton) – in the vicinity of the 1000 metres was severely hampered and had to be checked almost dislodging its rider after ENEMY OF THE STATE was taken in by AMBER DIAMONDS, which was taken in by KING TOMLOLA.

## **RACE 2: TREASURY WINES ESTATES MAIDEN PLATE – 1400 metres (cont'd)**

**KING TOMLOLA** (R. Hurdle) – in the vicinity of the 1000 metres shifted in when insufficiently clear of AMBER DIAMONDS, which was taken in onto ENEMY OF THE STATE, which was hampered and taken in onto EXPLOSIVE GIFT, which had to be checked when awkwardly placed on the running rail. In the incident HOLEY TRILOGEY, which was following EXPLOSIVE GIFT, had to be checked to avoid the heels of EXPLOSIVE GIFT. Rider severely reprimanded and reminded of his obligation to be clear when shifting ground in future. Rolled in when placed under pressure in the straight and in the vicinity of the 100 metres tightened ENEMEY OF THE STATE. Rider reprimanded. Rider was dislodged on pulling up in today's event. R. Hurdle was examined by the First Care Medical personnel and passed fit to fulfil his remaining engagements.

**TURF RAT** (R. Clark) – slow to begin.

**WHISKYTANGOFOXTROT** (J. Kah) – a post-race veterinary examination revealed a higher than expected heart rate.

**AMBER DIAMONDS** (J. Bowditch) – in the vicinity of the 1000 metres was taken in onto ENEMY OF THE STATE when by KING TOMLOLA, which shifted in when insufficiently clear.

Correct weight for this event was delayed to allow P. Gatt (ENEMY OF THE STATE) placed fifth, and trainer, Mr R. Balfour, to view the official vision. After doing so P. Gatt lodged an objection against AMBER DIAMONDS (J. Bowditch) being placed fourth alleging interference from the vicinity of the 1000 metres to the 900 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

P. Gatt also lodged an objection against KING TOMLOLA (R. Hurdle) being declared the third placegetter alleging interference from the entrance to the home straight until the vicinity of the 90 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

## **RACE 3: YOUNG GUNS DAY SAT JULY 8TH / SABOIS MAIDEN PLATE - 1200 metres**

**HE'S GOT SKILLS** (P. Gatt) – rider reported that he became concerned with the action of the gelding in the home straight and elected not to place his mount under pressure over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**TYPHON'S TOMMY** (A. Doyle) – rider reported that his mount raced erratically throughout the event and in the vicinity of the 500 metres shifted in despite his efforts hampering HIDATSA. Held up for clear running on entering the straight. Trainer, Mr G. Searle, was advised that a warning had been placed on the gelding in relation to its tractability. A post-race veterinary examination revealed no visible abnormalities.

**GOLD DRAGONESS** (B. Claridge) – laid in when placed under pressure in the straight.

**BARABBA GOLD** (D. Thornton) – held up for clear running on entering the straight.

**HIDATSA** (J. Toeroek) – in the vicinity of the 500 metres had to be restrained to avoid the heels of TYPHON'S TOMMY, which shifted in despite the efforts of its rider. Rider reported that his mount laid in, in the straight.

**MILITARY FORCES** (R. Hurdle) – knuckled on jumping away.

## **RACE 4: GOLDIN FARMS CLASS TWO HANDICAP - 1200 metres**

**BREAKER OF CHAINS** (S. Cahill) – jumped away awkwardly making contact with the outside partition of the barriers.

**JUST MAK** (J. Holder) – held up for clear running from the vicinity of the 500 metres until inside the 400 metres.

### **RACE 5: COOPERS / SABOIS THREE-YEAR-OLD BENCHMARK 64 HANDICAP - 1200 metres**

**POUND STERLING** (A. Jordsjo) – began awkwardly, shifting out and making contact with IMPERIAL JOURNEY. In the vicinity of the 1000 metres had to be restrained to avoid the heels of IMPERIAL JOURNEY, which shifted in when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

**JET EXPRESS** (D. Caboche) – shifted in on jumping away making contact with GOLD DENARI.

**IMPERIAL JOURNEY** (P. Gatt) – hampered on jumping away. In the vicinity of the 1000 metres shifted in when insufficiently clear of POUND STERLING. Rider was reminded of his obligations to be clear when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities.

**GOLD DENARI** (J. Bowditch) – hampered on jumping away. Held up for clear running from the vicinity of the 500 metres to inside the 400 metres.

**HARLEM CHILD** (V. Wong) – hampered on jumping away. Held up for clear running from the entrance of the home straight to inside the 200 metres.

**RED QUIRINA** (S. Fawke) – began awkwardly and shifted in making contact with HARLEM CHILD.

### **RACE 6: CRABB SHELLGRIT BENCHMARK 60 HANDICAP - 1400 metres**

**THE OTHER GUY** (S. Cahill) – a post-race veterinary examination revealed no visible abnormalities.

**KINGSGROVE** (J. Bowditch) – raced keenly in the middle stages of the event.

**JUST PEGGY** (J. Kah) – raced keenly in the early and middle stages of the event.

**CAPITOLINE** (Z. Spain) – raced keenly in the middle stages of the event.

**BOURDAIN** (S. Fawke) – slow to begin. Raced keenly in the middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

### **RACE 7: TERRACE FUNCTION CENTRE BENCHMARK 60 HANDICAP - 1400 metres**

**RAISE A DREAM** (A. Jordsjo) – laid out under pressure in the straight.

**SIMPATICO** (J. Potter) – laid out when placed under pressure in the straight.

**COMPLETE CLASS** (J. Holder) – slow to begin. Held up for clear running from in the vicinity 500 metres to inside the 300 metres. Had difficulty obtaining clear running from the 75 metres to the finish. A post-race veterinary examination revealed no visible abnormalities.

**FREEDOM ROAD** (R. Hurdle) – raced keenly in the middle stages of the event.

**EMMOOKI'S STAR** (J. Kah) – slow to begin. Held up for clear running from the 500 metre to in the vicinity of the 400 metres.

**WISH LIST** (R. Clark) – raced keenly in the middle stages.

**SHOWVIZ** (K. Crowther) – a post-race veterinary examination revealed no visible abnormalities.

### **RACE 8: RON HUGHES MEMORIAL CUP - 2100 metres**

**I HAVE A DREAM** (Jemma Frew) – momentarily held up for clear running on entering the straight.

**LETSAVA WIN (NZ)** (J. Kah) – over-raced in the early and middle stages of the event.

**MIGHTY MAHER** (P. Gatt) – jumped away awkwardly.

**RACE 8: RON HUGHES MEMORIAL CUP - 2100 metres (cont'd)**

**BON ELISE** (S. Fawke) – laid in, in the early stages of the event. In the vicinity of the 1900 metres rolled in momentarily inconveniencing JIMMYTOWN JEWEL.

**JIMMYTOWN JEWEL** (D. Caboche) – momentarily inconvenienced in the vicinity of the 1900 metres when BON ELISE laid in. Made the crossing awkwardly.

**RACE 9: KINGSFORD HOTEL BENCHMARK 60 HANDICAP – 1100 metres**

**RUG RAT** (B. Griffiths) – rider reminded of his obligations to ride his mounts out to the finish.

**WAPPING** (K. Bishop) – laid in when placed under pressure in the straight.

**BOLDACIOUS GIRL** (A. Jordsjo) – raced in restricted room shortly after jumping away.

**NUTHERBOTTLEGONSKI** (J. Toeroek) – late scratching on veterinary advices at 8.04 am. Trainer, Mr G. Carter, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.
