## RACE 2: CARLING FUEL DISTRIBUTORS/ LION NATHAN BREWING/ TRANSCONTINENTAL HOTEL BENCHMARK 54 HANDICAP - 1200 metres

**LAIKA GORDO** (S. Metcalfe) – contacted on jumping away.

**MORADO** (M. Henderson) – contacted a perimeter fence en route to the barriers. Underwent a prerace veterinary examination and passed fit to race. Jumped away awkwardly, shifted in and contacted LAIKA GORDO. A post-race veterinary examination revealed no visible abnormalities.

## RACE 3: UBET/ EMANUELE BROS ISUZU/ QUANDONG CAFE BENCHMARK 64 HANDICAP - 1400 metres

**SIR DYLAN** (K. Crowther) – slow to begin. A post-race veterinary examination revealed a torn suspensory to the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. Trainer Ms K. Mckerlie advised the gelding would now be retired.

#### RACE 4: THE TNC FINLAY FAMILY QUORN CUP - 1900 metres

EIGELSTEIN (GB) (K. Crowther) – contacted on jumping away

SASSY JO (K. Bishop) - jumped away awkwardly and contacted EIGELSTEIN (GB).

**OVERSTREET** (A. Doyle) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.
