**RACE 1: MURRAY PIONEER / RADIO 801-5RM / RADIO 5MU / POWER FM / SABOIS C, G & E**  
**MAIDEN PLATE - 1000 metres**

**EXALTED EDWARD** (D. Caboche) – inconvenienced shortly after the start when RUBIRON jumped away awkwardly and shifted out and ONEWOOD jumped away awkwardly and shifted in. Rider explained the gelding made an abnormal respiratory noise throughout the event. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race. Trainer advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

**ONEWOOD** (J. Maund) - jumped away awkwardly and shifted in.

**RUBITRON** (S. Fawke) - jumped away awkwardly and shifted out. Raced keenly throughout the event. Approaching the home turn had to momentarily steady when continuing to race keenly on the heels of JOLLMAC.

**STREET LIFE** (P. Gatt) – laid in under pressure in the straight.

**RACE 2: KELVIN WESTBROOK TRANSPORT & FEEDLOT / VALPATA PTY LTD / SABOIS**  
**FILLIES & MARES MAIDEN PLATE - 1000 metres**

**ANGEL'S BELLE** (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**MARG'S MINT** (J. Maund) - slow to begin. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities. Trainer advised a warning had been placed on the mare.

**GOOD NIC** (J. Kah) - jumped away awkwardly and as a result was slow into stride.

**LADY LA MANCHA** (J. Toeroek) – bumped on jumping way.

**ZAKOSHEA** (R. Clark) – bumped on jumping away. Lost its off hind plate during the event.

**RACE 3: LOXTON IRRIGATION CENTRE / TONY NOLAN MARRIAGE CELEBRANT / SABOIS  
MAIDEN PLATE - 1380 metres**

**HE'S A VALLEYBOY** (C. Lindop) - slow to begin. Tailed the field throughout. A post-race veterinary examination revealed no visible abnormalities. Trainer advised a warning had been placed on the gelding.

**SHOULD HAVE I** (A. Doyle) – stood flat-footed and was very slow to begin. Tailed the field throughout. A post-race veterinary examination revealed no visible abnormalities. Trainer advised a warning had been placed on the gelding.

**RACE 4: ZADOW WELL DRILLERS BENCHMARK 56 HANDICAP – 1800 metres**

**WATCHOUT WATCHOUT** (J. Toeroek) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**AMICONI ORIGINALE** – underwent a pre-race veterinary examination on arrival at the barriers and was found to be lame. Acting on that advice Stewards withdrew the gelding at 1.54 pm.

**MOON ARROW** (J. Huxtable) – in the vicinity of the 600 metres was momentarily inconvenienced when being restrained off the heels of HAILWIN.

**DISCERN** (C. Lindop) – raced ungenerously in the early and middle stages of the event.

**MAKO MAGIC** (A. Doyle) - raced ungenerously in the early and middle stages of the event.

**HAILWIN** (K. Bishop) – in the vicinity of the 600 metres had to be momentarily steadied when AUTOMED shifted in marginally.

**RACE 5: MALLEE DIPPING AND MULESING BENCHMARK 56 HANDICAP - 1800 metres**

**KAZOOM** (NZ) (J. Toeroek) - slow to begin. Raced keenly in the early and middle stages of the event.

**PAT THE WEAPON** (T. Pannell) – in the vicinity of the 400 metres had to shift out to avoid the heels of WISH LIST, which shifted out when insufficiently clear.

**PRESUMPTION** (S. Fawke) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**WISH LIST** (R. Clark) – in the vicinity of the 400 metres shifted out when insufficiently clear. Rider severely reprimanded under AR137(a) for careless riding.

**BLACKMOOR** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 6: JB ELECRICAL BENCHMARK 56 HANDICAP - 1380 Metres**

**BOLDACIOUS GIRL** (R. Clark) – shortly after entering the straight was buffeted for a short distance between CENTENARY SHOT, which shifted out under pressure and MOLLY THE SNIP, which shifted in under pressure.

**MOLLY THE SNIP** (M. Neilson) – rider reported the mare felt awkward in its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

**SPIRITED MATCH** (T. Pannell) – approaching the home turn was inclined to hang out onto the heels of RORY'S UNION and as a result had to be momentarily steadied and lost its position. A post-race veterinary examination revealed lacerations to the off foreleg. First aid administered.

**RACE 7: RELAX RETREAT BENCHMARK 56 HANDICAP - 1380 metres**

**DEWANGSA** (M. Neilson) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**FUGITIVE** (S. Fawke) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 8: COLLINS INDUSTRIAL DISTRIBUTORS PTY LTD MINDARIE-HALIDON CUP  
- 1800 metres**

**EMMOOKI'S DASH** (J. Potter) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**SASSY JO** (K. Bishop) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**FINAL TABLE** (T. Zanker) – raced wide without cover throughout the event.

**SANZIO** – a late scratching at 1.42 pm due to the track upgrade.

**KEEPAKIWI** (NZ) (S. Fawke) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**RACE 9: FLEA & DOUG FULLSTON AND VAL & NORM HUMPHRYS BENCHMARK 64  
HANDICAP - 1000 metres**

**POUND STERLING** (V. Wong) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**KESAN** (P. Gatt) – held up for clear running in the vicinity of the 100 metres for a short distance.

**BELEAGUER** (A. Jordsjo) - jumped away awkwardly and shifted out.

**AMATIVE** (C. Lindop) - jumped away awkwardly and shifted in.

**SAMBUCA SIREN** (J. Maund) – inconvenienced shortly after the start when BELEAGUER jumped away awkwardly and shifted out. Inside the 100 metres had to momentarily steady off the heels of POUND STERLING, which shifted out marginally.
