**Report on Race Meeting held at Gawler Racecourse**  
**by the Gawler & Barossa Jockey Club on Wednesday, 11 October 2017**

**TRACK:** Good 4 (*Downgraded to Soft 5 at 12.54 pm retrospective to Race 1).*  
(*Downgraded to Soft 6 at 2.02 pm retrospective to Race 3).*  
(*Downgraded to Soft 7 at 2.38 pm).*  
(*Downgraded to Heavy 8 at 3.11 pm retrospective to Race 5)*

**WEATHER:** Showery.

**RAIL:** Out 3 metres 800 metres to 400 metres, true remainder.

**RACE 1: GAWLER SOUTH BAKERY/ SABOIS DISTANCE MAIDEN PLATE – 2100 metres**

**ROCKARRAL** (J. Kah) – raced greenly in the straight.

**SCOPE (NZ)** (V. Wong) – weakened from in the vicinity of the 500 metres. A post-race veterinary examination revealed the mare had suffered a bi-lateral bleeding attack. Trainer, Mr D. Saxon, was advised as this was the mare's first bleeding attack, SCOPE (NZ) would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

**RACE 2: ADCOCK REAL ESTATE/ SABOIS MAIDEN PLATE – 1700 metres**

**EXALTED TRAVELLER** (D. Caboche) – slow to begin.

**HEZ A WOLF** (V. Wong) – raced keenly in the early and middle stages of the event.

**ZERNIKNAMAC** (D. Tourneur) – Performed poorly. A post-race veterinary examination revealed no visible abnormalities.

**ALWAYS RED** (J. Potter) – slow to begin. Rider report that the mare did not feel comfortable in its action during the event and for this reason he did not ride ALWAYS RED out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

**BOX ON COLLINS** (J. Kah) – Trainer, Mr T. McEvoy was fined \$50 under AR59A for failing to produce the Thoroughbred Identification Card. The colt was permitted to start as it was able to be identified from records held by the Stewards.

**CARAFFINI** (J. Toeroek) – underwent a pre-race veterinary examination on arrival on course and found to be lame in the near foreleg. Acting on this advice Stewards withdrew CARAFFINI at 11.28 am.

**RACE 3: TERRACE FUNCTION CENTRE/ SABOIS MAIDEN PLATE - 1100 metres**

The start of this event was delayed approximately 1 minute.

**MAPLE'S IMAGE** (K. Bishop) – held up for clear running from in the vicinity of the 500 metres until shortly after entering the straight when racing between TOO TUFF TARA and GO TO GATE.

### **RACE 3: TERRACE FUNCTION CENTRE/ SABOIS MAIDEN PLATE - 1100 metres (cont'd)**

**PUJOLS** (C. Lindop) – slow to begin. Rider reported that in her opinion the gelding didn't feel comfortable in its action when placed under pressure in the straight and for this reason elected not to ride PUJOLS out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

**BLAZING BULLET** (K. Crowther) – jumped away awkwardly, shifted out and bumped COVER GIRL.

**DARRYL'S LIBERTY** (D. Caboche) – late scratching at 1:52 pm as it refused to leave the mounting yard. Trainer, Mr C. Bieg, was advised that the gelding was now required to complete an Official Barrier Trial to the satisfaction of Stewards prior to a future race.

**PREPARETOGO** (J. Potter) – lost its off hind plate during the event.

**COVER GIRL** (R. Hurdle) – bumped at the start as BLAZING BULLET jumped away awkwardly and shifted out.

**GO TO GATE** (A. Doyle) – jumped away awkwardly. Inclined to lay in under pressure in the straight.

**LADY OF CREBILLY** (D. Tourneur) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 4: 2017 GAWLER CUP SUNDAY OCT 29TH FOUR-YEAR-OLD & OVER BM 56 HANDICAP - 1700 metres**

**SEEK TO DESTROY** (S. Price) – rider reported that in his opinion the gelding raced flat in today's event. A post-race veterinary examination revealed no visible abnormalities.

**TRICKY AFFAIR** (D. Caboche) – inside the 1400 metres became awkwardly placed on the heels of WISH LIST and was obliged to be eased and shift out. A post-race veterinary examination revealed no visible abnormalities.

**FREE THE WIND** (V. Wong) – raced wide without cover throughout the event.

**GIFT OF PRIMUS** (J. Holder) – slow to begin.

**SPIEGEL GROVE** (T. Pannell) – raced wide without cover during the early stages of the event.

**WISH LIST** (R. Clark) – inside the 1400 metres, when taking up a forward position, rider steadied the pace of her mount, and as a result TRICKY AFFAIR was obliged to be eased and shift out. Rider reminded of her obligations under AR137(d) in relation to excessively reducing the speed of her mount. Held up for clear running from in the vicinity of the 500 metres until shortly after the entrance to the straight.

### **RACE 5: GOLDIN FARMS CLASS TWO HANDICAP - 1500 metres**

**ANGELUCCI (NZ)** (J. Bowditch) – required to be reshod prior to leaving the mounting yard as the near fore plate had become loose. Underwent a pre-race veterinary examination and passed fit to start. In the vicinity of the 1100 metres shifted in onto FUGITIVE, which was racing keenly and was obliged to be eased. Rider severely reprimanded and advised to take greater care in future.

**RUPTURE** (J. Toeroek) – laid in under pressure in the straight.

**FUGITIVE** (D. Caboche) – lost its off hind plate during the running of the event. In the vicinity of the 1100 metres, when racing keenly, was obliged to be eased as ANGELUCCI (NZ) shifted in.

**AY OH WHEY OH** (R. Clark) – in the vicinity of the 300 metres was inconvenienced for a number of strides when attempting a run to the inside of AUGUSTA BELLE and outside of DEDUCT (NZ), which rolled out marginally.

### **RACE 5: GOLDIN FARMS CLASS TWO HANDICAP - 1500 metres (cont'd)**

**AUGUSTA BELLE** (J. Kah) – had difficulty obtaining clear ground from rounding the home turn until shortly after the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**DEDUCT (NZ)** (C. Lindop) – inclined to lay out under pressure in the straight and in the vicinity of the 300 metres rolled out and inconvenienced AY OH WHEY OH for a number of strides.

### **RACE 6: HOLDFAST INSURANCE BROKERS CLASS TWO HANDICAP - 1200 metres**

**VONRASANA** (J. Potter) – late scratching at 3.15 pm due to the track downgrade.

**REGAL GROVE** (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

**GOLDPHON** (A. Doyle) – late scratching at 3.17 pm due to the track downgrade.

**LOVE AND OBEY** (D. Caboche) – slow to begin. Rider explained the mare travelled well in the early stages of the event; however, when asked for an effort from inside the 800 metres failed to respond to his riding, and for this reason he elected not to ride LOVE AND OBEY out in his normal manner. Beaten twenty-five lengths. Trainer, Mr M. Moosha, was advised that a warning had been placed on the mare in relation to its competitiveness in today's event.

**SOCIAL LANE** (C. Lindop) – late scratching at 3.17 pm due to the track downgrade.

### **RACE 7: COOPERS PREMIUM LAGER MARES BENCHMARK 64 HANDICAP - 1200 metres**

**CONTAINMENT** (R. Hurdle) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In assessing penalty Stewards took into account R. Hurdle's circumstances during the event. He also pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip on consecutive strides and was reprimanded.

**SHORT STUFF** (R. Clark) – slow to begin.

**SWEET VARDEN** (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

**RED FAIRARIE** (K. Stra) – late scratching at 12.58 pm due to the track downgrade.

### **RACE 8: TREASURY WINE ESTATE FOUR-YEAR-OLD & OVER BENCHMARK 60 HANDICAP – 1100 metres**

**ILGATTINO** (S. Cahill) – in the vicinity of the 500 metres shifted out contacting ALBERDINI, and as a result turned that gelding's hindquarters.

**SUPER RULES** (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

**ALBERDINI** (C. Lindop) – in the vicinity of the 500 metres had its hindquarters turned when contacted by ILGATTINO, which shifted out.

**MY SNIP** (T. Pannell) – bumped at the start as BWUVA jumped away awkwardly and shifted in.

**BWUVA** (S. Price) – jumped away awkwardly, shifted in and bumped MY SNIP.

**DANDY MANDY** (J. Maund) – late scratching at 2.17 pm due to the track downgrade.

**REACT** (D. McWhinney) – a post-race veterinary examination revealed no visible abnormalities.

**AMATIVE** (R. Clark) – late scratching at 4.23 pm due to the track downgrade.

**ARAZITOFF** (D. Tourneur) – late scratching at 12.58 pm due to the track downgrade.

Race 3 – DARRYL'S LIBERTY – Suspended – Required to complete Official Barrier Trial to the Stewards' satisfaction – Refused to proceed to the barriers. Race 6 – LOVE AND OBEY – Warning – Uncompetitive.
