**RACE 1: BTR EXCAVATIONS / SABOIS DISTANCE MAIDEN PLATE - 2224 metres**

The start of this event was delayed approximately two minutes owing to remedial work to the outside running rail.

**LEMON ZEST** (S. Fawke) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**NOGGIN** (A. Jordsjo) - a post-race veterinary examination revealed the filly suffered a bi-lateral bleeding attack. Trainer Mr B. Brook was advised the filly was suspended from racing for a period of three months in accordance with AR53A.

**RACE 2: ALDENHOVEN HOMES MAIDEN PLATE - 1056 metres**

**PUNCHEON JOURNEY** (J. Toeroek) – rider pleaded guilty to a charge under AR137A(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$200.

**VANDERLUNE** (J. Maund) – laid in when placed under pressure in the straight.

**RACE 3: MCEVOY MITCHELL AT KILDALTON PARK / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1412 metres**

**BAD WOLF** (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

**GORILLE** (P. Gatt) - slow to begin. Laid in when placed under pressure in the straight.

**INDIAN MO** (S. Cahill) – contacted on entering the straight by GHODELEINE, which shifted out to improve.

**GHODELEINE** (J. Kah) – held up entering the straight and in the vicinity of the 400 metres shifted out in an attempt to improve and made contact with INDIAN MO.

**GO TO GATE** (A. Doyle) – began awkwardly. Over-raced in the early stages of the event. Laid out rounding the home turn.

**RACE 3: MCEVOY MITCHELL AT KILDALTON PARK / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1412 metres (Cont'd)**

**OUR MEMORIES** (D. Tourneur) – began awkwardly making contact with the inside partition of the barriers. Rider examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. A post-race veterinary examination revealed the filly to be exhibiting signs of low grade lameness in the hindquarters due to tying up. Trainer, Mr J. Macmillan, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**TOO TUFF TARA** (R. Clark) – raced greenly when placed under pressure in the straight.

**RACE 4: ADELAIDE GALVANISING INDUSTRIES / SABOIS MAIDEN PLATE - 1212 metres**

**COOL FONZY** (T. Pannell) – hampered on jumping away.

**PUJOLS** (C. Lindop) - a post-race veterinary examination revealed no visible abnormalities.

**AWESOME STAR** (P. Gatt) – rider pleaded guilty to a charge under AR137A(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$100.

**BIRDS IN HAND** (K. Bishop) - underwent a pre-race veterinary examination after being kicked behind the barriers and passed fit to race.

**PRINCESS LEAH** (J. Toeroek) – held up for clear running on entering the home straight. Rider reported that his mount hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**SVETLANA'S ARROW** (D. Tourneur) - underwent a pre-race veterinary examination after being fractious in the barriers and passed fit to race. Shifted in on jumping away making contact with COOL FONZY. In the vicinity of the 600 metres dipped for no apparent reason.

**RACE 5: MY BUTCHER CLASS TWO HANDICAP - 1412 metres**

**IMPULSE DIAVOLO** (A. Jordsjo) – over-raced in the early stages of the event. Rider reported her mount hung out when placed under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**SINGLE BARREL** (S. Cahill) - underwent a pre-race veterinary examination as it had not raced in the past 12 months and passed fit to race. Trainer Mr W. Smart was fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

**MYSTICANO** (T. Pannell) - jumped away awkwardly.

**FULLY STOKED** (D. Tourneur) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**PARENTIVE** (D. Caboche) – began awkwardly making contact with the outside partition of the gates.

**RACE 6: HENSON LLOYD BENCHMARK 56 HANDICAP – 1612 metres**

**MY THREE SONS** (D. Tourneur) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100. A post-race veterinary examination revealed no visible abnormalities.

**TRICKY AFFAIR** (D. Caboche) – over-raced in the early stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 6: HENSON LLOYD BENCHMARK 56**

**HANDICAP – 1612 metres (Cont'd)**

**PRINCESS TITANIC (NZ)** (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

**BALLAST** (E. Finnegan) – laid out under pressure over the concluding stages of the event. Rider was dislodged on pulling up after the event. Rider examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

**AY OH WHEY OH** (R. Clark) – began awkwardly and as a result was slow to begin.

**RACE 7: RIVERINE PREMIUM BEEF BENCHMARK 64 HANDICAP - 1056 metres**

The start of this event was delayed approximately five minutes.

**BRIMARVI EQUIADA** (J. Toeroek) – in the vicinity of the 700 metres shifted in when insufficiently clear of ASHERO. Rider reprimanded under AR137(a) for careless riding. A post-race veterinary examination revealed the gelding to be slow to recover.

**BWUVA** (S. Price) – hampered shortly after jumping away. Laid in under pressure in the straight.

**TROGIR** (E. Finnegan) - underwent a pre-race veterinary examination after taking hold of its rider en route to the barriers and was passed fit to race.

**ASHERO** (A Jordsjo) – shifted out on jumping away. In the vicinity of the 700 metres became awkwardly placed on the heels of SPIRITUAL GIRL after BRIMARVI EQUIADA shifted in when insufficiently clear.

**SPIRITUAL GIRL** (T. Pannell) – a post-race veterinary examination revealed the filly to be slow to recover.

**FANCY RUMBLE** (K. Crowther) – a late scratching at 4.32 pm on veterinary advice after breaking through the barriers and galloping for a significant distance. Co-Trainer Mr G. Kent was advised the filly would be required to trial to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

Following Race 7 rider D. Tourneur was re-examined by the First Care Medical Personnel and ruled unfit to fulfil his remaining engagements.

**RACE 8: TAYLORS WINES BENCHMARK 56 HANDICAP - 1212 metres**

**REGAL GROVE** (P. Gatt) – rider pleaded guilty to a charge under AR137A(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$100.

**BENGARA** (S. Fawke) – over-raced in the early and middle stages of the event.

**MELODY QUEEN** (K. Crowther) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$500.

**RED FAIRARIE** (K. Stra) – held up for clear running on entering the home straight until inside the 400 metres. Rider pleaded guilty to a charge under AR137A(5)(a)(i) in that she used her whip in a forehand manner in consecutive strides prior to the 100 metres and was reprimanded. Rider also pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**MOONIES CHOICE** (A. Doyle) - underwent a pre-race veterinary examination as it had not raced in the past 12 months and was passed fit to race. Rider pleaded guilty to a charge under AR137A(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was reprimanded.

**ZAAZOE** (E. Finnegan) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$100.

**GENERAL:**

Trainer Mr J. Macmillan pleaded guilty to a charge under AR87B (1) in that at trackwork at his registered training facility on Tuesday, 24 October 2017 he was mounted on a horse without an approved safety vest and was fined \$400.
