RACE 1: PETER & ROBYN WALTERS / SABOIS MAIDEN PLATE - 1430 metres

BABYLON (NZ) (C. Collins) - slow to begin.

ALI ORPHAN (NZ) (K. Walters) – in the vicinity of the 400 metres dipped for no apparent reason.

BERKSHIRE BABE (S. Fawke) – stood flat-footed and was very slow to begin. Trainer Mr D. Dodson was advised the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

RACE 2: FAMILY RACE DAY JANUARY 7TH 2018 / SABOIS MAIDEN PLATE – 1000 metres

SCOPEN SUCCESS (J. Maund) – rider explained the mare did not handle today's track conditions and the removal of its blinkers may have been a disadvantage to the mare in today's event. Performed below expectations. A post-race veterinary examination revealed the mare to be shin sore in the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

SEDUCE ME NOW (Jemma Frew) – in the vicinity of the 800 metres shifted in abruptly unbalancing its rider for a short distance. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

MACOOPER (L. Griffin) - jumped away awkwardly and as a result was slow into stride.

JIMMY JINX (K. Walters) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ZEMLYA (K. Bishop) – shortly after the start was momentarily inconvenienced when racing in restricted room for a short distance.

RACE 3: COOPERS HANDICAP - 2000 metres

SURVIVED (NZ) (H. McKechnie) – inconvenienced at the start when taken wider when UNICAJA jumped away awkwardly and shifted out. Raced keenly in the early stages of the event. Rider explained the gelding, in her opinion, did not handle today's track conditions.

UNICAJA (NZ) (K. Walters) - jumped away awkwardly and shifted out inconveniencing SURVIVED (NZ), which was taken wider.

QUEEN'S PALACE (K. Bishop) – raced keenly in the early stages of the event.

RACE 4: FINNS FINE FOODS BENCHMARK 80 HANDICAP - 1430 metres

BIANMAGIC (H. McKechnie) - slow to begin. Racked keenly in the early and middle stages of the event.

IN MUM'S MEMORY (K. Bishop) - slow to begin.

RACE 5: NARACOORTE CUP FEBRUARY 11 2018 BENCHMARK 60 HANDICAP - 1100 metres

OOSTERMAN (Jemma Frew) – laid in under pressure in the straight.

GO WALLY (S. Fawke) - slow to begin.

ARCADIAN (D. Tourneur) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

MISS MOSH (K. Stra) – raced greenly throughout the event. Approaching the 100 metres shifted in abruptly while continuing to race greenly. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: HENSCHKE INDUSTRIES PTY LTD BENCHMARK 60 HANDICAP - 2000 metres

ESSENCE PREVAIL (K. Bishop) - slow to begin.

MISTER WILL (D. Tourneur) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SANDHILL HALO (H. McKechnie) – approaching the 1500 metres made the turn awkwardly and shifted out inconveniencing RESETTHEODDS, which was taken wider. Raced keenly in the early and middle stages of the event.

RESETTHEODDS (K. Stra) – approaching the 1500 metres was inconvenienced when taken wider as SANDHILL HALO shifted out.

JUST RANGER (S. Fawke) – laid in under pressure in the straight.

RACE 7: LOCAL TRAINERS BENCHMARK 80 HANDICAP - 1100 metres

ELZETTE (H. McKechnie) – in the vicinity of the 1000 metres dipped on two occasions for no apparent reason.

BROAD SHOULDERS (T. Germaine) – approaching the 100 metres was unable to obtain clear running for a short distance.

RACE 8: PETER AND ELAINE LUDWIG BENCHMARK 60 HANDICAP - 1430 metres

EMIL (C. Collins) – rider explained that after looking for a run along the fence in the vicinity of the 600 metres she was unable to improve her position, elected to take the gelding wider and finished off the race in a positive manner. She added that the gelding was looking for more ground. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: PETER AND ELAINE LUDWIG BENCHMARK 60 HANDICAP - 1430 metres (Cont'd)

LEAD THE WITNESS (D. Tourneur) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

CELESTIAL STORY (T. Germaine) - slow to begin.

CRYSTAL GLASS (S. Fawke) - slow to begin.
