**RACE 1: PORT LINCOLN CRANE HIRE / SABOIS THREE-YEAR-OLD MAIDEN PLATE**  
- 1000 metres

**I AM DEXTER** (R. Hurdle) – shifted in abruptly shortly after the start. In the vicinity of the 300 metres shifted in abruptly making heavy contact with SHEZA PROPHET. Inclined to lay in, in the straight. A post-race veterinary examination revealed minor abrasions to the left knee.

**LIONSTAR** (A. Jordsjo) – knuckled on jumping away.

**AMERICAIN SAPHIRE** (C. Davies) – jumped away awkwardly. Raced fiercely in the early stages of the event. In the vicinity of the 700 metres had to be steadied when it improved onto the heels of TELEPHON QUEEN.

**BRAMFIELD** (B. Paterson) - slow to begin.

**SHEZA PROPHET** (K. Bishop) – became unbalanced in the vicinity of the 300 metres when contacted by I AM DEXTER.

**TELEPHON QUEEN** (S. Fawke) – slow to begin.

**RACE 2: JONES ELECTRICAL / SABOIS MAIDEN PLATE - 1210 metres**

**ECHO WARRIOR** (A Jordsjo) – hung out rounding the home turn.

**EQUIDANT** (K. Stra) – taken in shortly after the start onto MISS MOSSY MCLAREN. Had to take hold in the vicinity of the 1100 metres to avoid the heels of INVINCIBLE SUSHI. Improved onto the heels of INVINCIBLE SUSHI inside the 1000 metres and had to be steadied. Laid in under pressure in the straight.

**HARDAZ** (K. Crowther) – laid in under pressure in the straight.

**OUR FREEBIE** (T. Pannell) - slow to begin. Rider explained the gelding did not travel during the event and in his opinion would benefit from a race over a longer distance.

**FLASH HUSSY** (B. Paterson) - Trainer Mr D. Carrison was fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

## **RACE 2: JONES ELECTRICAL / SABOIS MAIDEN PLATE - 1210 metres (Cont'd)**

**FOTO ART** (C. Davies) - jumped away awkwardly and was slow into stride.

**INVINCIBLE SUSHI** (J. Maund) – shifted in shortly after the start onto EQUIDANT. In the vicinity of the 1100 metres shifted in onto EQUIDANT when insufficiently clear resulting in EQUIDANT having to take hold and lose its position. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 26 November and to conclude at midnight on Saturday, 2 December 2017: a period of 3 meetings.

**MISS MOSSY MCLAREN** (S. Fawke) – lost its position shortly after the start when tightened onto KOODA STAR by EQUIDANT. Hung in severely in the straight. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 3: PERKS INTEGRATED BUSINESS SERVICES BENCHMARK 64 HANDICAP - 1210 metres**

**THE HEADLINER** (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

**THE HARD WAY** (C. Davies) – reluctant to proceed to the start. Trainer advised a warning had been placed on the mare in relation to its pre-race behaviour. Stood flat footed and missed the start. Trainer advised a warning had been placed on the mare in relation to its barrier manners. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 4: AVIS PORT LINCOLN / SABOIS MAIEN 1 PLATE - 1750 metres**

**FUGITIVE** (S. Fawke) - a post-race veterinary examination revealed minor lacerations to the near hind coronet.

**PREFERRED ROUTE** (K. Bishop) - Trainer Ms T. Harrison was fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

**XANDER'S PORSHA** (C. Davies) - jumped away awkwardly. In the vicinity of the 1200 metres improved onto the heels of MIGHTY MAGPIE and had to be steadied.

**BELAMBO** (J. Huxtable) - Trainer Ms J. Stoetzer was fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

**BLONDE VOYAGE** (T. Pannell) - a post-race veterinary examination revealed minor lacerations to the near hind pastern.

**MIGHTY MAGPIE** (K. Crowther) – in the vicinity of the 1400 metres raced in restricted room for a short distance to the inside of DANOXIE and shortly thereafter, laid out across the heels of that gelding and had to be steadied. In the vicinity of the 1200 metres was inconvenienced by SYNERGY, which shifted out.

**SYNERGY** (K. Stra) – laid out throughout the event and in the vicinity of the 1200 metres shifted out onto MIGHTY MAGPIE.

## **RACE 5: GREAT NORTHERN SUPER CRISP 3.5 BENCHMARK 80 HANDICAP – 1210 metres**

**PROPSHAFT** (K. Crowther) – on pulling up rider was dislodged from the gelding. K. Crowther was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements.

**TOLSTOY** (A. Doyle) – jumped away extremely awkwardly, was reluctant to race resulting in the gelding tailing the field and being uncompetitive. Trainer advised the gelding would be required to jump with the field and be competitive in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

**WROTHAM HEATH (GB)** (J. Maund) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**RACE 6: NOSTON BAY WINES BENCHMARK 64 HANDICAP- 1390 metres**

**REVENGEFUL** (A. Doyle) - jumped away awkwardly. Rider reported his mount shifted in abruptly and contacted the running rail in the vicinity of the 400 metres and became unbalanced.

**HEZA HUSSLER** (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**NEVA DOUBT US** (K. Stra) – in the vicinity of the 600 metres improved onto the heels of DIVADEBEER and had to be steadied.

**NEW WAVE** (J. Maund) - slow to begin.

**ARTFUL MONTY** (A. Jordsjo) - a post-race veterinary examination revealed lacerations to off hind cannon.

**BENGARA** (A. Lindsay) - slow to begin.

**RACE 7: PORT LINCOLN TIMES BENCHMARK 56 HANDICAP - 1210 metres**

**ALL KRUPT** (C. Davies) – shifted in, inside the 200 metres onto OLD FARM ROAD (NZ), which was forced to take hold to avoid the heels of ALL KRUPT. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 26 November and to conclude at midnight on Saturday, 2 December 2017: a period of three meetings.

**OLD FARM ROAD (NZ)** (A. Doyle) – had to take hold in the vicinity inside the 200 metres to avoid the heels of ALL KRUPT and then had difficulty obtaining clear ground for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 8: M&M GROUP BENCHMARK 60 HANDICAP - 1000 metres**

**GET PRONTO** (J. Huxtable) – laid in under pressure in the straight and in the vicinity of the 150 metres shifted in onto INVINCIBLE ME. Rider reminded of his obligations when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

**INVINCIBLE ME** (K. Stra) – lost its position shortly after the start when tightened between NITRO MAGIC and NIPPY LIPPY. In the vicinity of the 150 metres raced in restricted room for a number of strides when awkwardly placed between the heels of MORE THAN MOST, which shifted out slightly and GET PRONTO, which laid in.

**NIPPY LIPPY** (A. Jordsjo) – shifted in on jumping away onto INVINCIBLE ME.

**MORE THAN MOST** (T. Pannell) – shifted out onto INVINCIBLE ME in the vicinity of the 150 metres. Rider reminded of his obligations when shifting ground.

**NITRO MAGIC** (J. Maund) – shifted out and away from ASHERO on jumping away onto INVINCIBLE ME.

**PRINCESS ASTRO** (A. Lindsay) – dislodged rider en route to the start and galloped riderless breaking through a perimeter fence. A late scratching at 6.07 pm. Rider examined by the First Care Medical Personnel and was uninjured. Trainer advised a warning had been placed on the mare in relation to its pre-race manners.

**OBLIQUE LINE** (K. Bishop) – raced keenly in the early and middle stages of the event.

**LAUVASSA** - a late scratching by order of Stewards at 5.10 pm as there was no apprentice rider available.
