Report on Race Meeting held at Clare Racecourse

RACE 1: MAGIC FM 5CS / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

GOLD MAESTRO (J. Maund) – hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

HAND TO HAND (NZ) (A. Jordsjo) - jumped away awkwardly and as a result was slow to begin.

ONEMORE ELMO (E. Boyd) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: AIRMASTER AUSTRALIA / SABOIS MAIDEN PLATE - 1200 metres

INCREDIBLE JOURNEY (K. Bishop) – bumped on jumping away when LONG JOURNEY jumped away awkwardly and shifted in.

MAPLE'S IMAGE (A. Jordsjo) – laid out rounding the home turn and in the straight. A post-race veterinary examination revealed no visible abnormalities.

BAD WOLF (J. Toeroek) – rider explained in his opinion the gelding raced greenly throughout.

LONG JOURNEY (J. Holder) - jumped away awkwardly and shifted in bumping INCREDIBLE JOURNEY. Raced keenly in the early and middle stages of the event. Rider explained the gelding failed to travel throughout the event and in his opinion LONG JOURNEY was very disappointing. A post-race veterinary examination revealed the gelding was lame in the near hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 3: KERSLAKE FOUNDATION FOR CLARE VALLEY / SABOIS FILLIES & MARES MAIDEN PLATE – 1100 metres

BIRDS IN HAND (B. Paterson) – laid out severely rounding the home turn. A post-race veterinary examination revealed no visible abnormalities. Trainer advised a warning has been issued on the mare.

DESXIRI (J. Toeroek) – rider explained in his opinion the mare felt awkward in its action throughout. A post-race veterinary examination revealed no visible abnormalities.

SHEZ A SHARK (T. Pannell) – rider explained the mare failed to respond to his riding throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SHOW 'EM SHARKIE (E. Boyd) – a post-race veterinary examination revealed no visible abnormalities.

TACTICAL LASS (C. Davies) - slow to begin.

RACE 3: KERSLAKE FOUNDATION FOR CLARE VALLEY / SABOIS FILLIES & MARES MAIDEN PLATE – 1100 metres (Cont'd)

POPPY DARLING (K. Stra) – raced greenly in the early and middle stages of the event.

TOFFEE BELL (K. Bishop) – took hold of its rider en route to the barriers and galloped for a considerable distance before being recaptured. A late scratching on veterinary advice at 1.57 pm. Trainer Mr A. Justice advised the filly would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

RACE 4: TAYLORS BENCHMARK 54 HCP – 1200 metres

NEVER WITHOUT YOU (A. Lindsay) – approaching the 100 metres shifted in under pressure momentarily inconveniencing SACRED MONARCH. Rider severely reprimanded.

ONEWOOD (J. Kah) – from the entrance to the straight to the vicinity of the 200 metres was held up for clear running.

SACRED MONARCH (J. Toeroek) – approaching the 100 metres was momentarily inconvenienced when NEVER WITHOUT YOU shifted in under pressure when insufficiently clear.

RACE 5: XXXX GOLD BENCHMARK 56 HANDICAP - 1800 metres

TRICKY AFFAIR (J. Toeroek) – raced keenly in the early and middle stages of the event. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ZERO PATIENCE (C. Lindop) – laid in under pressure in the straight.

SHADOWS ABOVE (D. McWhinney) - slow to begin.

RACE 6: TAMINGA HOTEL CLARE VALLEY CUP - 1800 metres

STAR WARS (NZ) (J. Toeroek) – raced keenly in the early and middle stages of the event. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

FANTASTIC MAGIC (C. Lindop) – raced keenly in the early and middle stages of the event.

CASINO EXIT (C. Davies) – approaching the 900 metres was momentarily inconvenienced when racing tight between runners.

RACE 7: JIM BARRY MEMORIAL BENCHMARK 64 HANDICAP - 1100 metres

MAKO COVE (A. Doyle) – approaching the 700 metres laid in bumping GET IN THE BOWL and as a result MAKO COVE was awkward in its stride when having its hindquarters turned out. Approaching the home turn laid out and as a result was awkwardly placed on the heels of KIWI BOSS for a short distance. A post-race veterinary examination revealed no visible abnormalities.

JUST A BIGGER DASH (J. Kah) – raced keenly in the early stages of the event.
