**Report on Race Meeting held at Ceduna Racecourse**

**RACE 1 : GYPSUM RESOURCES AUSTRALIA BENCHMARK 54 HANDICAP - 1200 metres**

**SPINE SCHILLER** (K. Crowther) – slow to begin. Rider reported that the gelding never travelled during the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr D. Courtney, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**KOODA STAR** (K. Bishop) – rider reported the mare never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**ROMULUS FLIGHT** (L. Griffin) – raced keenly in the early stages of the event.

**RACE 2 : FLINDERS PORTS / SABOIS MAIDEN PLATE - 1000 metres**

**ARTFUL DREAMWEAVER** (A. Lindsay) – rider reported that the gelding travelled well in the early and middle stages of the event; however, failed to respond to her riding when placed under pressure in the vicinity of the 500 metres. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3 : CEDUNA FOODLAND CHRISTMAS HANDICAP - 1000 metres**

**ARTFUL FRANCYL** (D. McWhinney) – underwent a pre-race veterinary examination as it had not raced in over twelve months and was passed fit to start.

**RACE 4 : VITERRA AUSTRALIA THEVENARD CUP - 1600 metres**

**NEW WAVE** (L. Griffin) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight Saturday, 9 December 2017 and to conclude midnight Friday, 15 December 2017, a period of three meetings.

**CASINO EXIT** – late scratching at 12.40 pm due to no rider being available.

**WITCHES LUCK** (K. Crowther) – a post-race veterinary examination revealed no visible abnormalities.

**RACE 5 : PHILL STEVENS & ASSOCIATES/ MIDDLETON SECURITIES BENCHMARK 54 HANDICAP - 1600 metres**

**ONEWOOD** (A. Lindsay) – slow to begin.

**GIFT OF PRIMUS** – late scratching at 12.40 pm due to no rider being available.

**FUGITIVE** (D. Caboche) – laid out under pressure over the concluding stages.

**RACE 5 : PHILL STEVENS & ASSOCIATES/ MIDDLETON SECURITIES BENCHMARK 54**  
**HANDICAP - 1600 metres (cont'd)**

**MINDSTORMS** (M. Henderson) – rider reported that the gelding travelled well in the early and middle stages of the event; however, failed to respond to his riding when placed under pressure in the vicinity of the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

**EXALTED FEATURES** (C. Collins) – a post-race veterinary examination revealed no visible abnormalities.
