**TRACK:** Good 4

**WEATHER:** Fine

**RAIL:** Out 9 metres 1000 metres to Winning Post, out 6 metres remainder.

**RACE 1: ADELAIDE GALVANISING BOXING DAY FAMILY RACES HANDICAP - 1250 metres**

**INDIAN THUNDER** (D. Yendall) – contacted at the entrance to the straight by TAN TAT FLAME, which was attempting to shift out.

**TAN TAT FLAME** (J. Huxtable) – hampered on jumping away. Disappointed at the entrance to the straight when attempting to shift out to obtain a run to the inside of INDIAN THUNDER.

**BAD WOLF** (J. Bowditch) – jumped away awkwardly and shifted out onto TAN TAT FLAME.

**RACE 2: HAPPY 60TH DARRYL JERICHO HANDICAP – 1250 metres**

**GALAXY GAZER** (R. Clark) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**HARD EMPIRE** (D. Yendall) – contacted on jumping away.

**BAROOD** (V. Wong) – lost its off fore plate and required farrier attention. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start.

**ELZETTE** (E. Finnegan) – slow to begin.

**REDENTES EDGE** (S. Fawke) – jumped away awkwardly and shifted in contacting HARD EMPIRE.

**RACE 3: GOLDIN FARMS HANDICAP - 1950 metres**

**HAVE PLENTY** (S. Fawke) – rider reported that the gelding made the home turn awkwardly and was reluctant to stretch out in the straight. Rider dismounted on pulling up. HAVE PLENTY was examined the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. First aid administered and was referred to the Morphettville Equine Clinic for further assessment. Trainer, Mr J. Hickmott, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**TUNES** (J. Huxtable) – in the vicinity of the 700 metres shifted in onto PRETTY PUNK, which had to be steadied. Rider severely reprimanded. Rider reported that the gelding made excess upper respiratory noise during the event. A post-race veterinary examination revealed no visible abnormalities.

**PRETTY PUNK** (C. Lindop) – had to be steadied and lost its position in the vicinity of the 700 metres when tightened between TUNES, which shifted in, and PENNY FOR A POUND, which rolled out slightly.

### **RACE 3: GOLDIN FARMS HANDICAP - 1950 metres (cont'd)**

**PENNY FOR A POUND** (V. Wong) – in the vicinity of the 700 metres rolled out onto PRETTY PUNK.

**KNIGHTOFTHEREALM** (D. Yendall) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mrs S. Jaensch, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**BEAU RIVAGE** (P. Gatt) – shifted in and contacted the running rail for no apparent reason in the vicinity of the 1400 metres.

**COOL FONZY** (D. Tourneur) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

### **RACE 4: UBET HANDICAP - 1400 metres**

**CHAMOIS ROAD** (R. Clark) – inclined to lay in rounding the home turn and in the straight.

**FEDERAL COURT** (J. Bowditch) – raced keenly in the early and middle stages of the event.

### **RACE 5: SCHWEPPE'S HANDICAP - 1000 metres**

**CASHED** (S. Price) – inclined to lay in under pressure in the straight.

### **RACE 6: JAMES BOAG'S PREMIUM HANDICAP – 1000 metres**

**MYSTIFIED** (J. Huxtable) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**NODOUBTABOUTIT** (E. Finnegan) - rider reported that the mare travelled well in the early and middle stages of the event; however, had not let down as she had anticipated when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**COLOSSEUM KING** (D. Tourneur) – shortly after the start shifted out and contacted IT'S BEEN A BATTLE.

**CLASSY JACK** (J. Holder) – rider reported that in his opinion the gelding may have been feeling its feet. A post-race veterinary examination revealed no visible abnormalities.

**IRISH MINT** (V. Wong) – laid out under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**IT'S BEEN A BATTLE** (R. Hurdle) – inconvenienced shortly after the start when contacted by COLOSSEUM KING.

**VICKI'S BOY** (T. Pannell) – jumped away awkwardly.

### **RACE 7: HUGHES LIMOUSINES HANDICAP – 1400 metres**

**LAST BULLET** (R. Clark) – a post-race veterinary examination revealed no visible abnormalities.

**SHOW BENDER** (J. Huxtable) – a post-race veterinary examination revealed no visible abnormalities.

**LIGHT 'N' FIRE** (D. Yendall) – had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

**SOCIAL SET** (J. Bowditch) – jumped away awkwardly. Raced keenly in the early and middle stages of the event.

**SCRATCHY LASS** (S. Fawke) – shifted in on jumping away and bumped ENKI.

**RACE 7: HUGHES LIMOUSINES HANDICAP – 1400 metres (cont'd)**

**ENKI** (A. Jordsjo) – shifted out on jumping away and bumped SCRATCHY LASS. Inclined to lay out throughout the event.

**RACE 8: THE JUNCTION HANDICAP – 1250 metres**

**NEVER WITHOUT YOU** (S. Fawke) – jumped away awkwardly. Inclined to lay out throughout the event.

**JETELLO** (S. Cahill) – jumped away awkwardly.

**WICKED PROMISE** (V. Wong) – hung out rounding the home turn.

**IT'S HUMPHREY** (J. Holder) – jumped away awkwardly.
