ARTFUL DREAMWEAVER (A. Lindsay) – inclined to lay in, in the straight.

RACE 2 : UBET BENCHMARK 60 HANDICAP - 1000 metres

CHANDLERY (L. Griffin) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

ALWAYS RED (D. McWhinney) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

JUST PAST MIDNIGHT (M. Lawrence) – a post-race veterinary examination revealed no visible abnormalities.

TASKMASTER (M. Lawrence) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.
