**RACE 1: JACK ESTATE / SABOIS MAIDEN PLATE - 1700 metres**

**DENOMINATOR (NZ)** (J. Bowditch) – in the vicinity of the 50 metres shifted out momentarily under pressure. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**JIMMY JINX** (S. Fawke) - slow to begin.

**POWER OF WORDS** (A. Chan) - raced keenly in the early and middle stages of the event.

**GRACEFUL INTENT** (K. Bishop) – rider reported the mare made an abnormal breathing noise throughout the event. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**RACE 2: OTTELIA / SABOIS MAIDEN PLATE – 1400 metres**

**NEWBOLD LAD** (A. Chan) – in the vicinity of the 1300 metres was inconvenienced when taken wider on the track.

**THAI CONNECTION** (J. Huxtable) - jumped away awkwardly and shifted out bumping MISS CHEEVIOUS.

**SOLAAZEM** (S. Fawke) – in the vicinity of the 1300 metres was inconvenienced when taken wider on the track. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**FOURDEE** (A. Lindsay) – in the vicinity of the 1300 metres was inconvenienced when taken wider on the track.

**MACOOPER** (A. Jordsjo) – in the vicinity of the 1300 metres shifted out abruptly, inconveniencing NEWBOLD LAD, SOLAAZEM and FOURDEE, which were all taken wider. Raced keenly in the early and middle stages of the event.

**MISS CHEEVIOUS** (D. Tourneur) – bumped on jumping away when THAI CONNECTION jumped away awkwardly and shifted out.

**RACE 3: RICHARD RAY INSURANCE BROKERS / SABOIS MAIDEN PLATE - 1100 metres**

The start of this event was delayed approximately four minutes due to a power outage.

**WEPT** (A. Lindsay) – over-raced in the early and middle stages of the event.

**SANDHILL GALAXY** (A. Chan) - slow to begin.

**PRESS ON** (D. Tourneur) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 4: RYMILL COONAWARRA BENCHMARK 56 HANDICAP - 1100 metres**

The start of this event was delayed approximately three minutes.

**VELONSKI** (J. Potter) - underwent a pre-race veterinary examination and ruled unfit to start. Acting on veterinary advice Stewards withdrew VELONSKI at 11.38 am. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**MISS HASSLETOFF** (J. Maund) - Trainer Ms L. Delaney was reprimanded under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

**RACE 5: DIGIORGIO FAMILY WINES BENCHMARK 60 HANDICAP - 1400 metres**

**IAMTHEKEY** (J. Huxtable) – in the vicinity of the 300 metres shifted in marginally, momentarily inconveniencing SCROLL. Rider reminded of his obligations when shifting ground in future.

**CATCH US** (M. Julius) – stood-flat footed and was slow to begin. In the vicinity of the 50 metres had to be momentarily steadied when racing tight to the inside of SCROLL, which rolled in marginally and to the outside of SHE'S ALL POWER.

**SHE'S ALL POWER** (K. Walters) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**SCROLL** (S. Fawke) – in the vicinity of the 300 metres had to be momentarily steadied when IAMTHEKEY shifted in marginally.

**RACE 6: BOWEN ESTATE BENCHMARK 80 HANDICAP - 1300 metres**

**RHYTHMATIC** (D. Tourneur) - performed below expectations. A post-race veterinary examination revealed the gelding was lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**MISS JOOLIA** (E. Finnegan) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**GREEN VIPER** (C. Puls) – pulled hard in the early and middle stages of the event.

Correct weight for this race was delayed to allow J. Bowditch (KNIGHTOFTHEREALM), placed second to view the vision in the straight.

**RACE 7: COONAWARRA VIGNERONS CUP - 1700 metres**

The start of this event was delayed approximately seven minutes.

**WOAKWINE** (D. Tourneur) – from the vicinity of the 400 metres until the vicinity of the 200 metres was held up for clear running.

**RACE 7: COONAWARRA VIGNERONS CUP - 1700 metres (Cont'd)**

**WE'RE SO LUCKY** (J. Potter) – rider pleaded guilty to a charge under AR137A(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$200.

**ATHOS** (V. Wong) – dislodged rider in the mounting yard. Rider examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. A post-race veterinary examination revealed lacerations to the upper mouth.

**COSTA LANTE** (J. Huxtable) - slow to begin.

**RACE 8: LINDEMAN'S COONAWARRA BENCHMARK 60 HANDICAP - 1700 metres**

The start of this event was delayed approximately four minutes.

**SHOOSHKABOB** (J. Maund) – approaching the home turn had to momentarily steady around the heels of **CANNY MOVE**, which was beginning to tire.

**RESETTHEODDS** (J. Huxtable) – bumped on jumping away when **HUSTLER LA LOPE** jumped away awkwardly and shifted out. As a result, **RESETTHEODDS** was slow into stride. Rider was found guilty under AR145 in that he weighed in, in excess of half a kilogram and was fined \$200.

**HUSTLER LA LOPE** (V. Wong) - jumped away awkwardly and shifted out bumping **RESETTHEODDS**.

**TZAREVNA** (S. Fawke) – rider pleaded guilty to a charge under AR145 in that he weighed in, in excess of half a kilogram and was fined \$200

Huxtable ( <b>RESETTHEODDS</b> ) – Fined \$200 – AR145 – Weighed in, in excess of half a kilogram. Race 8 – S. Fawke ( <b>TZAREVNA</b> ) – Fined \$200 – AR145 – Weighed in, in excess of half a kilogram. T. Germaine – Fined \$100 – AR120(b) – unable to claim full allowance on <b>MACOOPER</b> (Race 2 ) and <b>HASTA LA THOMAS</b> (Race 7).
