RACE 1: JAMES BOAG'S PREMIUM HANDICAP - 1600 metres

BELFAST (Z. Spain) – when questioned regarding the performance of the colt, rider stated he was instructed to attempt to find a position off the rail in today's event. After beginning well was able to establish a position off the rail in the early stages but passing the 1500 metres, PEARL RAIDER improved to his outside and consequently elected to find a position with cover rather than place his mount under pressure in the early stages. He added his mount failed to respond to his riding from the vicinity of the 600 metres and was slightly disappointed in its finishing efforts. A post-race veterinary examination revealed no visible abnormalities.

PEARL RAIDER (C. Lindop) – rider accidentally dropped her whip in the vicinity of the 350 metres and was reprimanded.

MANHATTAN DESIRE (E. Boyd) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: SCHWEPPES HANDICAP - 1600 metres

JIM'S JOURNEY (J. Huxtable) - slow to begin.

GALAXY GAZER (C. Lindop) – over-raced in the early and middle stages of the event.

RACE 3: HOLDFAST INSURANCE HANDICAP - 1050 metres

CHICAGO TYPEWRITER (J. Huxtable) - a post-race veterinary examination revealed no visible abnormalities.

MORE THAN EXCEED (NZ) (D. Tourneur) – held up for clear running from the vicinity of the 300 metres to approaching the 200 metres.

ADOZENROSES (Z. Spain) – Trainer Mr D. Jolly was fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. Slow to begin.

HAPPY ATOM (B. Paterson) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: HUGHES LIMOUSINES HANDICAP - 1100 metres

PLUTOCRACY (C. Parish) – in the vicinity of the 850 metres had to be steadied to avoid the heels of ATLANTICA, which was taken in by LANZINI, which shifted in when insufficiently clear.

THOMPSON'S REWARD (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

ATLANTICA (V. Wong) – in the vicinity of the 850 metres had to be steadied and taken in by LANZINI, which shifted in when insufficiently clear.

LITTLEBITFUNNY (E. Finnegan) – began awkwardly and was slow to begin. Lost its off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

PURRFECT KISSES (J. Toeroek) – in the vicinity of the 850 metres had to be steadied and taken in by ATLANTICA, which was taken in by LANZINI, which shifted in when insufficiently clear.

LANZINI (D. Tourneur) - in the vicinity of the 850 metres shifted in when insufficiently clear of ATLANTICA, which had to be steadied and was taken in onto PURFECT KISSES, which had to be steadied and was taken in onto MIGHTY MICK, which had to take hold. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 10 February and to conclude at midnight on Thursday, 15 February 2018: a period of three meetings.

MIGHTY MICK (E. Boyd) – in the vicinity of the 850 metres had to take hold to avoid heels. Lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: UBET ADELAIDE CUP MONDAY 12TH MARCH HANDICAP - 1200 metres

RIZIZ (T. Pannell) – lost its near fore plate during the event.

TRIED AND TIRED (J. Huxtable) - a post-race veterinary examination revealed no visible abnormalities.

BENZ (J. Holder) – held up for clear running rounding the home turn and entering the home straight.

CANON DIABLO (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

STRATEGIC DEMAND (C. Lindop) - over-raced in the early and middle stages of the event.

ONE MORE DAISY (Z. Spain) – had difficulty obtaining clear running in the straight until inside the 100 metres.

RACE 6: MEDALLION HOMES HANDICAP - 1101 metres

DEL PIERO (J. Huxtable) - a post-race veterinary examination revealed the gelding had tied up in both shoulders. First aid administered. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

OAMARU OWL (J. Holder) – in the vicinity of the 800 metres over raced after being crossed by CHAPEL ROAD and had to be restrained. Laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

CHAPEL ROAD (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

ZALMONA (P. Gatt) – in the vicinity of the 800 metres had to be restrained to avoid the heels of OAMARU OWL.

RACE 7: ADELAIDE GALVANISING HANDICAP - 1800 metres

DIVINE SANCTION (H. Coffey) – when questioned regarding the performance of the gelding, rider stated that after beginning well was able to obtain a mid-field position as per his instructions. He added that his mount began to weaken in the vicinity of the 700 metres and finished in a disappointing manner. He further stated that in his opinion the gelding would be suited racing over more ground. A post-race veterinary examination revealed a poor respiratory recovery. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

SAGAAB (T. Pannell) – laid out rounding the home turn.

BERTWHISTLE (J. Potter) – raced wide without cover throughout the event.

TAN TAT TRUSTING (NZ) (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: THE JUNCTION HANDICAP - 1200 metres

JUST A BIGGER DASH (S. Fawke) – began awkwardly, shifted in making contact with OAMARU LAD.

OUTINTHESTREET (J. Bowditch) – in the vicinity of the 600 metres shifted out around the heels of BAKSLAP in an attempt to improve into clear running.

OAMARU LAD (Z. Spain) - contacted on jumping away.

PRETIOSA (V. Wong) – a late scratching at 3.53 pm on veterinary advice as the gelding was lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

TRAFFIC MAESTRO (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.
