# RACE 1: MURRAY PEST CONTROL - CLEVE / LOCK FRIENDLY GROCER / FROSTING AND SPRINKLES CAFÉ 54 HANDICAP – 1000 metres

**HECTIC** (D. McWhinney) – shifted out on jumping away contacting WHISTLING MIKADO.

**ARTFUL DREAMWEAVER** (A. Lindsay) – underwent a pre-race veterinary examination on arrival on course after knocking its mouth in the horse transport and was passed fit to start.

**MAGNUS MAGIC** (D. Evans) – at the entrance to the straight inconvenienced and obliged to alter course to avoid the heels of WHISTLING MIKADO, which shifted out. A post-race veterinary examination revealed the mare to have pulled up sore. Trainer, Mr J. Hickmott, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**LIVERPOOL STRIKER** (M. Henderson) – in the vicinity of the 900 metres rolled in inconveniencing WHISTLING MIKADO.

**WHISTLING MIKADO** (E. Boyd) – contacted at the start. Approaching the 900 metres was obliged to be steadied to avoid the heels of LIVERPOOL STRIKER, which rolled in. At the entrance to the straight when disappointed for a run between HECTIC and LIVERPOOL STRIKER, shifted out and inconvenienced MAGNUS MAGIC. Rider reminded of her obligations when shifting ground.

#### RACE 2: LOCK AG SERVICES / SABOIS MAIDEN PLATE - 1200 metres

**HARDAZ** (M. Henderson) – tightened at the start between Ll'L EAG, which shifted in and LIONSTAR, which shifted out.

**TYPHON'S TOMMY** (D. McWhinney) – reared on jumping away and as a result was slow into stride.

**LIONSTAR** (A. Lindsay) – shifted out at the start and tightened HARDAZ onto LI'L EAG. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

### RACE 2: LOCK AG SERVICES / SABOIS MAIDEN PLATE - 1200 metres (cont'd)

**LI'L EAG** (C. Davies) – fractious en route to the barriers and contacted an outside perimeter fence. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Shifted in at the start tightening HARDAZ onto LIONSTAR.

**TELEPHON QUEEN** (D. Evans) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 3: GERALD SCHLINK LOCK SPRINT - 1200 metres

**MORE THAN MOST** (P. Crich) – rider reported he became concerned with the geldings action from the entrance to the straight and for that reason he did not ride the gelding out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

# RACE 4: BILL HITCHCOCK MEMORIAL / WEST END / WUDINNA HOTEL MOTEL BENCHMARK 60 HANDICAP - 1400 metres

WRIST WATCH (D. Evans) – rider pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. Rider also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. Rider reported that the gelding was disappointing in the early stages of the event and in his opinion did not appreciate the underfoot conditions and finished the race off only fairly.

**TASKMASTER** (P. Crich) – disappointed for clear running from the entrance to the straight until the 200 metres.

#### RACE 5: RAMSEY BROS / CASE IH LOCK CUP - 1900 metres

**ZIPALANG** (E. Boyd) – laid in under pressure, in the straight on the final occasion. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

**BETTERTHANYOUTHINK** (D. McWhinney) – raced keenly in the early stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 6: A & K ELECTRICAL & ENGINEETING PTY LTD BENCHMARK 54 HANDICAP – 1800 metres

**TASSIE** (D. Evans) – in the vicinity of the 1300 metres momentarily rolled in and inconvenienced ROMULUS FLIGHT. Rolled about and contacted ROMULUS FLIGHT on several occasions in the straight on the final occasion.

**PATRIOT CODE** (A. Lindsay) – awkward to begin and shortly after the start shifted out and inconvenienced ANOTHER MARTINI.

**ANOTHER MARTINI** (P. Crich) – slow to begin and shortly after the start was inconvenienced when PATRIOT CODE shifted out.

**ARTFUL FRANCYL** (C. Davies) – A post-race veterinary examination revealed no visible abnormalities.

**ROMULUS FLIGHT** (E. Boyd) – approaching the 1300 metres was inconvenienced momentarily when TASSIE rolled in. Rolled about and contacted TASSIE on several occasions in the straight on the final occasion.

# RACE 6: A & K ELECTRICAL & ENGINEETING PTY LTD BENCHMARK 54 HANDICAP – 1800 metres (cont'd)

Correct weight for this event was delayed to allow D. Evans (TASSIE) placed second, and trainer, Mr D. Carrison, to view the Official Vision in the straight.
