### RACE 1: HOLDFAST INSURANCE / SABOIS DISTANCE MAIDEN PLATE - 1950 metres

BARSHONTI (R. Clark) - slow to begin.

#### RACE 2: QUAYCLEAN / SABOIS FILLIES & MARES MAIDEN PLATE - 1000 metres

**MINTRICE** (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

**LEAD FOOT LACEY** (S. Fawke) – over-raced in the early and middle stages. A post-race veterinary examination revealed no visible abnormalities.

MARACAS (T. Pannell) – a post-race veterinary examination revealed no visible abnormalities.

**TUCKERS DAUGHTER** (J. Bowditch) – momentarily held up for clear running in the vicinity of the 200 metres.

## RACE 3: MEDALLION HOMES / SABOIS MAIDEN PLATE - 1550 metres

**MARAVILLOSO** (D. Caboche) – late scratching on veterinary advised at 3.46 pm after being fractious in the barriers. Trainer, Mr R. Balfour, was advised that the mare was now required compete to the Stewards' satisfaction in an Official Barrier Trial prior to a future race.

**RESISTA** (A. Jordsjo) – in the vicinity of the 600 metres improved onto the heels of BURST OF FAITH and had to be restrained. A post-race veterinary examination revealed no visible abnormalities.

**TAMARA MARIE** (J. Potter) – underwent a pre-race veterinary examination and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 4: SCHWEPPES HANDICAP - 2400 metres

**MAJESTIC MOMENT** (J. Kah) – in the vicinity of the 2000 metres was momentarily tightened for room after CENTENARY SHOT rolled in. Held up for clear running from the vicinity of the 500 metres until approaching the 100 metres.

# RACE 4: SCHWEPPES HANDICAP - 2400 metres (cont'd)

**SEEK TO DESTROY** (J. Bowditch) – in the vicinity of the 2000 metres was momentarily tightened for room after CENTENARY SHOT rolled in. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr J. Croucher, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**CENTENARY SHOT** (R. Clark) – in the vicinity of the 2000 metres rolled in taking SEEK TO DESTROY in onto MAJECTIC MOMENT. A post-race veterinary examination revealed no visible abnormalities.

**SILENT ELATION** (C. Lindop) – a post-race veterinary examination revealed the filly had bled from one nostril. Trainer, Mr D. Magro, was advised that SILENT ELATION would now be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

#### **RACE 5: THE JUNCTION MAIDEN PLATE - 1300 metres**

**PARTY TIGER** (T. Pannell) – hampered on jumping away. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Co-trainers, Mr T. Dansie and Ms N. Stoor, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**UNFLYNNCHING** (J. Holder) – over-raced in the middle stages of the event and in the vicinity of the 800 metres improved onto heels.

**JOHN'S LAST SONG** (D. Caboche) – underwent a pre-race veterinary examination and was passed fit to start. Began awkwardly and shifted out taking PARTY TIGER out onto TURF MAN.

**TURF MAN** (J. Bowditch) – hampered on jumping away. Held up for clear running on entering the straight.

**MO FEMME** (E. Finnegan) – raced keenly in the early stages of the event. Momentarily held up for clear running on entering the straight and had to shift inside to improve into clear running.

**BOOM TUNE** (S. Fawke) – began awkwardly and shifted in making contact with TURF MAN.

#### RACE 6: HUGHES LIMOUSINES HANDICAP – 1550 metres

**MULLINGER LANE** (E. Boyd) – jumped away awkwardly and shifted out taking ART MUSIC out onto MOLLY THE SNIP. A post-race veterinary examination revealed no visible abnormalities.

ART MUSIC (J. Holder) - hampered on jumping away.

SIR CHARLESTON (NZ) (V. Wong) - began awkwardly and shifted in making contact with HIPPOGRIFF.

**HIPPOGRIFF** (B. Paterson) – hampered on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**MOLLY THE SNIP** (S. Fawke) – hampered on jumping away.

**QUICK BISCUIT** (A. Jordsjo) – raced wide without cover throughout the event.

#### RACE 7: UBET ADELAIDE CUP - MONDAY 12 MARCH CLASS TWO HANDICAP - 1000 metres

**NEEDY ROCKET** (P. Gatt) – held up for clear running on entering the home straight and in the vicinity of the 200 metres shifted out in an attempt to improve into clear running taking MINT COLLECTOR out onto SILENT ICE. Approaching the 100 metres raced in restricted room to the outside of BALLISTA, which shifted out under pressure. Rider severely reprimanded under AR137(a) for careless riding.

**SILENT ICE** (C. Lindop) – in the vicinity of the 200 metres was hampered after NEEDY ROCKET shifted out taking MINT COLLECTOR out. Laid in under pressure in the straight.

# RACE 7: UBET ADELAIDE CUP - MONDAY 12 MARCH CLASS TWO HANDICAP - 1000 metres (cont'd)

**BALLISTA** (J. Holder) – shifted out under pressure over the concluding stages hampering NEEDY ROCKET. Rider reprimanded under AR137(a) for careless riding.

**YURILLA** (E. Boyd) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**MINT COLLECTOR** (V. Wong) – hampered in the vicinity of the 200 metres.

# RACE 8: JAMES BOAG'S PREMIUM HANDICAP - 1300 metres

**BAKSLAP** (T. Pannell) – in the vicinity of the 1200 metres was hampered after ARCTIC BLAZE shifted in and away from AUTUMN STREET, taking GRACENA in onto DATURA, which was taken in onto RED SCIMITAR, which was taken in onto BAKSLAP. A post-race veterinary examination revealed no visible abnormalities.

**DATURA** (J. Kah) – in the vicinity of the 1200 metres was hampered after ARCTIC BLAZE shifted in and away from AUTUMN STREET, taking GRACENA in onto DATURA. As a result DATURA was taken in onto RED SCIMITAR resulting in BAKSLAP being hampered.

**OAMARU LAD** (E. Finnegan) – late scratching at 6.16 pm after refusing to load into the barriers. Cotrainers, Mr W. Francis & Mr G. Kent, were advised that the gelding was required to load to the Stewards' satisfaction in an Official Barrier Trial prior to a future race.

**RED SCIMITAR** (P. Gatt) – in the vicinity of the 1200 metres was hampered after ARCTIC BLAZE shifted in and away from AUTUMN STREET, taking GRACENA in onto DATURA, which was taken in onto RED SCIMITAR hampering BAKSLAP.

**ARCTIC BLAZE** (C. Lindop) – in the vicinity of the 1200 metres shifted in and away from AUTUMN STREET, taking GRACENA in onto DAUTRA, which was taken in onto RED SCIMITAR resulting in BAKSLAP being hampered.

**GRACENA** (B. Paterson) – in the vicinity of the 1200 metres was hampered after ARCTIC BLAZE shifted in and away from AUTUMN STREET. As a result GRACENA was taken in onto DATURA., which was taken in onto RED SCIMITAR resulting in BAKSLAP being hampered.

STAGHORN (S. Fawke) - knuckled on jumping away. Lost its off fore plate during running.
