RACE 1: CHEETHAM SALT / MICK WHITTLE MEMORIAL / SABOIS MAIDEN PLATE - 1200 metres

LI'L EAG (C. Davies) - reared on jumping away. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: CEDUNA FORESHORE HOTEL MOTEL / BEVAN CAMPBELL BENCHMARK 60 **HANDICAP** - 1200 metres

WITCHES LUCK (P. Crich) – inclined to lay in under pressure in the straight.

ROCKY VALLEY (A. Lindsay) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3: PENONG HOTEL / WEST COAST FUEL BENCHMARK 54 HANDICAP - 1400 metres

FLASH HUSSY (A. Lindsay) - jumped away awkwardly, shifted out contacting TELEPHON QUEEN.

TELEPHON QUEEN (C. Davies) - contacted on jumping away. Rider reported the filly felt awkward in its action and elected not to ride his mount out to the finish from the vicinity of the 200 metres. A postrace veterinary examination revealed the filly to be lame in both forelegs. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 4: FAR WEST FARMERS PENONG CUP - 1600 metres

HARD AT IT – a late scratching at 1.00 pm as there was not suitable rider available.

REVENGEFUL (A. Lindsay) - rider pleaded guilty to a charge under AR137(a) in that she dropped her whip in the vicinity of the 200 metres and was fined \$50.

NEW WAVE (M. Henderson) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

IT'S HUMPHREY (R. Sakai) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

AL ZAFIR (C. Davies) - slow to begin.

AMBER DIAMONDS (P. Crich) - a post-race veterinary examination revealed the mare to be lame in both forelegs. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.
