#### RACE 1: PETER IRVINE MEMORIAL / SABOIS MAIDEN PLATE - 1000 metres

The start of this event was delayed 55 minutes to allow jockeys and officials to arrive on course owing to transport difficulties. Re-scheduled to 1.50 pm

**ETHELAIDES** (A. Badger) – slow to begin. A post-race veterinary examination revealed the filly to be lame in the off foreleg. Trainer, Mr T. Haddy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

Rescheduled 2.35 pm.

Rescheduled to 3.00 pm.

**ALREADY TAKEN** (P. Hamblin) – rider reported the gelding never travelled in today's event and in his opinion would be suited over a longer distance. A post-race veterinary examination revealed no visible abnormalities.

### RACE 4 : FOODLAND STREAKY BAY & ROLL THE DICE BENCHMARK 64 HANDICAP - 1400 metres

Rescheduled to 3.30 pm.

**JESTWIN** (K. Bishop) – a post-race veterinary examination revealed no visible abnormalities.

MR JAZZ MAN (R. Sakai) – laid out under pressure over the concluding stages.

**OLD FARM ROAD** (A. Badger) – underwent a pre-race veterinary examination and passed fit to start.

### RACE 5: XXXX GOLD & STREAKY BAY COMMUNITY HOTEL STREAKY BAY CUP - 1800 metres

Rescheduled to 4.00 pm

**ROOBOY** (P. Hamblin) – in the vicinity of the 1600 metres shifted in taking HARD AT IT in, and momentarily inconveniencing that horse. Rider pleaded guilty to a charge of careless riding under AR137(a) and was reprimanded.

# RACE 5: XXXX GOLD & STREAKY BAY COMMUNITY HOTEL STREAKY BAY CUP - 1800 metres (cont'd)

**HARD AT IT** (C. Small) – in the vicinity of the 1600 metres was taken in and momentarily inconvenienced when ROOBOY shifted in.

**REVENGEFUL** (C. Davies) – hampered on jumping away when LOTION shifted out and EYE THE WORLD shifted in.

LOTION (J. Maund) - shifted out on jumping away contacting REVENGEFUL.

EYE THE WORLD (A. Badger) – shifted in on jumping away contacting REVENGEFUL.

IT'S HUMPHREY (R. Sakai) - hung out rounding the turn in the vicinity of the 1600 metres.

### RACE 6: STREAKY BAY MARINE PRODUCTS / ELDERS RURAL SERVICE/STREAKY BAY MEAT SERVICE BM 54 HANDICAP - 1800 metres

**ANOTHER MARTINI** (J. Maund) – contacted on jumping away.

FLASH HUSSY (C. Small) - shifted out on jumping away contacting ANOTHER MARTINI.

**ROMULUS FLIGHT** (R. Sakai) – raced in restricted room for a number of strides in the vicinity of the 200 metres.

**OUR MISSION** (C. Davies) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr T. Haddy, was advised that the gelding was required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to a future race.
