# RACE 1: KIMBA GATEWAY / DARKE PEAK /COWELL COMMERCIAL HOTELS / SABOIS MAIDEN PLATE - 1210 metres

The start of this event was delayed approximately one minute.

**HUSTA** (C. Davies) – refused to load. A late scratching at 1.pm. Trainer Mr T. Jolly advised the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

**KOODA RHYTHM** (J. Potter) – in the vicinity of the 900 metres was obliged to be restrained and shifted out abruptly when awkwardly placed on the heels of WITCH KID, which rolled in.

**LESONDEA** (A. Lindsay) - slow to begin. Inclined to hang in and raced greenly throughout the event. A postrace veterinary examination revealed minor skin lacerations to the near hind pastern.

**FLOP** (R. Clark) – held up for a short distance inside the 500 metres.

**WITCH KID** (A. Chan) - underwent a pre-race veterinary examination and passed fit to race. In the vicinity of the 900 metres rolled in onto KOODA RHYTHM, which was obliged to be eased and as a consequence when being restrained shifted out abruptly.

## RACE 2: HARDER TRANSPORT CLASS TWO HANDICAP - 1390 metres

GOLDPHON (R. Clark) - jumped away awkwardly. Hung in under pressure in the straight.

**LIVERPOOL STRIKER** (K. Bishop) - hung out throughout the event. A post-race veterinary examination revealed lesions to the near hind cannon.

**BURGUNDEE MISS** (K. Crowther) – at the entrance to the straight rolled in and away from OBLIQUE LINE, which had improved to its outside onto FUGITIVE, which was obliged to be eased.

**FUGITIVE** (J. Potter) – at the entrance to the straight was obliged to be eased when racing tight to the inside of BURGUNDEE MISS, which rolled in and away from OBLIQUE LINE, which had improved to its outside. Rider reported the gelding did not feel comfortable in its action during the event and after receiving interference at the entrance to the straight FUGITIVE failed to respond to his riding and therefore did not ride the gelding out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**DESERT MINTY** (C. Lindop) – inclined to lay in under pressure in the straight.

# RACE 3: LIENERT ENGINEERING "BUD WOOLFORD MEMORIAL" BENCHMARK 60 HANDICAP - 1000 metres

KINGSON (K. Crowther) - near the 400 metres rolled out and bumped NIPPY LIPPY.

HELMARA (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

NIPPY LIPPY (K. Bishop) - near the 400 metres bumped with KINGSON, which rolled out.

NITRO MAGIC (R. Clark) - inclined to lay in for a short distance shortly after entering the straight.

**TORNADO BLUE** (A. Chan) - underwent a pre-race veterinary examination as it had contacted a perimeter fence upon exiting the mounting yard and passed fit to race.

## RACE 4: MARINA HOTEL BENCHMARK 60 HANDICAP - 1210 metres

ALL KRUPT (A. Lindsay) - a post-race veterinary examination revealed no visible abnormalities.

**GOLD BUSKER** (R. Clark) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**ASH ROAD** (J. Potter) – held up for clear running from approaching the 400 metres until shortly after the entrance to the straight and as a result was obliged to shift out to obtain clear running.

## RACE 5: WUDINNA HOTEL MOTEL BENCHMARK 64 HANDICAP - 1390 metres

GALAXY FALLS (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**TASKMASTER** (A. Lindsay) – over-raced in the early and middle stages of the event. Weakened from in the vicinity of the 500 metres. A post-race veterinary examination revealed no visible abnormalities.

**BEARDED DRAGON** (R. Clark) – inside the 100 metres was disappointed for a run between TICKET TO PARIS and I AM DEXTER for a number of strides.

## RACE 6: ELDERS INSURANCE FLYING HANDICAP - 1210 metres

BELLOMO (K. Crowther) - slow to begin.

ARTFUL RAMBLER (A. Chan) – laid in under pressure in the straight.

**THE HEADLINER** (R. Clark) – required to be re-saddled on arrival at the barriers.

**ICELANDIC STAR** (C. Lindop) – held up for clear running from in the vicinity of the 400 metres until shortly after the entrance to the straight.

## RACE 7: DK QUARRIES KIMBA CUP - 1960 metres

**COPPER COAST RAIDA** (J. Potter) - a post-race veterinary examination revealed lacerations to near fore fetlock. First aid administered. Trainer Mr B. Lear advised Stewards that the gelding would now be spelled.

**LAKE JACKSON** (J. Maund) – shortly after passing the winning post on the first occasion bumped with HAND TO HAND, which rolled out. Inside the 100 metres when racing tight to the outside of NEVA DOUBT US rider had his whip struck out of his hand by K. Crowther's whip.

**ROOBOY** (T. Pannell) – inclined to rear on jumping way.

HARD AT IT (C. Lindop) - in the vicinity of the 1300 metres dipped for no apparent reason.

**HAND TO HAND (NZ)** (A. Chan) – reared on jumping away. Shortly after passing the winning post on the first occasion, rolled out and bumped LAKE JACKSON. Raced keenly in the middle stages of the event.

# RACE 8 : SENTURION STEEL BENCHMARK 60 HANDICAP - 1750 metres

**BETTERTHANYOUTHINK** (K. Bishop) - jumped away awkwardly. Near the 400 metres was inclined to hang out, rolled out onto WRIST WATCH and was obliged to be steadied when awkwardly placed on the heels of that gelding, lost its positon and in doing so shifted out onto LADY CONQUISTADOR, which was obliged to be checked, lost its position and became awkward in its action for a number of strides when tightened onto HEZA HUSSLER.

BOUTONNIERE (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

LADY CONQUISTADOR (A. Chan) – held up for clear running from approaching the 600 metres until the entrance to the straight. Near the 400 metres was obliged to be checked, lost its position and became awkward in its action for several strides as BETTERTHANYOUTHINK, which was inclined to hang out, rolled out when awkward on the heels of WRIST WATCH.
