Report on Race Meeting held at Gawler Racecourse

RACE 1: BAROSSA VOLKSWAGEN / SABOIS PLUS MAIDEN / CLASS ONE PLATE
- 2122 metres

IMMUTABLE (J. Bowditch) – rider reported the gelding travelled well in the early stages however, was under pressure inside the 1000 metres. A post-race veterinary examination revealed no visible abnormalities.

EXALTED CRAFTSMAN (J. Kah) - slow to begin.

MANCHURIAN (D. Caboche) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed a higher than expected heart rate. Trainer was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

SILENT ELATION (S. Fawke) – inclined to lay in under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

BURST OF FAITH (A. Chan) – lost its near hind plate during the event.

RACE 2: THETERRACEFUNCTIONCENTRE.COM.AU / SABOIS MAIDEN PLATE- 1215 metres

FORGOT MY SOCK (K. Crowther) – laid in under pressure in the straight. In the vicinity of the 300 metres had to be steadied when it shifted in at the same time as AMBISHOP shifted out. Continued to lay in and in the vicinity of the 200 metres shifted in and had to be steadied off the heels of AMBISHOP. A post-race veterinary examination revealed no visible abnormalities.

GUEST LIST (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

MARINA (S. Fawke) – shifted in on jumping away onto HINCHIN MISS.

AMBISHOP (K. Bishop) – shifted out in the vicinity of the 300 metres onto FORGOT MY SOCKS.

RACE 2: THETERRACEFUNCTIONCENTRE.COM.AU / SABOIS MAIDEN PLATE– 1215 metres
(Cont'd)

HINCHIN MISS (E. Finnegan) – hampered on jumping away when tightened onto FORGOT MY SOCKS by MARINA, which shifted in. A post-race veterinary examination revealed a laceration to the near foreleg. First aid administered.

STAR FLIGHT (A. Chan) - jumped away awkwardly and shifted in abruptly shortly after the start.

RACE 3: GAWLER ANZAC DAY RACES 25 APRIL / SABOIS MAIDEN PLATE - 1515 metres

The start of this event was delayed approximately one minute.

INDIAN MO (E. Finnegan) – difficult to load. Jumped away awkwardly. Laid in under pressure in the straight.

LOSTARC (J. Toeroek) – rider reported the gelding was inclined to lay out under pressure rounding the home turn.

OUT OF KILTER (J. Bowditch) – slow into stride.

TRYSTOFF (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

OUR GOLDEN PATRIOT (K. Bishop) – raced keenly in the early and middle stages of the event.

RACE 4: HOLDFAST INSURANCE BENCHMARK 56 HANDICAP - 1515 metres

GRAND ARMADA (C. Collins) - jumped away awkwardly. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. Stewards took into account that the rider had never been spoken to in relation to this rule.

HE'S GOT SKILLS (H. Grace) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

BELZELADY (A. Jordsjo) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$300. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

EWAN MINE (T. Voorham) - jumped away awkwardly. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$200.

SWEET MISCHIEF (T. Stone) – inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: COOPERS SESSION ALE / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP
- 1515 metres

CHOSEN ANGEL (J. Holder) - jumped away awkwardly.

GRACENA (K. Crowther) – inclined to lay in, in the straight.

EXALTED JENNI (J. Kah) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: GBJC LIFE MEMBERS CUP BENCHMARK 60 HANDICAP - 1722 metres

RED RAIDER (C. Lindop) – taken in on jumping away onto CHAPAL. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: GBJC LIFE MEMBERS CUP BENCHMARK 60 HANDICAP - 1722 metres (Cont'd)

CHAPAL (J. Holder) – inconvenienced on jumping away when contacted by RED RAIDER. Laid in under pressure in the straight.

MY THREE SONS (E. Finnegan) – Trainer Mr P. Stokes advised he would instruct his rider to attempt to position more forward than at the gelding's most recent start. Shifted in on jumping away onto RED RAIDER.

RACE 7: UBET BENCHMARK 60 HANDICAP - 1215 metres

ANYPORTINASTORM (E. Boyd) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RED DAZZLE (H. Grace) - jumped away awkwardly.

ILGATTINO (T. Voorham) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$300.

WILLOCHRA (T. Stone) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

TUCKERS DAUGHTER (A. Chan) - a post-race veterinary examination revealed no visible abnormalities.

SILICONNI (E. Finnegan) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

SHEANNA (H. English) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: GOLDIN FARMS CLASS TWO HANDICAP - 1115 metres

WANTED BY ALL (S. Fawke) – taken in approaching the 800 metres onto EQUIDAME.

LADY ALCATRAZ (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

WITH HOPE (C. Lindop) – shifted in on jumping away and bumped BIT SPENSIVE. Raced keenly in the early and middle stages of the event.

BALLISTA (J. Holder) – shifted in and away from SWEET VARDEN approaching the 800 metres onto WANTED BY ALL.

EXALTED HONEY (J. Kah) – difficulty in obtaining clear ground in the straight.

EQUIDAME (A. Chan) - jumped away awkwardly. Inconvenienced approaching the 800 metres when tightened by WANTED BY ALL.
