Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 7 April 2018

RACE 1: ADELAIDE GALVANISING THREE-YEAR-OLD MAIDEN PLATE - 1200 metres

ALWAYS THE KING (Z. Spain) – laid in, in the straight.

COPPERGATE (J. Kah) – raced keenly in the early stages of the event. Rider explained her instructions were to be positive early and after obtaining a forward positon in running, the colt travelled fairly, however from near the 500 metres failed to stretch out, became short in its action, was disappointing and failed to finish the event off. A post-race veterinary examination revealed post-race stress colic with a poor cardio and respiratory recovery rate and signs of abdominal discomfort. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

FERINGO (D. Caboche) – slow into stride.

HAHNDORF (J.Toeroek) – rider reported the gelding laid in during the event. A post-race veterinary examination revealed no visible abnormalities.

MEADOWS LASSIE (D. Yendall) - underwent a pre-race veterinary examination as the filly had not raced since March 2017 and was passed fit to race.

SUPRE (J. Bowditch) – laid out from inside the 600 metres and raced greenly in the straight. Rider reported that rounding the home turn the filly was inclined to lay out. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: DARLEY HANDICAP - 1100 metres

GYTRASH (A Jordsjo) – laid in, in the straight.

SECRET VEGA (J. Bowditch) – rolled in approaching the 800 metres and inconvenienced IN HEART'S WAKE.

KEMALPASA (J. Toeroek) – awkward to begin. Raced keenly in the early stages of the event and was inclined to lay in, in the straight.

IN HEART'S WAKE (J. Kah) – approaching the 800 metres was inconvenienced by SECRET VEGA as that horse rolled in.

RACE 2: DARLEY HANDICAP - 1100 metres (Cont'd)

QUEEN'S SONG (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

VIVI VALENTINA (P. Gatt) – shortly after the start became awkward on the heels of IN HEART'S WAKE for several strides and had to be restrained. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: ADELAIDE FESTIVAL OF RACING 5 -19 MAY HANDICAP - 1050 metres

DESPATCH (Z. Spain) – rider explained his instructions were to be positive early and after obtaining a forward position, was trapped wide without cover and from near the 600 metres the gelding was inclined to lay out and thereafter was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

FANCY RUMBLE (K. Crowther) – laid in, in the early stages of the event. Rider reported her saddle shifted to the off side from inside the 600 metres placing her at a slight disadvantage.

M'LADY (D. Caboche) – awkward to begin, shifted out and contacted MISS LABELLE.

MISS LABELLE (J. Holder) – contacted at the start. Rider reported the filly was short in its action over the concluding stages and was disappointing. A post-race veterinary examination revealed the filly was lame in the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. First aid administered.

KINGSON (C. Lindop) – shifted in shortly after the start and tightened SPARROWS onto SPLIT LIP. Held up for a short distance near the entrance to the straight.

SWEET SNITTY (J. Bowditch) – held up for a number of strides prior to the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

SPARROWS (R. Sakai) – raced in restricted room for a short distance shortly after the start between KINGSON, which shifted in and SPLIT LIP, which maintained its line. Hung out in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: DARLEY HANDICAP - 1200 metres

KESAN (P. Gatt) – tightened at the start.

SHALL WE HOPE (J. Toeroek) – rider reported the gelding was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

GOUGERS (J. Bowditch) – inside the 100 metres raced in restricted room and became awkward on the heels of SILENT ICE, when taken out slightly by PERETTI as that horse shifted out and away from SHARK MIRAGE to its inside.

SHARK MIRAGE (A. Chan) – reared at the start and was very awkward to begin and approaching the 800 metres became awkward for a short distance on the heels of KESAN and thereafter inside the 100 metres shifted out slightly onto PERETTI.

NEEDY ROCKET (K. Crowther) - underwent a pre-race veterinary examination on arrival at the gates as the gelding contacted the mounting yard gate on leaving the mounting yard and was passed fit to race.

PERETTI (J. Holder) – inside the 100 metres sifted out and away from SHARK MIRAGE as that horse shifted out slightly and as a consequence took GOUGERS wider. A post-race veterinary examination revealed no visible abnormalities.

WHITWAY (S. Fawke) – laid in shortly after the start and shifted in onto KESAN, which was tightened onto GONDOLIERA, which shifted out slightly. Thereafter laid in severely for a short distance and raced ungenerously. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: DARLEY HANDICAP - 1200 metres (Cont'd)

GONDOLIERA (J. Kah) - shifted out at the start, contacted KESAN and had its hindquarters turned.

JACKTHEGIANTSLAYER (J. Maund) – inclined to lay in, in the straight. Rider explained in his opinion the tempo in this event was too slow and did not suit his mount in running and shortly after entering the straight he elected not to take a run to the inside of GOUGERS as he had anticipated that, that horse might roll in. As a consequence he altered course to the outside of that horse to improve its position but stated that his horse did not stretch out over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: FLEURIEU MILK COMPANY HANDICAP - 1200 metres

HAVE ANOTHER GLASS (J. Huxtable) – rider explained his instructions were to attempt to obtain cover behind the leaders, however owing to his wide barrier and the formation of the field in the early stages, he was unable to do so. He added thereafter he was trapped wide without cover and as a consequence approaching the 800 metres, had elected to push forward to avoid being trapped wide throughout the event and settled outside the leader. A post-race veterinary examination revealed no visible abnormalities.

BEAUTIFUL FLYER (E. Boyd) – held up for clear ground from the 500 metres until the entrance to the straight.

MISS CUOCO (J. Bowditch) – held up from near the entrance to the straight until near the 300 metres.

ALASKAN JADE (J. Innes (Jnr)) – laid in, in the straight. Rider spoken to regarding the use of his whip with his arm raised above shoulder height on two occasions over the concluding stages. Lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

CALLISTO GIRL (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

RACE 6: 13CABS HANDICAP - 1600 metres

SUPER HAZE (IRE) (Z. Spain) – Mr C. McEvoy acting for Trainer Mr T. Mc Evoy advised Stewards prior to the event that he would instruct his rider to attempt to settle further back with cover. A post-race veterinary examination revealed no visible abnormalities.

SAVANERO (NZ) (A. Jordsjo) – brushed near the 300 metres.

FLOW METER (S. Fawke) – lost its near fore plate during the event.

DAKTARI (L. Meech) – fractious on arrival behind the barriers.

ENKI (J. Kah) – held up for a short distance near the 400 metres. Laid out from near the 300 metres and brushed SAVANERO (NZ). A post-race veterinary examination revealed no visible abnormalities.

VON COSTA GLASS (J. Huxtable) – rider explained his instructions were to settle back but to improve his position near the 1000 metres. He stated he was obliged to travel wide without cover for some distance when improving his position near the 1000 metres. Thereafter approaching the 400 metres the gelding failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed the gelding was lame in the near hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

TARANTINO (NZ) (A. Chan) – awkward to begin and shifted in abruptly at the start.

RACE 7: MANIHI CLASSIC - 1100 metres

LOPE DE CAPIO (K. Crowther) – rider reported the gelding felt short in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

LORD ASPEN (J. Huxtable) – raced keenly for a short distance near the 600 metres. Rider accidentally dropped his whip near the 100 metres and was fined \$50 under AR137(a) for carelessness.

RACE 7: MANIHI CLASSIC - 1100 metres (Cont'd)

WHISPERING BROOK (D. Yendall) – the start was momentarily delayed to allow the barrier staff to assist after the mare got its tongue over the bit. Rider reported on return to scale that the mare again got its tongue over the bit in running. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: LAELIA STAKES - 1600 metres

The start of this event was delayed approximately two minutes.

BELLE DU NORD (NZ) (Z. Spain) – at the entrance to the straight was hampered by AMBERTONE, which shifted out and away from SHOKORA, which rolled out. A post-race veterinary examination revealed no visible abnormalities.

SHOKORA (A. Mallyon) – shifted out near the 400 metres onto BEHAVE tightening that horse resulting in BEHAVE having to be restrained to avoid the heels of SHOKARA. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 8 April and to conclude at midnight on Wednesday, 18 April 2018: a period of four meetings.

PANDEMONIUM (J. Innes (Jnr)) – proved fractious in its barrier stall and had to be removed. Underwent a pre-race veterinary examination and was passed fit to race. Rider examined by the First Care Medical Personnel and was cleared of injury. Proved difficult again when being re-loaded. Lost its near fore plate during the event. Trainer Ms G. Waterhouse was advised in view of the horse's behaviour a warning had been placed on the filly regarding its barrier manners.

MO FEMME (E. Finnegan) – unable to obtain clear running from near the entrance to the straight until inside the 200 metres.

SNOGGING (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

HARDLY SURPRISING (L. Meech) - a post-race veterinary examination revealed no visible abnormalities.

BLACK AND TAN (J. Huxtable) - slow to begin.

EARTH ANGEL (J. Bowditch) – unable to obtain clear ground from the entrance to the straight until near the 200 metres.

AMBERTONE (J. Potter) – shifted out and away from SHOKARA at the entrance to the straight.

BEHAVE (J. Holder) – had to be checked approaching the 400 metres off the heels of SHOKARA, which shifted out.

SOPRESSA (D. Yendall) – held up from near the entrance to the straight and was unable to obtain clear running until approaching the 100 metres and had to be restrained on several occasions when awkwardly placed on the heels of runners.

RACE 9: UBET HANDICAP - 1800 metres

KAZOOM (NZ) (S. Cahill) - slow to begin.

TAHNEE TIARA (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

SO BELAFONTE (D. Caboche) – approaching the 400 metres shifted in onto THINK OUT LOUD taking that horse onto ITCHYZARIZ, resulting in THINK OUT LOUD and ITCHYZARIZ being hampered and ITCHYZARIZ losing its positon. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period of three meetings. Dates to be advised.

RACE 9: UBET HANDICAP - 1800 metres (Cont'd)

ASHADY HUSSY (J. Toeroek) – laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

THINK OUT LOUD (S. Fawke) - awkward to begin, shifted in sharply shortly after the start to take up a position closer to the rail. Hampered near the 400 metres when taken in onto ITCHYZARIZ by SO BELAFONTE.

ITCHYZARIZ (J. Potter) – near the 400 metres was tightened by THINK OUT LOUD, which was taken in by SO BELAFONTE, was hampered and lost its position.
