RACE 1: FINNS FINE FOODS / SABOIS MAIDEN PLATE - 1700 metres

TURF MAN (S. Fawke) - slow to begin.

LITTLE BRITT (R. Clark) - slow to begin.

RACE 2: PENOLA LIFE MEMBERS / SABOIS MAIDEN PLATE - 1300 metres

JUST WANTO RUN NOW (R. Clark) – rider reported the mare made abnormal breathing noises throughout the event. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SUNSET STAR (S. Fawke) – rider reported the mare did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

QUAZAAM (J. Maund) – slow into stride. Rider reported the filly did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: COOPERS BREWERY BENCHMARK 64 HANDICAP - 2100 metres

CENTENARY SHOT (D. Bates) – a late scratching by order of Stewards at 12.21 pm due to the earlier track downgrade.

RACE 4: UBET / SABOIS MAIDEN PLATE - 1100 metres

ANOTHER KERRIE (T. Germaine) - slow to begin.

CORNELIA (S. Fawke) – approaching the winning post shifted out marginally brushing TIZA.

STREWTH (K. Crowther) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

TIZA (K. Bishop) – approaching the winning post shifted in marginally brushing CORNELIA.

Correct weight was delayed to allow S. Fawke (CORNELIA) placed fourth and Trainer Mr J. Hickmott to view the vision in the straight. After doing so S. Fawke lodged an objection against K. Bishop (TIZA) placed third, alleging interference over the last 150 metres. After considering the evidence, viewing the official vision and acting on their own observations Stewards *dismissed* the objection.

RACE 5: THE MIDFIELD GROUP BENCHMARK 56 HANDICAP - 1300 metres

DADDY'S LITTLELADY (J. Potter) – approaching the 100 metres was inconvenienced when THE OTHER GUY rolled in marginally.

NAUGHTY RABBIT (J. Lorensini) – bumped on jumping away when TRICK 'N' TREAT jumped away awkwardly and shifted out. Approaching the winning post shifted in abruptly inconveniencing WILKIN, which was taken in.

THE OTHER GUY (K. Crowther) - jumped away awkwardly and shifted in bumping WILKIN. Approaching the 100 metres shifted in marginally inconveniencing DADDY'S LITTLELADY, which was taken in.

TRICK 'N' TREAT (J. Huxtable) - jumped away awkwardly and shifted out bumping NAUGHTY RABBIT.

WILKIN (K. Bishop) – bumped on jumping away when THE OTHER GUY jumped away awkwardly and shifted in. Approaching the winning post was inconvenienced when taken in by NAUGHTY RABBIT, which shifted in abruptly.
