RACE 1: COOPERS BREWERY / SABOIS DISTANCE MAIDEN PLATE - 1700 metres

JAMBOREE (A. Chan) – in the vicinity of the 1100 metres was awkwardly placed on the heels of BEAU BUMBLE and was obliged to be restrained and from thereafter raced keenly.

TURNPIKE (E. Finnegan) – jumped away awkwardly, shifted in and contacted AZ LUCKY (NZ).

AZ LUCKY (NZ) (L. German) – contacted on jumping away as TURNPIKE jumped away awkwardly and shifted in. Raced wide without cover throughout the event. Weakened from in the vicinity of the 500 metres. Rider explained that in his opinion the mare did not handle the track conditions. A post-race veterinary examination revealed a small laceration to the near foreleg.

INDUBITABLE (D. Tourneur) – Trainer, Mr M. Williams, was reprimanded under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified by records held by the Stewards. In assessing penalty Stewards took into account Mr M. Williams's excellent record under this Rule. Slow to begin.

RACE 2: BALNAVES OF COONAWARRA / SABOIS MAIDEN PLATE - 1100 metres

DAY ON THE DRINK (D. Bates) – shortly after the start bucked for a number of strides. Trainer, Mr D. Bowman, was advised that the gelding was now required to complete an Official Barrier Trial or Approval to Race Jump-out in a race-day saddle prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

LITTLE SWEETHEART (K. Lau) – dipped for no apparent reason in the vicinity of the 400 metres.

ROOKLEY ROSE (R. Clark) – raced greenly in the straight.

RACE 3: KATNOOK ESTATE / SABOIS MAIDEN PLATE - 1400 metres

SEAS THE HOST (L. German) – jumped away awkwardly, shifted in and contacted DE BRUCE STAR, which was taken in and bumped TIZA. Held up for clear running from the 400 metres until the entrance to the straight when racing to the inside of the heels of CRYSTAL CHOICE, which was weakening.

DE BRUCE STAR (J. Potter) – contacted at the start by SEAS THE HOST and taken in bumping TIZA. A post-race veterinary examination revealed no visible abnormalities.

GIGGLON (C. Collins) - slow to being.

LONG JOURNEY (E. Finnegan) – a post-race veterinary examination revealed no visible abnormalities.

RACE 3: KATNOOK ESTATE / SABOIS MAIDEN PLATE - 1400 metres (cont'd)

ABRUZZO DESIRE (C. Puls) – inside the 1100 metres was obliged to be eased when racing keenly and tight between SEAS THE HOST and COTILLION, which rolled in marginally.

CRYSTAL CHOICE (K. Bishop) – weakened from in the vicinity of the 500 metres. Rider reported that the mare did not feel comfortable in its action. A post-race veterinary examination revealed an injury to the near fore tendon. Trainer, Mrs T. Pretlove, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

TIZA (G. Lo) – bumped at the start with DE BRUCE STAR, which was taken in by SEAS THE HOST. Hung in under pressure in the straight.

COTILLION (K. Lau) – inside the 1100 metres rolled in marginally onto ABRUZZO DESIRE.

RACE 4: UBET CLASS TWO HANDICAP - 1400 metres

DIRTOMIC (D. Bates) – in the vicinity of the 400 metres raced tight and was obliged to be restrained when racing between SHARK MAGIC, which was taken in by SAN GREGORIO, which hung in, and UNRELATED, which had clipped heels and shifted out.

HASTA LA BOUNTY (S. Cahill) – a post-race veterinary examination revealed no visible abnormalities.

MISTA KNOWITALL (D. Tourneur) – in the vicinity of the 200 metres bumped with CHU CHU CHARLIE.

UNRELATED (J. Potter) – in the vicinity of the 400 metres when attempting a tight run between LUVULONGTIME, which rolled out slightly, and NAUGHTY RABBIT, which shifted in marginally, became awkward on and clipped the heels of LUVULONGTIME, unbalancing J. Potter for a number of strides and UNRELATED becoming awkward in its action and losing several lengths. A post-race veterinary examination revealed no visible abnormalities.

LUVULONGTIME (S. Fawke) – in the vicinity of the 400 metres rolled out marginally onto UNRELATED, which clipped the heels of the gelding when racing tight to its outside as NAUGHTY RABBIT shifted in. Rider reminded of his obligations and advised to take greater care when his mounts shift ground in future.

NAUGHTY RABBIT (J. Lorensini) – in the vicinity of the 400 metres shifted in marginally onto UNRELATED, which was obliged to be steadied and clipped the heels of LUVULONGTIME, which rolled out marginally. Rider severely reprimanded and advised to take greater care in future.

SAN GREGORIO (C. Puls) – hung in from in the vicinity of the 600 metres and in the vicinity of the 400 metres shifted in onto SHARK MAGIC, which was taken in onto DIRTOMIC, which became tight onto UNRELATED, which clipped heels and shifted out.

SHARK MAGIC (J. Maund) – in the vicinity of the 400 metres was tightened onto DIRTOMIC by SAN GREGORIO, which was hanging in.

CHU CHU CHARLIE (E. Finnegan) – slow to begin. In the vicinity of the 200 metres bumped with MISTA KNOWITALL.

VEGAS BOUND (K. Lau) – slow to begin.

NORLANE (NZ) (L. German) - L. German was granted permission to ride the gelding claiming only one kilogram of his three kilogram allowance.

RACE 5: BARRY MANEY FORD BENCHMARK 72 HANDICAP - 1300 metres

SANDHILL WARRIOR (K. Lau) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ANY GIVEN GLASS (J. Lorensini) – bumped at the start with BUNGALALLY BELLE, which jumped away awkwardly and shifted out.

RACE 5: BARRY MANEY FORD BENCHMARK 72 HANDICAP - 1300 metres (cont'd)

BUNGALALLY BELLE (A. Chan) – jumped away awkwardly, shifted out and bumped ANY GIVEN GLASS.

RACE 6: PINKERTON, PALM, HAMLYN & STEEN BENCHMARK 60 HANDICAP - 1700 metres

GURU JIM (NZ) (D. Bates) – shortly after the entrance to the straight shifted out abruptly of its own accord. A post-race veterinary examination revealed no visible abnormalities.

OUR HENRIETTA (J. Maund) – a post-race veterinary examination revealed no visible abnormalities.

CARSON (NZ) (J. Lorensini) – slow to begin.

WILKIN (K. Bishop) - slow to begin.

NAHANNI (A. Chan) – jumped away awkwardly.

RACE 7: S.A. THOROUGHBRED BREEDERS BENCHMARK 56 HANDICAP - 1100 metres

ROCKSTAR RANGA (L. German) – laid out throughout the event. Approaching the 400 metres bumped with OLATUNJI.

DADDY'S LITTLELADY (J. Potter) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

OLATUNJI (J. Maund) – approaching the 400 metres bumped with ROCKSTAR RANGA. A post-race veterinary examination revealed no visible abnormalities.

LINDSAY ALFRED (S. Fawke) – jumped away awkwardly.
