**Report on Race Meeting held at Gawler Racecourse**

**RAIL:** Out 7 metres 1750 metres to 1500 metres, out 4 metres remainder.

**RACE 1: BAROSSA VOLKSWAGEN / SABOIS DISTANCE MAIDEN PLATE – 2132 metres**

**AMAKINSKY** (D. Morgan) – on entering the straight was held up for clear running on the back of HEZ A WOLF and made contact with the running rail when attempting a run to the inside of HEZ A WOLF when there was insufficient room. Laid in when placed under pressure in the straight.

**PURADEANIE** (T. Pannell) – on Thursday, 28 June 2018, Trainer, Mr R. Balfour, reported to Stewards that PURADEANIE was exhibiting signs of a bruise to the off fore hoof and in his opinion this may have affected the performance of PURADEANIE.

**SHOW 'EM SHARKIE** (J. Holder) – slow to begin. Momentarily held up for clear running on entering the straight.

**BOXCAR BETTY** (R. Clark) – slow to begin. When questioned regarding the performance of BOXCAR BETTY rider reported that she placed her mount under pressure from the vicinity of the 800 metres. She added that her mount failed to respond to her riding and she elected not to place her mount under pressure over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**MISS VERNE** (R. Hurdle) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 2: GAWLER SOUTH BAKERY / SABOIS MAIDEN PLATE – 1522 metres**

**MAPLE'S IMAGE** (K. Lau) – laid out when placed under pressure in the straight.

**NEED PRAGMATISM** (J. Holder) – underwent a pre-race veterinary examination as it had not raced in twelve months and was passed fit to start. Over-raced in the early and middle stages of the event and in the vicinity of the 900 metres became awkwardly placed on the heels of CALL ME MAYBE.

## **RACE 2: GAWLER SOUTH BAKERY / SABOIS MAIDEN PLATE – 1522 metres (cont'd)**

**TEXAS MILLER** (D. Tourneur) – in the vicinity of the 900 metres rolled out inconveniencing CALL ME MAYBE. Rider reprimanded under AR137(a) for careless riding.

**HUNGRY FOR LOVE** (J. Potter) – slow to begin. In the vicinity of the 900 metres was momentarily inconvenienced by CALL ME MAYBE, which shifted in whilst racing greenly.

**CALL ME MAYBE** (K. Bishop) – over-raced in the early stages of the event and in the vicinity of the 900 metres was inconvenienced by TEXAS MILLER, which shifted out. As a result, raced fiercely for a number of strides, shifted in, hampering HUNGRY FOR LOVE, which was taken in onto DUNKIRK, which had to be restrained. A post-race veterinary examination revealed no visible abnormalities.

**DUNKIRK** (P. Gatt) – slow to begin. In the vicinity of the 900 metres had to be restrained to avoid the heels of HUNGRY FOR LOVE, which was taken in by CALL ME MAYBE.

## **RACE 3: TWILIGHT RACING - GAWLER CUP FRI OCT 26 MAIDEN PLATE - 1222 metres**

**BALWARRA SPIRIT** (M. Henderson) – a post-race veterinary examination revealed no visible abnormalities.

**CAFFE ROMANO** (R. Hurdle) – laid in when placed under pressure in the straight.

**MANILOW** (P. Gatt) – over-raced in the early stages of the event.

**THAT'S TWO SLABS** (J. Maund) – underwent a pre-race veterinary examination after being kicked by another runner behind the barriers and was passed fit to start.

**LANNISTER GOLD** (D. Morgan) – raced wide without cover throughout the event.

**SALLY BREEZE** (D. Caboche) – a post-race veterinary examination revealed no visible abnormalities.

**BOHEMIAN FOREST** (S. Fawke) – difficult to load. Trainer, Mr D. Magro, was advised that a warning had been placed on the filly. Laid out rounding the home turn and in the straight.

**KNAVESMIRE** (J. Bowditch) – in the vicinity of the 300 metres shifted out after being held up for clear running hampering POETIC DIVA. Rider reprimanded under AR137(a) for careless riding.

**POETIC DIVA** (D. Tourneur) – in the vicinity of the 300 metres after KNAVESMIRE shifted out when insufficiently clear.

## **RACE 4: WOLF BLASS WINES CLASS TWO HANDICAP - 1222 metres**

**RACING RORY** (J. Bowditch) – a post-race veterinary examination revealed no visible abnormalities.

**VUMA HILLS** (S. Fawke) – late scratching at 1.55 pm on veterinary advice after becoming fractious behind the barrier stalls. Trainer, Miss R. Anderson, was advised that a warning had been placed on the mare.

**SELDOM HOME** (E. Boyd) – a post-race veterinary examination revealed no visible abnormalities.

## **RACE 5: GOLDIN FARMS - AKEED MOFEED / SABOIS 3YO BENCHMARK 64 HANDICAP – 1222 metres**

The start of this event was delayed approximately seven minutes owing to the late rider change of ARDIZZONE. T. Pannell was kicked in the mounting yard prior to the running of this event. T. Pannell was examined by the First Care Medical personnel and ruled unfit to fulfil his riding obligation in this race.

**ARDIZZONE** (K. Bishop) – over-raced in the early stages of the event.

**RACE 5: GOLDIN FARMS - AKEED MOFEED / SABOIS 3YO BENCHMARK 64 HANDICAP – 1222 metres (cont'd)**

**DUCHESS GRACE** (J. Bowditch) – rider reported that his mount slipped on jumping away. Over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**HAHNDORF** (P. Gatt) – slow to begin. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**HINCHIN MISS** (G. Lo) – over-raced in the early stages of the event.

T. Pannell was examined by the First Care Medical personnel following this event and passed fit to fulfil his remaining engagements.

**RACE 6: COOPERS SESSION ALE BENCHMARK 60 HANDICAP - 1122 metres**

**BEL STREAK** (S. Cahill) – laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**BOLDACIOUS GIRL** (R. Clark) – had difficulty obtaining clear running on entering the straight.

**SOCIAL MEDIA** (A. Jordsjo) – reared on jumping away making contact with the roof of the barrier stall. A post-race veterinary examination revealed no visible abnormalities. A. Jordsjo was examined by the First Care Medical personnel and passed fit to fulfil her remaining engagements.

**RACE 7: WOLF BLASS RASCALS CUP BENCHMARK 64 HANDICAP - 2132 metres**

**DANOULI** (J. Bowditch) – over-raced in the early and middle stages of the event. Laid in under pressure in the straight.

**DIAMOND DUKE** (S. Cahill) – lost its near hind plate in running.

**HE'S A VALLEYBOY** (D. Caboche) – in the vicinity of the 2000 metres had to be restrained, after over-racing, to avoid the heels of THE BIG CHEESE, which shifted in when insufficiently clear. In the vicinity of the 600 metres had to be restrained to avoid the heels of THE BIG CHEESE, which shifted out when insufficiently clear.

**SASUN** (K. Bishop) – began awkwardly, shifted in and contacted KEEPAKIWI (NZ).

**THE MOSHIRE** (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

**BLAZING CHEERS** (A. Chan) – began awkwardly shifting out and contacting KEEPAKIWI (NZ).

**SHOGUN'S REIGN** (P. Gatt) – over-raced in the early and middle stages of the event.

**THE BIG CHEESE** (D. Tourneur) – in the vicinity of the 2000 metres, shifted in when insufficiently clear of HE'S A VALLEYBOY. Rider severely reprimanded. In the vicinity of the 600 metres shifted out when insufficiently clear of HE'S A VALLEYBOY. Rider reminded of his obligation to be clear when shifting ground. Laid in under pressure in the straight.

**TOMMY GUN** (E. Boyd) – over-raced in the early stages of the event.

**KEEPAKIWI (NZ)** (J. Potter) – hampered on jumping away. Lost its off fore plate in running.

**RACE 8: THETERRACEFUNCTIONCENTRE.COM.AU BENCHMARK 60 HANDICAP - 1522 metres**

**EMMOOKI'S DASH** (K. Lau) – over-raced in the early stages of the event.

**BIG CALL** (S. Fawke) – in the vicinity of the 300 metres was hampered when ANYPORTINASTORM rolled out.

**RACE 8: THETERRACEFUNCTIONCENTRE.COM.AU BENCHMARK 60 HANDICAP - 1522 metres**  
(cont'd)

**ROTHMOORE** (D. Tourneur) – when questioned regarding the tactics adopted on the gelding rider stated that he was under no instructions but elected to restrain his mount to find cover from his wide barrier, rather than be trapped wide in the early stages. When entering the straight ROTHMOORE laid out and he allowed his mount to shift out to the outside of the track as he deemed that to be better going. He further reported that whilst racing in restricted room to the outside he was unable to use his whip on a number of strides as it was making contact with the outside running rail.

**ANYPORTINASTORM** (P. Gatt) – over-raced in the early stages of the event. In the vicinity of the 300 metres rolled in hampering BIG CALL.

**SPIEGEL GROVE** (R. Hurdle) – in the vicinity of the 1400 metres was momentarily inconvenienced when improving onto the heels of DOLLAR DOLLAR BILL.
