STIPENDIARY STEWARDS' REPORT
Report on Race Meeting held at the Naracoorte Racecourse
by the Naracoorte Racing Club on Sunday, 1 July 2018

TRACK: Soft 7 (Downgraded to Heavy 8 @12.46 pm retrospective to Race 1)

WEATHER: Fine

RAIL: Out 2 metres from 800 metres to 550 metres, true remainder.

RACE 1: MGA INSURANCE BROKERS / SABOIS PLUS MAIDEN/CLASS ONE PLATE – 1800 meters

DIRTOMIC (J. Potter) – over-raced in the early stages of the event and in the vicinity of the 1400 metres elected to shift wider on the track. When questioned regarding the performance of the gelding, rider reported his mount travelled well throughout the race but in the vicinity of the 400 metres, when placed under pressure, his mount began to weaken and finished the race off in a disappointing manner. A post-race veterinary examination revealed no visible abnormalities.

JAWS OF LIFE (S. Fawke) – began awkwardly.

WILKIN (K. Bishop) – laid in under pressure in the straight.

SPUDFEST (M. Lawrence) – over-raced in the early and middle stages of the event. Rider reported her mount raced greenly throughout the event. In the vicinity of the 100 metres became awkward in its stride placing her at a disadvantage for a number of strides. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: STEVE LETTON MOTORCYCLES / SABOIS MAIDEN PLATE – 1430 meters

JELLARTO (D. Tourneur) – in the vicinity of the 800 metres was momentarily inconvenienced after **BODIDLEY** shifted in when insufficiently clear.

BODIDLEY (J. Maund) – in the vicinity of the 800 metres rolled in when insufficiently clear of **JELLARTO**. Rider reminded of his obligations to be clear when shifting ground. In the vicinity of the 500 metres had to be restrained when improving onto the heels of **SINNAMON LANE**.

DE BRUCE STAR (J. Potter) – Trainer advised the gelding would be required to perform competitively to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

LADY NYORA (K. Bishop) – in the vicinity of the 1000 metres was momentarily inconvenienced after **SINNAMON LANE** shifted in.

DISCO REBEL (J. Lorensini) - slow to begin.

SINNAMON LANE (A. Chan) – in the vicinity of the 1000 metres, whilst over-racing, shifted in inconveniencing **LADY NYORA**. Over-raced throughout the event and on entering the home straight laid in when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: SEARS ELECTRICAL BENCHMARK 60 HANDICAP - 2000 metres

CHU CHU CHARLIE (J. Lorensini) – hampered on jumping away.

ITCHYZARIZ (K. Bishop) – began awkwardly shifted in making contact with CHU CHU CHARLIE.

MICKIEM (D. Tourneur) – hampered on jumping away.

SANDHILL HALO (A. Chan) – began awkwardly, shifted out making contact with MICKIEM. Laid in, in the early stages of the event.

RACE 4: SINCLAIR ELECTRICAL SOLUTIONS / SABOIS MAIDEN PLATE - 1100 metres

IOWNABOY (S. Fawke) - began awkwardly and was slow as a result. Rider reported his mount was under pressure throughout the event and in his opinion may not have handled the heavy going. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

SANDHILL CHEVY (D. Tourneur) - slow to begin.

KAPHARK (J. Maund) - underwent a pre-race veterinary examination as it had not raced for 12 months and passed fit to race.

SWIZZLE STICKS (M. Lawrence) – Trainer advised he would instruct his rider to not use the whip in today's event as in his opinion the mare resents the use of the whip. Rider dislodged en route to the barriers. M. Lawrence was examined by the First Care Medical Personnel and passed fit to fulfil her engagements. Raced keenly in the early stages and in the vicinity of the 1000 metres raced with its head in the air.

SERENA ON COURT – Stewards declared SERENA ON COURT a late scratching at 2.28 pm on veterinary advice after proving fractious in the barrier. Trainer Mr P. Jones was advised a warning had been placed on the filly.

SONAISALI (K. Bishop) – hung in throughout the event.

RACE 5:CAPPA MOTOR BODIES BENCHMARK 60 HANDICAP - 1000 metres

MUSICAL QUERY (S. Cahill) – when questioned regarding the performance of the mare, rider stated he was instructed to ride the mare positive and was able to take up a forward position without making much use of his mount in the early stages. He added when entering the home straight he elected to allow his mount to shift out to the centre of the track as he deemed that part of the track to be better going. He further stated in the vicinity of the 100 metres his mount dwelt and as a result became awkward for a stride and began to lay out under pressure. A post-race veterinary examination revealed no visible abnormalities.

AKERBOY (A. Jordsjo) – in the vicinity of the 800 metres had to be restrained after improving onto heels.

RACE 6: NEVILLE MARTIN MEMORIAL BENCHMARK 64 HANDICAP - 1200 metres

AMERICAN STAR (S. Cahill) – laid in under pressure in the straight.

CRYSTAL GLASS (J. Lorensini) – shifted out on jumping away hampering SOLAAZEM.

NIGHT QUEEN (A. Chan) – shifted out on jumping away taking CRYSTAL GLASS out onto SOLAAZEM.

DEXELATION (R. Hurdle) – shifted out approaching the winning post.

SOLAAZEM (S. Fawke) – had to be checked on jumping away to avoid the heels of CRYSTAL GLASS, which was taken out by NIGHT QUEEN.

RACE 7: WATTLE RANGE FUNERALS BENCHMARK 56 HANDICAP - 1430 metres

ALLEGIANT (J. Potter) – rider reported his mount became to weaken from the vicinity of the 800 metres, felt awkward in its action and as a result elected not to place his mount under pressure over the concluding stages. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

FIRST STAR (IRE) (K. Bishop) - slow to begin.

MAGIC PEGASUS (M. Lawrence) – reared as the start was affected and as a result was slow into stride.
