**Report on Race Meeting held at Morphettville Parks Racecourse**

**RACE 1: DENISE DELLIT 50TH BIRTHDAY HANDICAP - 2400 metres**

**MONGOLIAN WOLF** (J. Allen) – taken wider near the 600 metres. Rider explained that the gelding raced flat in today's event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr D. Weir, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**SURVIVED (NZ)** (D. Bates) – raced keenly in the early stages of the event. Broke down near the 600 metres and was eased out of the event by its rider who dismounted shortly thereafter. A post-race veterinary examination revealed the gelding to have fractured its near hind cannon and was humanely euthanased. A post-mortem blood sample was taken from SURVIVED (NZ). Rider explained that his mount travelled well until the incident. Following the running of this event Stewards inspected the track in the vicinity of the 600 metres and found no areas of concern.

**DANCE OF HEROES (GB)** (K. Crowther) – inclined to lay in, in the straight.

**CINNAMON CARTER** (A. Chan) – near the 600 metres was inconvenienced when racing behind SURVIVED (NZ), which broke down, and as a consequence had to shift out to avoid that horse's heels and hampered MONGOLIAN WOLF, which was taken wider.

**CASINO CLUB** (J. Kah) – awkward to begin and lost its off fore plate during the event.

**MORE THAN FABULOUS** (J. Bowditch) – lost its off fore plate during the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$250.

**PIPPOS** – acting on confirmed advice from trainer Mr B. Brook that PIPPOS was lame in the off hind leg Stewards withdrew the gelding at 8.37 am.

## **RACE 2: HAPPY 80TH KEVIN ALSOP HANDICAP – 1400 metres**

**EXALTED ADAM** (J. Kah) – shifted in inside the 200 metres and inconvenienced SAVE ME NED. Rider reminded of her obligations when shifting ground.

**BOGGOMS** (D. Tourneur) – inconvenienced for several strides near the 1200 metres when racing to the inside of EMBECEEE LIL, which had to be restrained when taken in by DISGRACEFUL. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**PAINTE** (J. Lorensini) – held up for clear running from near the 500 metres until inside the 200 metres.

**SAVATAG (NZ)** (T. Pannell) – rider reported that the gelding was not suited to today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

**SOHOOL** (J. Holder) – shifted out at the start contacting SAVE ME NED, which was inconvenienced. Raced wide without cover in the middle stages of the event.

**EMBECEE LIL** (R. Sakai) – near the 1200 metres was hampered by KUNGSLEDEN, which shifted in, and was taken in onto BOGGOMS, which was inconvenienced. Thereafter had difficulty obtaining clear ground from the entrance to the straight until inside the 100 metres, and inside the 200 metres became awkwardly placed inside the heels of SAVE ME NED, which was taken in by EXALTED ADAM, which shifted in.

**SAVE ME NED** (R. Clark) – contacted and inconvenienced at the start. Inside the 200 metres was inconvenienced when taken in by EXALTED ADAM, which shifted in. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. Rider reported that the mare laid out from in the vicinity of the 400 metres to the winning post.

**KUNGSLEDEN** (K. Crowther) – rider reported that on pulling up she became concerned with the gelding's action. A post-race veterinary examination revealed the gelding to be lame in the near foreleg and had strained its near fore tendon. First aid administered. Trainer, Ms K. Mckerlie, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**DISGRACEFUL** (E. Finnegan) – prior to the running of this event trainer, Mr W. Clarcken, advised Stewards that he would instruct his rider to attempt to settle more forward than at the gelding's previous start, and possibly share the lead. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. Shifted in near the 1200 metres onto EMBECEEE LIL, which was hampered and taken in onto BOGGOMS, which was inconvenienced. Rider was reprimanded and advised to take greater care when shifting ground in future. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr W. Clarcken, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

## **RACE 3: MYPUNTER.COM OAKLANDS PLATE – 1400 metres**

**UNFAIR DISMISSAL** (J. Allen) – awkward to begin.

**POISED TO STRIKE** (D. Tourneur) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**CROCKETT** (J. Kah) – shifted in at the start onto TONGSAI BOSS, which was taken in onto FIRST DIAMOND. In the vicinity of the 1000 metres clipped the heels of TONGSAI BOSS and knuckled when that gelding restrained off the heels of GRABBING GLORY and shifted out. Laid out in the straight.

**THE MAILMAN** (M. Payne) – trainer, Ms M. Payne, advised Stewards prior to the event that she would attempt ride THE MAILMAN further back with cover than it had raced in its most recent start. Awkward to begin.

**EXALTED TRAIL** (T. Pannell) – inside the 1000 metres was awkward on the heels of FIRST DIAMOND and raced in restricted room as FIRST DIAMOND crossed to the rail.

### **RACE 3: MYPUNTER.COM OAKLANDS PLATE – 1400 metres (cont'd)**

**TONGSAI BOSS** (R. Clark) – in the vicinity of the 1000 metres became awkwardly placed on the heels of GRABBING GLORY and shifted out, hampering CROCKETT.

**FIRST DIAMOND** (J. Holder) – contacted at the start and had its hindquarters turned. Shifted in approaching the 1000 metres and when crossing UNFAIR DISMISSAL inconvenienced that horse momentarily, and thereafter crossed EXALTED TRAIL, which was inconvenienced resulting in GRABBING GLORY, which was following becoming awkwardly placed on the heels of EXALTED TRAIL for a short distance and getting its head up and racing ungenerously. Rider reprimanded and advised to take greater care when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

**GRABBING GLORY** (E. Boyd) – slow to begin. Inside the 1000 metres became awkwardly placed on the heels of EXALTED TRAIL for some distance and raced ungenerously and shifted out taking TONGSAI BOSS out onto CROCKETT.

### **RACE 4: TERRY HOWE PRINTING HANDICAP - 1250 metres**

**SHEHROZ** (D. Bates) – jumped away awkwardly. Raced extremely fiercely in the early and middle stages of the event and was inclined to shift about. A post-race veterinary examination revealed no visible abnormalities.

**AMBERDI** (R. Clark) – shifted in on jumping away onto BOOMER BEACH.

**SCRAP DRAGON** (J. Kah) – shifted out on jumping away onto BOOMER BEACH. Lost its off fore plate during the event.

**BOOMER BEACH** (T. Pannell) – hampered on jumping away when tightened between AMBERDI and SCRAP DRAGON. Over-race in the early and middle stages of the event.

**OH MO** (J. Bowditch) – held up from the vicinity of the 400 metres until near 300 metres. Laid out under pressure in the straight.

**GALCRUM** (K. Crowther) – jumped away awkwardly.

### **RACE 5: AAMI HANDICAP - 1000 metres**

**ALL ABOUT NICCI** (J. Allen) – tightened at the start. Near the 200 metres rolled in onto WITH HOPE, which was inconvenienced for several strides.

**MYSTICANO** (K. Crowther) – had difficulty obtaining clear ground for a short distance shortly after the entrance to the straight.

**ACCELERATO** (J. Noonan) – tightened at the start. Laid out in the straight. Was accidentally struck over the head by the whip of A. Jordsjo approaching the 100 metres.

**FICA GAL** (R. Clark) – shifted in at the start onto ALL ABOUT NICCI, which was tightened.

**AKKACAN** (J. Holder) – laid in, in the straight.

**FLEETING FEELING** (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

**WITH HOPE** (A. Jordsjo) – shifted out at the start onto ACCELERATO, which was tightened. Near the 200 metres was inconvenienced for several strides by ALL ABOUT NICCI as that horse rolled in. Approaching the 100 metres, when shifting out to improve, A. Jordsjo accidentally struck ACCELERATO over the head with her whip.

### **RACE 6: UBET HANDICAP - 1550 metres**

**LAURE ME IN** (J. Kah) – inconvenienced at the start. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 6: UBET HANDICAP - 1550 metres (cont'd)**

**BAD WOLF** (J. Bowditch) – raced wide without cover in the middle stages of the event.

**CASA DE LAGO** (J. Noonan) – slow to begin losing one to two lengths. Laid in, in the straight.

**THRONES** (J. Huxtable) – approaching the 400 metres laid in and became held up on the heels of ARDIZZONE for several strides as that horse shifted out tightening THRONES onto CAPTAIN HARRY, which improved its position to the outside of THRONES. Thereafter, continued to lay in for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

**ARDIZZONE** (J. Holder) – shifted out approaching the 400 metres and inconvenienced THRONES. Rider reported that at the entrance to the straight the gelding commenced to weaken and was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

**CANFORD** (T. Pannell) – shifted out at the start onto LAURE ME IN, which was inconvenienced.

### **RACE 7: 13CABS HANDICAP - 1250 metres**

**HASTA LA GORBY** (E. Finnegan) – inconvenienced shortly after the start. A post-race veterinary examination revealed no visible abnormalities.

**SHE'S BENEFICIAL** (J. Allen) – momentarily inconvenienced at the start. Near the 1100 metres rolled out and contacted ROWDY RICHARD, which was taken out onto BURIED TREASURE, which was inconvenienced.

**JUST KAPPY** (A. Chan) – lost its off fore plate during the event.

**TRUENO** (J. Kah) – had difficulty obtaining clear running from near the entrance to the straight until near the 200 metres.

**AUTUMN STREET** (J. Huxtable) – shifted in at the start onto SHE'S BENEFICIAL.

**BOLT I AM** (K. Crowther) – slow to begin. Laid in, in the early part of the straight.

**BURIED TREASURE** (P. Gatt) – inconvenienced near the 1100 metres.

**ASHERO** (A. Jordsjo) – shifted out shortly after the start inconveniencing HASTA LA GORBY. Inside the 100 metres was obliged to alter course to the outside of SHE'S BENEFICIAL as that horse rolled in, continued to shift out tightening ROWDY RICHARD just prior to the winning post and shortly thereafter tightened ROWDY RICHARD onto BOLT I AM, resulting in ROWDY RICHARD having to be checked. Rider severely reprimanded and advised to take greater care in future.

**ROWDY RICHARD** (R. Hurdle) – taken out near the 1100 metres when contacted by SHE'S BENEFICIAL, which rolled out. Tightened by ASHERO, which shifted out just prior to the winning post, and shortly after the winning post was obliged to be checked when in restricted room between ASHERO and BOLT I AM.

Correct weight for this event was delayed to allow R. Hurdle (ROWDY RICHARD) placed fourth, and trainer, Mr K. Sweeney, to view the official vision in the straight.

### **RACE 8: ZOE AREZINA HANDICAP - 1400 metres**

**VIEIRA** (A. Chan) – awkward to begin. Raced keenly in the early stages of the event. Rider explained that the gelding over-raced in the early and middle stages of the event; however, was off the bridle in the middle stages, but thereafter over the final 200 metres finished the race off more positively. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**LAST WITNESS** (R. Sakai) – a post-race veterinary examination revealed no visible abnormalities.

**RACE 8: ZOE AREZINA HANDICAP - 1400 metres (cont'd)**

**TROGIR** (K. Crowther) – near the 1100 metres raced keenly for a short distance and became awkwardly placed on the heels of GOOD THERAPY and shifted out to avoid the heels of that runner. Laid in over the concluding stages of the event.

**ITS TIME FOR MAGIC (NZ)** (J. Huxtable) – unable to obtain clear running shortly after the entrance to the straight when racing inside the heels of VIEIRA, which rolled about, and was unable to improve its position until inside the 200 metres, where it was obliged to shift to the outside of VIEIRA's heels to obtain clear running.

**REDEEM BOUNTY** (E. Finnegan) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

**BARBIE'S BOY** (D. Tourneur) – had a little blood in its mouth in the mounting yard. Underwent a pre-race veterinary examination in the mounting yard and passed fit to proceed to the barriers. Underwent a subsequent veterinary examination on arrival at the barriers and was passed fit to start. Laid in, in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. A post-race veterinary examination revealed no visible abnormalities.
