**RACE 1: GOLDIN FARMS - AKEED MOFEED BENCHMARK 64 HANDICAP – 1722 metres**

**FREE THE WIND** (A. Chan) – raced keenly in the early and middle stages of the event.

**RACE 2: COOPERS SESSION ALE / SABOIS PLUS BENCHMARK 64 HANDICAP – 2125 metres**

**DIAMOND DUKE** (T. Pannell) – a post-race veterinary examination revealed significant lameness to the near hind leg. First aid administered. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**PURADEANIE** (J. Kah) – raced wide without cover throughout the event.

**ANURADHA** (P. Gatt) – trainer advised the Stewards prior to this event that he would instruct the rider to attempt to settle further forward in today's event if possible. Laid out from rounding the home turn to the finish of the event.

**EXALTED BLOOM** (K. Crowther) – laid out under pressure in the straight.

**ALDOLPHIN** (S. Fawke) – was examined by the Club's Veterinary Surgeon on arrival on course who reported it to have lacerated its tongue and would be unfit to race. Acting on this advice Stewards withdrew ALDOLPHIN at 12.32 pm.

**CEALLACH** (A. Jordsjo) – hung out rounding the home turn.

Correct weight was delayed to allow R. Hurdle (EVIL PRINCESS), placed second, and that mare's trainer, Mr M. Vassallo, to view the official vision in the straight.

### **RACE 3: BAROSSA VOLKSWAGEN / SABOIS MAIDEN PLATE - 1518 metres**

**NUCLEAR BANG** (D. Caboche) – at the entrance to the straight shifted out and bumped THAT'S TWO SLABS.

**THAT'S TWO SLABS** (J. Maund) – inconvenienced in the vicinity of the 1300 metres when contacted by POETIC DIVA. Inconvenienced when contacted at the entrance to the straight. Rider explained that in his opinion the gelding may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

**AMBISHOP** (E. Finnegan) – rider accidentally dropped her whip in the vicinity of the 150 metres and was reprimanded under AR137(a) for carelessness.

**BRAKEFOOT BLING** (J. Potter) – slow to begin. Hampered in the vicinity of the 500 metres. Rider could offer no explanation for the mare's poor performance however added in his opinion it may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

**GLAMAROO** (A. Chan) – in the vicinity of the 500 metres shifted out and away from THAT'S TWO SLABS onto BRAKEFOOT BLING. Rider accidentally dropped his whip in the vicinity of the 250 metres and was fined \$50 for carelessness under AR137(a).

**POETIC DIVA** (J. Kah) – in the vicinity of the 1300 metres was inconvenienced when taken in onto THAT'S TWO SLABS.

**SCINTILLO WINE** (E. Boyd) – inclined to lay in throughout the event.

**FIRST TIME FELON** (R. Hurdle) – laid in throughout the event and in the vicinity of the 1300 metres shifted in onto POETIC DIVA.

Following the running of this event J. Huxtable was examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagements.

### **RACE 4: KINGSFORD HOTEL / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 metres**

**AMBIBELLA** (A. Chan) – hampered in the vicinity of the 900 metres, over-reacted, got its head up and lost its position when SERIOUS SPENDER shifted in. In the vicinity of the 400 metres contacted by SERIOUS SPENDER unbalancing A. Chan, who was dislodged. A. Chan was transported to hospital for further observations. A post-race veterinary examination revealed no visible abnormalities.

**IT'S A MYTH** (K. Crowther) – slow to begin.

**LA MAGIQUE** (J. Kah) – reared on jumping away and slow into stride.

**LANNISTER GOLD** (P. Gatt) – inconvenienced on jumping away. Shifted out in the vicinity of the 400 metres when insufficiently clear of SERIOUS SPENDER resulting in that filly clipping the heels of LANNISTER GOLD and dislodging its rider. As a consequence SERIOUS SPENDER shifted in making heavy contact with AMBIBELLA, unbalancing A. Chan, who was dislodged. Rider found guilty of a charge of careless riding under AR137(a) and was suspended from riding in races for a period from midnight Saturday, 1 September 2018 to conclude midnight Wednesday, 26 September 2018, a period of eleven meetings. A post-race veterinary examination revealed lacerations to the right hock consistent with being galloped on. First aid administered.

**SERIOUS SPENDER** (R. Clark) – shifted in, in the vicinity of the 900 metres onto AMBIBELLA. Rider reminded of her obligations when shifting ground. In the vicinity of the 400 metres clipped the heels of LANNISTER GOLD and knuckled dislodging R. Clark. R. Clark was examined by the First Care Medical personnel and ruled unfit to fulfil her remaining rides. A post-race veterinary examination revealed no visible abnormalities.

**YANKEE EYES** (T. Pannell) – fractious in its barrier prior to the start being effected and as a result jumped away awkwardly and shifted in onto LANNISTER GOLD. In the vicinity of the 900 metres improved onto the heels of LA MAGIQUE and had to be steadied when the pace slackened.

Due to the fall in this event all races were put back one race with Race 8 rescheduled to be run at 5.19pm.

### **RACE 5: HOLDFAST INSURANCE / SABOIS MAIDEN PLATE - 1100 metres**

**DASKULYA** (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

**ROCK HARBOUR** (K. Crowther) – slow into stride.

**BLIND CHANCE** (P. Gatt) – laid in under pressure in the straight.

**FAITH IN GRACE** (J. Potter) – jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**FIRST KISS** (G. Lo) – held up for a short distance at the entrance to the straight and obliged to alter course to obtain clear ground.

**UNINHIBITED (NZ)** (D. Tourneur) – laid in under pressure over the concluding 100 metres.

**TOFFEE BELL** (K. Bishop) – rolled out in the vicinity of the 150 metres and had to be steadied when it became awkwardly placed on the heels of UNINHIBITED (NZ).

### **RACE 6: BBQ VOLUNTEERS APPRECIATION BENCHMARK 60 HANDICAP - 1518 metres**

**QUIERO** (E. Finnegan) – raced keenly in the early and middle stages of the event.

**THRONES** (A. Jordsjo) – laid in rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

**SIR CHARLESTON (NZ)** (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

**HOLY TRILOGEY** (K. Crowther) – raced keenly in the early and middle stages of the event.

**AMBER ALERT** (J. Potter) – rider was reminded of his obligations in relation to using his whip with an action that raises his arm above shoulder height in accordance with AR137A(4)(b).

**KINGSGROVE** (D. Tourneur) – raced keenly in the early and middle stages of the event.

### **RACE 7: GAWLER SOUTH BAKERY BENCHMARK 56 HANDICAP - 1100 metres**

**EXALTED GOLD** (K. Crowther) – forced to take hold in the vicinity of the 900 metres when GOLDEN LUSTRE shifted in. Hampered in the vicinity of the 800 metres when ZAAZOE was taken in. A post-race veterinary examination revealed no visible abnormalities.

**GOLDEN LUSTRE** (G. Lo) - jumped away awkwardly. In the vicinity of the 900 metres shifted in when insufficiently clear of EXALTED GOLD resulting in that rider having to take hold to avoid the heels of GOLDEN LUSTRE. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 2 September and to conclude at midnight on Sunday, 9 September 2018: a period of three meetings.

**COOL MAVERICK** (J. Kah) – approaching the 800 metres laid in onto ZAAZOE.

**GALCRUM** (J. Maund) - jumped away awkwardly.

**SOCIAL MEDIA** (D. Tourneur) – in the vicinity of the 200 metres raced in restricted room for a short distance between EXALTED GOLD, which had been taken out by PRICKLES and the outside running rail.

**PURRFECT KISSES** (P. Gatt) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**ZAAZOE** (S. Fawke) – raced keenly in the early stages of the event and in the vicinity of the 800 metres shifted in and away from COOL MAVERICK onto EXALTED GOLD. Hung out rounding the home turn.

**RACE 8: SANDERS FODDER / MITAVITE BENCHMARK 60 HANDICAP - 1200 metres**

**FUTAGO** (K. Bishop) – shifted in on jumping away onto MYSTICANO. Hampered and forced to race in restricted room for a short distance approaching the 800 metres when SPRINGFIELD LEW laid in.

**MYSTICANO** (T. Pannell) – contacted on jumping away.

**LOVE CLUB** (K. Crowther) – laid out under pressure in the straight.

**IRON MAX** (D. Caboche) - jumped away awkwardly. Shortly after the start was hampered when it shifted out and away from SWIPE ME RIGHT across the heels of SPRINGFIELD LEW.

**CONNERMARA ROSE** (D. Morgan) – slow to begin. Reluctant to stretch out in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**SPRINGFIELD LEW** (J. Potter) – laid in rounding the turn in the vicinity of the 800 metres.

**UNSCOPEABLE** (J. Kah) – laid in under pressure in the straight.
