**RACE 1 : LAKE BREEZE WINES / SABOIS DISTANCE MAIDEN PLATE - 2050 metres**

**DOUBLE BURNER** (K. Bishop) – bumped on jumping away as DEVAGA ROUGE jumped away awkwardly and shifted in.

**SPACE HERO** (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

**AHECKSTAR** (D. Caboche) – a post-race veterinary examination revealed the mare to be lame in the off foreleg. First aid administered. Trainer, Mr T. Jolly, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**BAGNAIA** (J. Maund) – examined by the Club's Veterinary Surgeon on arrival at the barriers and found to be lame in the near foreleg. Acting on this advice Stewards withdrew BAGNAIA at 12.42 pm. Trainer, Mr J. Hyam, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**DEVEGA ROUGE** (A. Jordsjo) – jumped away awkwardly, shifted in and bumped DOUBLE BURNER. Raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**SILENT SWAY** (J. Potter) – approaching the 100 metres rider lost the use of his off side iron for several strides placing him at a disadvantage.

**RACE 2: STOCKMANS CHALLENGE / SABOIS MAIDEN PLATE – 1350 metres**

**KARMIDALA** (R. Sakai) – a post-race veterinary examination revealed no visible abnormalities.

## **RACE 2: STOCKMANS CHALLENGE / SABOIS MAIDEN PLATE – 1350 metres (Cont'd)**

**MADNESS INVALENCIA** (J. Potter) – shortly after the start became tight between REX GOLIATH, which rolled in, and CHUMPUNYA, which rolled out.

**MYPO TIME** (R. Hurdle) – bumped on jumping away as PINT'S PUNCH jumped away awkwardly and shifted out.

**PINT'S PUNCH** (K. Bishop) – jumped away awkwardly, shifted out and bumped MYPO TIME. In the vicinity of the 1200 metres was taken in by SLIPPERY JOURNEY.

**REX GOLIATH** (R. Clark) – shortly after the start rolled in and contacted MADNESS INVALENCIA. A post-race veterinary examination revealed no visible abnormalities.

**SLIPPERY JOURNEY** (A. Chan) – over-raced in the early and middle stages of the event. In the vicinity of the 1200 metres became awkwardly placed on the heels of BERNARDINI BAY and KARMIDALA, was obliged to be checked and lost ground taking PINT'S PUNCH in. In the vicinity of the 200 metres shifted in onto CLIFF TOP, which was obliged to be steadied and lost its position when weakening. Rider severely reprimanded and advised to take greater care in future. In viewing the incident Stewards were mindful of the positioning of KARMIDALA when A. Chan made an attempt to relieve the pressure to his inside.

**CHUMPUNYA** (J. Holder) – shortly after the start rolled out onto MADNESS INVALENCIA.

**CLIFF TOP** (J. Toeroek) – in the vicinity of the 200 metres was obliged to be steadied and lost its position as SLIPPERY JOURNEY shifted in. A post-race veterinary examination revealed no visible abnormalities.

**SO WE ARE** (D. Caboche) – laid in from the entrance to the straight until the finish.

## **RACE 3: G & J EAST STRATHALBYN / SABOIS MAIDEN PLATE - 1200 metres**

**BLAZING ROW** (D. Tourneur) – on jumping away was taken in by WARY GLANCE, which jumped away awkwardly and shifted in. In the vicinity of the 1100 metres shifted in onto TREBLA, which was taken in and obliged to be eased.

**DASKULYA** (A. Chan) – in the vicinity of the 100 metres shifted in under riding when insufficiently clear of BUNDLE O' DIAMONDS, which was obliged to be steadied and lost its position. Rider pleaded guilty to charge of careless riding under AR137(a) in that he shifted in when insufficiently clear and was suspended from riding in races for a period to commence midnight Saturday, 8 September to conclude midnight Saturday, 15 September 2018, a period of three meetings.

**GOURMELIN** (S. Fawke) – slow into stride. Raced keenly in the early and middle stages of the event. Approaching the 800 metres shifted out onto SIR COEN, which was taken wider. In the vicinity of the 700 metres became awkward in its action and shifted out abruptly onto SIR COEN when MAXSAMIA improved onto its heels. A post-race veterinary examination revealed no visible abnormalities.

**MAXSAMIA** (D. Morgan) – reared on jumping away and as a result was slow to begin. In the vicinity of the 700 metres became awkwardly placed on the heels of TREBLA and GOURMELIN and was obliged to be restrained.

**SIR COEN** (E. Boyd) – jumped away awkwardly. In the vicinity of the 800 metres was taken wider by GOURMELIN. In the vicinity of the 700 metres was taken wider again by GOURMELIN, which shifted out abruptly. A post-race veterinary examination revealed no visible abnormalities.

**THANASI** (J. Toeroek) – jumped away awkwardly and shifted in.

**WARY GLANCE** (R. Hurdle) – jumped away awkwardly and shifted in onto BLAZING ROW, which was taken in. In the vicinity of the 900 metres lost its position when tightened onto BLAZING ROW as ROYAL RING, which was racing greenly, was inclined to lay in and shifted in.

### **RACE 3: G & J EAST STRATHALBYN / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)**

**BUNDLE O' DIAMONDS** (J. Holder) – jumped away awkwardly and shifted out onto MAAZLE, which was taken out. In the vicinity of the 200 metres was obliged to be steadied and lost its position when DASKULYA shifted in when insufficiently clear.

**PANZER PRINCESS** (K. Lau) – taken out onto TREBLA on jumping away by MAAZLE, which was taken out by BUNDLE O' DIAMONDS, which jumped away awkwardly and shifted out.

**TREBLA** (K. Crowther) – lost its position on jumping away when tightened onto PANZER PRINCESS, which was taken out by BLAZING ROW, which was taken in. In the vicinity of the 1100 metres was taken in by BLAZING ROW, which shifted in, and was obliged to be eased.

**ROYAL RING** (R. Clark) – in the vicinity of the 900 metres, when racing greenly, rolled in onto WARY GLANCE, which was tightened onto BLAZING ROW and as a result lost its position.

**MAAZLE** (J. Maund) – taken out onto PANZER PRINCESS on jumping away as BUNDLE O' DIAMONDS jumped away awkwardly and shifted out. In the vicinity of the 1100 metres shifted in and away from TREBLA, which was taken in, became inconvenienced and awkward in its action, contacted the running rail for a number of strides and as a result lost ground.

### **RACE 4: STRATHALBYN SMALL ENGINES CLASS TWO HANDICAP – 1600 metres**

**GIGGLON** (S. Fawke) – jumped away awkwardly. Shifted out abruptly in the vicinity of the 100 metres and was inclined to lay out from thereafter.

**JUST A GIGOLO** (J. Holder) – got its leg up on the barrier stalls prior to the start being effected. Inclined to rear on jumping away. Trainer, Miss J. Giles, was advised that a warning had been placed on the gelding due to it being fractious in the barriers.

**FANDANGO** (J. Potter) – raced keenly in the early and middle stages of the event.

**RED QUIRINA** (C. Lions) – raced keenly in the early stages of the event.

Correct weight for this event was delayed to allow J. Holder (JUST A GIGOLO) to view the vision of the start. J. Holder made a submission to the Stewards that as the start was effected JUST A GIGOLO, which had its leg up, was denied a fair start. After considered the evidence, viewing the vision and acting on their own observations Stewards ruled that JUST A GIGOLO be declared a runner and that the incident was of its own doing.

### **RACE 5: TERMINUS HOTEL CLASS TWO HANDICAP - 1100 metres**

**ANCIENT HISTORY (IRE)** (E. Finnegan) – rider reported the gelding did not feel comfortable in its action over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**ZARACE** (A. Lindsay) – inside the 900 metres was obliged to be restrained when the pace was eased.

**CONTAINMENT** (R. Clark) – inclined to lay in under pressure in the straight.

**GOUGERS** (J. Holder) – in the vicinity of the 900 metres was obliged to be eased as TASTE OF DIAMONDS shifted in.

**TASTE OF DIAMONDS** (D. Tourneur) – in the vicinity of the 900 metres shifted in onto GOUGERS, which was obliged to be eased. Rider reprimanded and advised to take greater care in future. Shortly thereafter D. Tourneur eased the pace and as a result ZARACE was obliged to be restrained. Rider reminded of his obligations under AR137(d).

**AMBERTONE** (J. Potter) – a post-race veterinary examination revealed no visible abnormalities.

**RACE 6: RAINE AND HORNE STRATHALBYN BENCHMARK 60 HANDICAP – 2050 metres**

**FANTASTIC MAGIC** (D. Caboche) – jumped away awkwardly and shifted out onto KEEPAKIWI (NZ). Raced keenly in the early and middle stages of the event.

**DOUBLESPEAK** (J. Toeroek) – rider reported the mare raced greenly throughout the event. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**PEARL RAIDER** (E. Boyd) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**KEEPAKIWI (NZ)** (A. Lindsay) – shortly after the start was taken out by FANTASTIC MAGIC.

**JARRVIS** (A. Chan) – hampered shortly after the start as KEEPAKIWI (NZ) was taken out.

**RACE 7: HIGH STREET TRADING CO BENCHMARK 56 HANDICAP - 1200 metres**

**BLONDE MISSILE** (K. Lau) – jumped away awkwardly, shifted out and bumped WISE AND HAPPY.

**WISE AND HAPPY** (J. Huxtable) – bumped at the start by BLONDE MISSILE, which jumped away awkwardly and shifted out. A post-race veterinary examination revealed the gelding to have atrial fibrillation. Trainer, Miss J. Giles, was advised that the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

**LICORICE BULLET** (K. Crowther) – slow into stride.

**ARTISTIC ESCAPE** (E. Boyd) – held up for a short distance in the vicinity of the 500 metres.

**CAPITOLINE** (C. Lions) – jumped away awkwardly and shifted out.

**RACE 8: ROSE AND PETER MOODY'S 50TH WEDDING ANNIVERSARY BENCHMARK 60 HANDICAP - 1350 metres**

The start of this event was delayed approximately four minutes owing to a TRSA staff member being kicked prior to the runners exiting the mounting yard and having to be attended to by the First Care Medical Personnel.

**AUTUMN STREET** (K. Lau) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**ARCHWAY TO HEAVEN** (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**ATARARTZI** (J. Potter) – inside the 100 metres was obliged to be eased as SPIRITED MATCH shifted out.

**SPIRITED MATCH** (A. Lindsay) – inside the 100 metres shifted out onto ATARARTZI, which was obliged to be eased. Rider severely reprimanded and advised to take greater care in future.
