RACE 1: BUSHMANS ARMS HOTEL / SABOIS MAIDEN PLATE - 1800 meters

BODIDLEY (J. Maund) – over-raced in the early and middle stages of the event. In the vicinity of the 1400 metres had to be restrained after improving onto the heels of POETIC DIVA.

AZ LUCKY (NZ) (R. Hurdle) – was hampered shortly after jumping, after POETIC DIVA shifted out.

LADY NYORA (A. Jordsjo) – when questioned regarding the tactics adopted on the mare, rider stated that she was under no specific instructions but in her opinion, her assessment of the pace in the race was slow and after being positive out of the gates was able to take up a position outside the leader. She added her mount travelled comfortably throughout the run and finished off in a positive manner.

POETIC DIVA (K. Crowther) – began awkwardly, shifted out and contacted AZ LUCKY (NZ). Laid out throughout the event. Rider reported her mount over-raced throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: CRANE LIVESTOCK CARRIRES / SABOIS MAIDEN PLATE – 1430 meters

BRINGME THE BUTLER (K. Bishop) - underwent a pre-race veterinary examination after not racing for the past 12 months and passed fit to race. Over-raced in the early and middle stages of the event. In the vicinity of the 1200 metres had to be restrained after improving onto the heels of SPEED ESPRIT. A post-race veterinary examination revealed no visible abnormalities.

BRONSKI (S. Fawke) – laid out for a short distance entering the home straight. Laid in under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

EURO GOLD (K. Crowther) – when questioned regarding the performance of the gelding, rider reported in her opinion her mount was one paced, failed to respond to her riding in the straight and was disappointing in its finishing efforts. A post-race veterinary examination revealed no visible abnormalities.

SERENA ON COURT (D. Tourneur) - slow to begin.

RACE 3: HAYNES ENGINEERING BENCHMARK 60 HANDICAP - 1000 metres

OGUNDE (R. Sakai) – laid out under pressure in the straight.

RACE 3: HAYNES ENGINEERING BENCHMARK 60 HANDICAP - 1000 metres (Cont'd)

VISUAL IMAGE (D. Tourneur) - slow to begin.

AKERBOY (E. Finnegan) – over-raced in the early stages of the event. Held up for clear running on entering the straight. In the vicinity of the 200 metres became momentarily inconvenienced on the heels of PHAR LINK, after being disappointed for a run and had to shift out in an attempt to improve into clear running.

SEDUCE ME NOW (S. Fawke) - slow to begin. In the vicinity of the 400 metres became awkward in its action for no apparent reason. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: COOPERS SESSION ALE / SABOIS MAIDEN PLATE - 1000 metres

BEAR PASS (D. Tourneur) – difficult to load. Trainer advised a warning had been placed on the horse regarding its loading manners.

SAMPHIRE (K. Crowther) – in the vicinity of the 400 metres had to be steadied to avoid the heels of WOKIT, which shifted in when insufficiently clear.

WOKIT (R. Sakai) – began awkwardly, shifted out taking CASINO MAGIC out onto JUST WANTO RUN NOW. Laid in throughout the event. In the vicinity of the 400 metres shifted in when insufficiently clear of SAMPHIRE. Rider was found guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 16 September and to conclude at midnight on Sunday, 23 September 2018: a period of 3 meetings.

CASINO MAGIC (E. Finnegan) – was hampered when jumping away. In the vicinity of the 800 metres was momentarily inconvenienced after MELBOURNE HERO shifted in when insufficiently clear.

JUST WANTO RUN NOW (S. Fawke) – slow into stride. Shortly after jumping away was severely hampered by CASINO MAGIC, which was taken out by WOKIT.

OCTOBER JEWEL (D. Caboche) - laid out under pressure in the straight.

TOFFEE BELL (K. Bishop) - slow to begin.

MELBOURNE HERO (A. Jordsjo) – in the vicinity of the 800 metres shifted in when insufficiently clear of CASINO MAGIC. Rider was severely reprimanded. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: NARACOORTE READY MIX CONCRETE BENCHMARK 64 HANDICAP - 2000 metres

LAST STAND (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

CHU CHU CHARLIE (D. Tourneur) – blundered on jumping away.

MICKIEM (S. Fawke) – laid in when placed under pressure in the straight.

RACE 6: COOPERS BREWERY CLASS TWO HANDICAP - 1200 metres

MISTA KNOWITALL (D. Tourneur) – rider reported his mount would benefit from racing over a greater distance. A post-race veterinary examination revealed no visible abnormalities.

COOLIDGE (K. Bishop) – over-raced in the early and middle stages of the event.

SWEET SCHILLY (S. Fawke) - slow to begin. Rider reported his mount failed to respond to his riding throughout the event and finished off disappointingly. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: BARRETT PETROLEUM BENCHMARK 72 HANDICAP - 1200 metres

ANY GIVEN GLASS (S. Fawke) - slow to begin. Held up for clear running from the vicinity of the 500 metres to inside the 400 metres. Laid out under pressure in the straight.

LILAC WINE (K. Bishop) – in the vicinity of the 800 metres raced in restricted room for a number of strides.

RACE 8: MINI JUMBUK BENCHMARK 60 HANDICAP - 1430 metres

ZEZE ULATER (K. Crowther) – held up for clear running on entering the straight. In the vicinity of the 300 metres shifted out in an attempt to improve taking AMBER ALERT out onto GREEN BACK DOLLAR.

AMBER ALERT (J. Potter) – over-raced in the early stages of the event. Held up for clear running on entering the straight. In the vicinity of the 300 metres was taken out onto GREEN BACK DOLLAR by ZEZE ULATER when attempting the same run as ZEZE ULATER.

EL GRECO (S. Fawke) - slow to begin.

GREEN BACK DOLLAR (A. Jordsjo) – in the vicinity of the 300 metres was hampered and taken wider after ZEZE ULATER and AMBER ALERT attempted the same run to the inside.
