Report on Race Meeting held at the Mindarie-Halidon Racecourse by the Mindarie-Halidon Racing Club on Sunday, 16 September 2018

RACE 1: MURRAY PIONEER / RADIO 801-5RM / RADIO 5MU-POWER FM / SABOIS CG&E MAIDEN PLATE - 1000 metres

DASKULYA (A. Chan) – laid in under pressure in the straight.

HEEZA PRINCE (J. Potter) – over-raced in the early and middle stages of the event.

PHILTON (J. Huxtable) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

IT'S MAGIC (K. Lau) – hung out from in the vicinity of the 600 metres until in the vicinity of the 200 metres.

RACE 2: KELVIN WESTBROOK TRANSPORT & FEEDLOT / VALPATA PTY LTD / SABOIS F&M MAIDEN PLATE - 1000 metres

BUNDLE O'DIAMONDS (K. Bishop) – shortly after the start rolled in and inconvenienced JOANNA. A post-race veterinary examination revealed no visible abnormalities.

FAITH IN GRACE (J. Potter) - jumped away awkwardly and shifted out taking ISLAND GAME wider.

INVINCIBLE SUSHI (R. Clark) – inclined to rear on jumping away.

JOANNA (K. Crowther) - inconvenienced shortly after the start as BUNDLE O'DIAMONDS rolled in.

PATSY (D. Tootell) - underwent a pre-race veterinary examination as it had not raced for over three years and passed fit to race. Hung out rounding the home turn.

VICKI'S GIRL (A. Lindsay) –on jumping away bumped with ISLAND GAME, which was taken out. In the vicinity of the 700 metres was obliged to be steadied and lost its positon when ISLAND GAME rolled in marginally.

ISLAND GAME (A. Chan) – became fractious in the float en route to the track. Underwent a pre-race veterinary examination and passed fit to race on jumping away. Taken out by FAITH IN GRACE and as a result contacted VICKI'S GIRL. In the vicinity of the 700 metres rolled in marginally onto VICKI'S GIRL, which was obliged to be steadied and lost its position. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: KELVIN WESTBROOK TRANSPORT & FEEDLOT / VALPATA PTY LTD / SABOIS F&M MAIDEN PLATE - 1000 metres (Cont'd)

SIZZLING AFFAIR (J. Toeroek) – held up for clear running from approaching the 400 metres until approaching the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: LOXTON IRRIGATION CENTRE / RIVERLAND MOTOR GROUP / KBH KAROONDA / SABOIS MAIDEN PLATE - 1800 metres

DOUBLE BURNER (K. Bishop) – held up for a short distance in the vicinity of the 300 metres. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In assessing penalty, Stewards took into account the distance of the race and that in their opinion K. Bishop was in contention for the finish.

LORD GREYSON (R. Clark) – rounding the home turn shifted out and contacted NUCLEAR BANG, which became awkward in its action and shifted out abruptly.

NUCLEAR BANG (D. Caboche) – raced keenly in the early and middle stages of the event. Rounding the home turn shifted out abruptly and became awkward in its action taking CHUMPUNYA wider. Rider was reminded of his obligation under AR137A(4)(b) in using his whip in a manner that raised his arm above shoulder height. A post-race veterinary examination revealed no visible abnormalities.

CHUMPUNYA (T. Pannell) – on jumping away bumped with PLAYFUL HOST, which jumped away awkwardly and shifted out. Raced wide without cover throughout the event. Rounding the home turn was taken wider by NUCLEAR BANG, which became awkward in its action and shifted out abruptly.

PLAYFUL HOST (A. Jordsjo) - jumped away awkwardly, shifted out and bumped CHUMPUNYA. Raced wide without cover throughout the event. A post-race veterinary examination revealed an elevated heart rate

RACE 4: VAL & NORM HUMPHRYS BM 54 HANDICAP - 1380 metres

WOLLONGONG (NZ) (D. Caboche) - underwent a pre-race veterinary examination as it had not raced for over 12 months and passed fit to race. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

ARCHWAY TO HEAVEN (D. Tourneur) – laid out throughout the event and in the vicinity of the 700 metres shifted out onto DOUBLE DUX, which was inconvenienced.

CELEBRITY TYCOON (J. Maund) - underwent a pre-race veterinary examination as it had not raced for over 12 months and passed fit to race.

SHEANNA (R. Clark) – in the vicinity of the 100 metres bumped with TAMARA MARIE, which rolled out and was taken wider. A post-race veterinary examination revealed the mare had bled from both nostrils. Stable foreman Mr R. Mirelli on behalf of Trainer, Mr K. Sweeney, was advised that as this was the gelding's first bi-lateral bleed IMPULSE BUY would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

SWIFT JET (A. Chan) - slow to begin. In the vicinity of the 100 metres shifted out abruptly. A post-race veterinary examination revealed no visible abnormalities.

FINNISS MOMENT (D. Morgan) - raced wide without cover throughout the event.

TAMARA MARIE (J. Potter) – in the vicinity of the 100 metres rolled out and bumped SHEANNA, which was taken wider.

DOUBLE DUX (C. Lions) – in the vicinity of the 700 metres was inconvenienced by ARCHWAY TO HEAVEN, which was inclined to lay out and shifted out.

RACE 5: FLEA & DOUG FULLSTON BM 54 HANDICAP - 1380 metres

NOSTROVIA (R. Clark) – slow into stride. A post-race veterinary examination revealed no visible abnormalities.

CHUCKLES (A. Chan) – approaching the 600 metres raced in restricted room for a short distance between LICORICE BULLET and CAPITOLINE. In the vicinity of the 400 metres was buffeted between CAPITOLINE and LICORICE BULLET for a number of strides.

LICORICE BULLET (K. Crowther) – slow into stride.

CAPITOLINE (C. Lions) - raced keenly in the early and middle stages of the event. When making the turn in the vicinity of the 1100 metres became awkward and shifted out. Approaching the winning post shifted out abruptly.

SPIRITED MATCH (A. Lindsay) – approaching the finish rider dropped her off side rein placing her at a disadvantage for several strides.

RACE 6: MALLEE DIPPING AND MULESING / ZADOW WELL DRILLERS BM 56 HANDICAP - 1800 Metres

BALTIC PRINCE (K. Lau) – shifted out abruptly rounding the home turn and became awkward in its action for a short distance. In the vicinity of the 100 metres was hampered when tightened between KINGSGROVE, which was taken in and BROOKTON ICE.

BIG BOY BLEV (R. Clark) – in the vicinity of the 100 metres shifted in under riding when insufficiently clear of COOL TARGET, which was obliged to be steadied to avoid that gelding's heels. Thereafter continued to shift in under riding when insufficiently clear of KINGSGROVE, which was obliged to take hold and lost its positon to avoid the heels of BIG BOY BLEV. Rider pleaded guilty to a charge of careless riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 22 September and to conclude at midnight on Sunday, 30 September 2018: a period of four meetings. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

COOL TARGET (D. Morgan) - in the vicinity of the 100 metres was obliged to be steadied when tightened onto KINGSGROVE as BIG BOY BLEV shifted in when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

BROOKTON ICE (S. Fawke) – raced wide without cover in the early stages of the event. In the vicinity of the 1000 metres improved around the field to take up the lead.

KINGSGROVE (C. Lions) – in the vicinity of the 100 metres was obliged to take hold when tightened onto BALTIC PRINCE to avoid the heels of BIG BOY BLEV, which shifted in when insufficiently clear.

RACE 7: COLLINS INDUSTRIAL DISTRIBUTORS PTY LTD MINDARIE-HALIDON CUP - 1800 metres

DR DAPPER (D. Caboche) - raced keenly in the early and middle stages of the event.

SPIRITOF ENDEAVOUR (USA) (R. Sakai) – raced wide without cover throughout the event.

RED MENACE (A. Chan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: GJ CLARKE & CO BENCHMARK 64 HANDICAP - 1000 metres

MINTRICE (R. Sakai) – rolled out shortly after the start onto SAMBUCA SIREN. A post-race veterinary examination revealed minor skin lacerations underneath both eyes and minor skin abrasion to both eyes.

SAMBUCA SIREN (J. Maund) – hampered shortly after the start when tightened onto ATOMIC LOKADE as MINTRICE rolled out. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: GJ CLARKE & CO BENCHMARK 64 HANDICAP - 1000 metres (Cont'd)

VILLE DE BERNE (A. Jordsjo) - underwent a pre-race veterinary examination in accordance with the TRSA 12-year-old horse racing policy and passed fit to race.
