THOROUGHBRED RACING AUTHORITY S.A. LIMITED STIPENDIARY STEWARDS' REPORT Report on Race Meeting held at the Naracoorte Racecourse by the Naracoorte Racing Club on Sunday, 1 October 2018

RACE 1: FAMILY DAY 30 DECEMBER 2018 / SABOIS PLUS MAIDEN/CLASS ONE PLATE – 1800 meters

QUICKCRAFT (K. Crowther) – in the vicinity of the 1400 metres was momentarily inconvenienced when SOTRMY JACK shifted out whilst over-racing. As a result, QUICKCRAFT over-raced for a number of strides.

BRINGME THE BUTLER (D. Caboche) – in the vicinity of the 600 metres had to be restrained after improving onto the heels of INSTINCTUAL. Laid in under pressure in the straight. When questioned regarding the performance of BRINGME THE BUTLER, rider reported that on entering the home straight he had shifted out in an attempt to improve into a run between LILAC WINE and STORMY JACK. He added his mount was reluctant to improve into that run and as a result was unable to be fully tested to the finish. A post-race veterinary examination revealed no visible abnormalities.

LILAC WINE (K. Bishop) – awkward to begin.

STORMY JACK (E. Finnegan) – in the vicinity of the 1400 metres shifted out whilst over-racing contacting QUICKCRAFT. A post-race veterinary examination revealed no visible abnormalities.

SUDDEN IMPULSE (D. Tourneur) – laid in under pressure in the straight.

RACE 2: HORSE OF THE YEAR IAMTHEKEY BENCHMARK 80 HANDICAP - 1430 meters

VON COSTA GLASS (S. Fawke) – slow to begin.

SOUL FIRE (K. Crowther) – laid in under pressure in the straight.

CHESTNUT CHARLIE (D. Tourneur) – when questioned regarding the performance of the horse rider reported that he was under no specific instructions, but in his opinion there was a distinct lack of pace in the race and as a result he elected to place his mount under pressure in the vicinity of the 800 metres as he was mindful that CHESTNUT CHARLIE was one paced.

RACE 3: MINI JUMBUK NARACOORTE CUP 10 FEB 2019 / SABOIS MAIDEN PLATE - 1430 metres

The start of this event was delayed approximately eight minutes owing to the late scratching of MYPO TIME.

MYPO TIME (D. Tourneur) – dislodged its rider en route to the barriers and galloped a significant distance. Late scratching on veterinary advice at 1.48 pm. Co-trainer, Mr K. Frew, was advised that MYPO TIME would be required to complete an Official Barrier Trial to the Stewards' satisfaction prior to a future race.

SEEARESEVEN (R. Hurdle) – slow to begin and inconvenienced shortly after the start. In the vicinity of the 300 metres had to be restrained to avoid the heels of CHALLICUM, which was taken out by BOMBSHELL BABE (NZ).

ELITE LADY (T. Pannell) – in the vicinity of the 400 metres was severely hampered and taken across the heels of BOMBSHELL BABE (NZ) after PUTTING ON AIRS shifted out.

SECRET BAR (S. Fawke) – over-raced in the early stages of the event.

BOMBSHELL BABE (NZ) (J. Beriman) – in the vicinity of the 300 metres shifted out marginally taking CHALLICUM out onto SEEARESEVEN.

PUTTING ON AIRS (K. Crowther) – hung out throughout the event and in the vicinity of the 300 metres shifted out taking ELITE LADY out across the heels of BOMBSHELL BABE (NZ). Rider severely reprimanded.

ATOMIC RUMOUR (D. Bates) – a post-race veterinary examination revealed no visible abnormalities.

CHALLICUM (E. Boyd) – slow to begin. In the vicinity of the 500 metres had to be restrained after improving onto heels.

RACE 4: GERICKE LOGISTICS / SABOIS MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately seven minutes owing to the late scratching of FAREWELL GRETA and a kangaroo in close proximity to the race course.

FAREWELL GRETA (A. Chan) – underwent a pre-race veterinary examination after becoming fractious in the mounting enclosure and was passed fit to start. Dislodged its rider behind the barriers and ran a considerable distance. Late scratching on veterinary advice at 2.28 pm. Trainer, Mr M. O'leary, was advised that FAREWELL GRETA was required to complete an Official Barrier Trial to the satisfaction of Stewards prior to a future race start.

SOME ACTION (S. Fawke) – rider advised that his mount raced greenly throughout the event, failed to respond to his riding at any stage and went to the line in a disappointing manner. A post-race veterinary examination revealed no visible abnormalities.

FERGIE (K. Crowther) – laid in under pressure in the straight.

RACE 5: NARACOORTE CFS BENCHMARK 60 HANDICAP - 1000 metres

SNIP OF MAGIC (D. Caboche) – over-raced in the early stages of the event.

AKERBOY (E. Finnegan) – over-raced in the early stages of the event.

NAUGHTY RABBIT (S. Fawke) – slow to begin.

RACE 6: RENEW YOUR NRC MEMBERSHIP BENCHMARK 64 HANDICAP - 2000 metres

MR STEAL (NZ) (A. Lindsay) – in the vicinity of the 400 metres allowed her mount to improve into a run where there was insufficient room to the inside of KINGSGROVE, and as a result made contact with the hindquarters of KINGSGROVE unbalancing both runners. Rider pleaded guilty to a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence midnight Wednesday, 3 October 2018 to conclude midnight Wednesday, 10 October 2018, a period of three race meetings.

SUDDEN MOMENT (K. Crowther) – a post-race veterinary examination revealed no visible abnormalities.

TOMMY GUN (S. Fawke) – rider reported that he was instructed if the pace slackened in the middle stages to allow his mount to improve around runners as in his opinion his mount was very much one paced.

KINGSGROVE (D. Caboche) – in the vicinity of the 400 metres was severely hampered when MR STEAL (NZ) attempted to improve into a run to its inside, contacting KINGSGROVE's hindquarters. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: TRADIES DAY 23 NOVEMBER 2018 BENCHMARK 56 HANDICAP - 1200 metres

FIRST REWARD (K. Crowther) – began awkwardly, shifted out taking BURNVALE LADY out onto CATCH US.

CATCH US (S. Fawke) – hampered on jumping away. Laid out throughout the event.

BURNVALE LADY (D. Bates) – hampered on jumping away.

GOLDEN RULE (G. Lo) – slow to begin.

RACE 8: COOPERS CLASS TWO HANDICAP - 1430 metres

ARCHWAY TO HEAVEN (D. Tourneur) – over-raced in the early stages of the event.

JACKTHEGIANTSLAYER (J. Maund) – momentarily inconvenienced in the vicinity of the 300 metres when MONTRE rolled in marginally. As a result JACKTHEGIANTSLAYER was taken in onto DELIGHTFUL SCOOP, which was severely hampered.

CLAIBORNE KING (E. Boyd) – underwent a pre-race veterinary examination after not competing in the last twelve months and was passed fit to start.

MONTRE (K. Bishop) – in the vicinity of the 300 metres rolled in momentarily taking JACKTHEGIANTSLAYER in onto DELIGHTFUL SCOOP.

DELIGHTFUL SCOOP (P. Marks) – over-raced in the early stages of the event. In the vicinity of the 300 metres had to be restrained and became severely hampered by JACKTHEGIANTSLAYER, which was taken in MONTRE.
