**RACE 1: AAMI SPRING CARNIVAL AT MORPHETTVILLE OCT 20 - NOV 6 HANDICAP - 1600 metres**

**ROSELLI STING** (L. King) – contacted on jumping away. Laid in under pressure in the straight.

**RIKIBOBBY** (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr P. Hardacre advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**GALAXY GAZER** (R. Clark) – taken wider in the vicinity of the 1100 metres when contacted by WITH A BIT OF DASH.

**DIAPASON (NZ)** (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

**SAVANERO (NZ)** (A. Jordsjo) – shifted in, in the vicinity of the 1100 metres when insufficiently clear of WITH A BIT OF DASH, which was forced to take hold to avoid that gelding's heels. Rider pleaded guilty to a charge of careless riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 29 September and to conclude at midnight on Wednesday, 3 October 2018: a period of three meetings.

**WICKED PROMISE** (S. Fawke) – shifted in on jumping away and contacted ROSELLI STING. Laid out rounding the home turn. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer Mr G. Lesnikowski advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**WITH A BIT OF DASH** (G. Cartwright) – shifted out on jumping away contacting ROSELLI STING. Forced to take hold in the vicinity of the 1100 metres to avoid the heels of SAVANERO (NZ), and in doing so shifted out contacting GALAXY GAZER.

**RACE 2: TABLE & CHAIR CO THREE-YEAR-OLD MAIDEN PLATE – 1100 metres**

**LIPPSY SHUFFLE** (A. Chan) – shifted out on jumping away contacting TONGSAI BOSS. Raced greenly in the straight. A post-race veterinary examination revealed no visible abnormalities.

**SPLASH SOME CASH** (Z. Spain) slow to begin.

**TONGSAI BOSS** (T. Pannell) – contacted on jumping away.

## **RACE 2: TABLE & CHAIR CO THREE-YEAR-OLD MAIDEN PLATE – 1100 metres (Cont'd)**

**CHARMIST** (D. Tourneur) - raced keenly in the early and middle stages of the event.

**HOLY TORMENT** (G. Cartwright) - raced keenly in the early and middle stages of the event.

**SASSY MANEUVER** (J. Maund) – in the vicinity of the 700 metres rolled out onto UNDESIRE.

**SWORD OF MERCY** (L. King) - a post-race veterinary examination revealed no visible abnormalities.

**UNDESIRE** (S. Fawke) - raced keenly in the early and middle stages of the event. In the vicinity of the 700 metres was taken out by SASSY MANEUVER onto ROYAL RING.

**ROYAL RING** (R. Clark) – in the vicinity of the 700 metres was inconvenienced when taken wider by UNDESIRE. Laid in under pressure in the straight.

**SIR GARFIELD** (A. Jordsjo) – kicked by another runner en route to the barriers. Underwent a pre-race veterinary examination and ruled unfit to race. Acting on this advice, Stewards withdrew SIR GARFIELD at 1.20 pm.

## **RACE 3: FLEURIEU MILK COMPANY HANDICAP – 2000 metres**

**HOLY JUAN** (T. Pannell) – rider explained the gelding had jumped away better than expected and due to the formation of the field, he had settled closer to the speed than he had anticipated.

**WICKED RHYTHM** (G. Cartwright) - raced keenly in the early and middle stages of the event.

**CREANCE** (J. Holder) – inclined to lay in under pressure in the straight.

## **RACE 4: DOMINANT HANDICAP - 1100 metres**

The start of this event was delayed approximately two minutes.

**DOMINATION** (C. Caserta) - jumped away awkwardly and was slow into stride. Rider explained it was his intention to take up a position in the lead however, after jumping away poorly, he was obliged to race wide outside of the leading group. He added the gelding had travelled well, however had been disappointing to the finish. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer Mr T. McEvoy was advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**WRAPSODY** (L. Riordan) – shifted out on jumping away and contacted CALLISTO GIRL.

**BWUVA** (R. Sakai) – contacted in the vicinity of the 100 metres by COLUMBIA on a number of occasions.

**CALLISTO GIRL** (D. Tourneur) – had blood in its mouth on arrival at the barriers. Underwent a pre-race veterinary examination and passed fit to race. Fractious in its barrier after being loaded and was re-examined by the Club's Veterinary Surgeon and was passed fit to race. Shifted in on jumping away and contacted WRAPSODY.

**COLUMBIA** (T. Pannell) – held up from the vicinity of the 400 metres until the 100 metres, then shifted out to obtain clear ground and in doing so bumped BWUVA on two occasions.

**CONTAINMENT** (R. Clark) – had difficulty in obtaining clear ground over the concluding 150 metres.

**MAZESTIC** (J. Holder) – approaching the 200 metres was disappointed when attempting a tight run between the heels of DOMINATION and CALLISTO GIRL and became held up until inside the 100 metres.

#### **RACE 5: SKY ATA TRAINERS' TRUST HANDICAP – 1200 metres**

**EDGEWOOD** (J. Huxtable) – stood flat footed and was slow to begin. Trainer Mr J. Macmillan was advised a warning had been placed on the gelding.

**BALWARRA GOLD** (E. Finnegan) - jumped away awkwardly. Rider reported the gelding made an abnormal respiratory noise on pulling up. A post-race veterinary examination revealed no visible abnormalities.

**MOGHUL EMPIRE** (J. Toeroek) - jumped away awkwardly. Rider explained it was his expectation that the gelding would settle further forward in the event, however after jumping away awkwardly, he found himself further back than anticipated. He added the gelding had not travelled well throughout the event and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

**DEBT COLLECTOR** (R. Clark) – shifted in, in the vicinity of the 100 metres when insufficiently clear of SWIPE ME RIGHT, which was severely hampered and forced to check to avoid that gelding's heels. Rider pleaded guilty to a charge of careless riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 30 September 2018 (at the conclusion of the suspension incurred at Mindarie Halidon on Sunday, 16 September 2018) and to conclude at midnight on Saturday, 13 October 2018: a period of six meetings.

**EXTREME THRILL** (G. Cartwright) – laid in under pressure in the straight.

**SWIPE ME RIGHT** (D. Tourneur) – in the vicinity of the 100 metres was severely hampered and forced to check when DEBT COLLECTOR shifted in.

#### **RACE 6: TOKYO CITY CUP - 1800 metres**

**YOGI (NZ)** (N. Callow) - slow to begin.

**BROWN BEN** (C. Parish) – laid out under pressure in the straight.

**DANON LIBERTY (JPN)** (C. Symons) – rider reported the horse had travelled well in the early and middle stages of the event however, did not let down as he had expected and was disappointing to the finish. A post-race veterinary examination revealed the horse to be lame in the off hind leg. Trainer Mr D. Weir was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

#### **RACE 7: W H WYLIE HANDICAP - 1100 metres**

**CASINO WIZARD** (N. Callow) - jumped away awkwardly and shifted in onto ALL ABOUT NICCI. Taken in off its running line between the 1000 metres and the 800 metres by DESERT LASHES.

**LOPE DE CAPIO** (T. Pannell) –Raced in restricted room for a short distance in the vicinity of the 100 metres when awkwardly placed to the inside of PRINCESS OF QUEENS, which had been taken in.

**DESERT LASHES** (R. Vigar) – shifted in taking CASINO WIZARD in from the 1000 metres to the 800 metres. Rider reprimanded. Approaching the 100 metres shifted in under riding when insufficiently clear of PRINCESS OF QUEENS, which was forced to take hold and lost its position. Rider was found guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 23 September and to conclude at midnight on 6 October 2018: a period of six meetings.

**PRINCESS OF QUEENS** (C. Parish) – had to be steadied approaching the 800 metres when awkwardly placed on the heels of HOLY BLADE. In the vicinity of the 100 metres had to take hold and lost its position when DESERT LASHES shifted in.

**DEMERARA** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 7: W H WYLIE HANDICAP - 1100 metres (Cont'd)**

**KHALAMA** (R. Sakai) – inconvenienced in the vicinity of the 50 metres when ALTA STELLA was taken out.

**HOLY BLADE** (H. Coffey) – hampered approaching the 800 metres and forced to be steadied when taken in onto the heels of FANCY RUMBLE by ALTA STELLA.

**ALL ABOUT NICCI** (C. Caserta) – lost its position on jumping away. Shifted out in the vicinity of the 50 metres onto ALTA STELLA.

**MAZUREK** (G. Cartwright) - jumped away awkwardly.

**ALTA STELLA** (K. Crowther) – approaching the 800 metres improved onto the heels of CARLINGFORD and had to be steadied. In being steadied, shifted in onto HOLY BLADE. Inconvenienced in the vicinity of the 50 metres when ALL ABOUT NICCI shifted out. A post-race veterinary examination revealed no visible abnormalities.

**RACE 8: HUGHES LIMOUSINES HANDICAP - 1200 metres**

**GRACENA** (K. Crowther) – in the vicinity of the 50 metres improved onto the heels of ATLANTICA, which commenced to give ground and had to be steadied. A post-race veterinary examination revealed no visible abnormalities.

**TRUPT** (R. Sakai) – shifted out on jumping away onto RIVER LEE.

**ATLANTICA** (A. Chan) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Inclined to lay out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

**RIVER LEE** (C. Parish) - jumped away awkwardly and shortly after was inconvenienced by TRUPT.

**GENERAL**

Stewards questioned Apprentice Liam Riordan in relation to him failing to provide Stewards his Winning Ride Book as required. L. Riordan pleaded guilty to a charge under AR92(10) and was fined \$200. As this was the second straight week that L. Riordan had failed to provide his book, he was advised that a future breach under this rule may result in him being stood down from riding at the meeting.

Race 5 – EDGEWOOD – Warned – Barrier manners. Race 6 – DANON LIBERTY (JPN) – Not to race – Vet Cert of Fitness required prior to future trial or race – Lameness off hind leg.
