

**THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT**

**Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 10 November 2018**

RAIL: Out 5 metres 1000 metres to the Winning Post, out 3 metres remainder. Sectional 606 metres.

RACE 1: UBET TWO-YEAR-OLD PLATE - 1000 metres

SOUTH STREET BOSS (T. Pannell) – had to be removed from its barrier stall after being loaded and was examined by the Club's veterinary surgeon as a result of YULONG ROCKSTAR becoming fractious in its barrier stall and getting both front legs over the partition between both runners and was passed fit to start.

STAR QUEST (R. Hurdle) – a post-race veterinary examination revealed no visible abnormalities.

YULONG ROCKSTAR (H. Coffey) – proved very fractious after being loaded in its barrier stall, reared and got both its front legs over the inside barrier partition. Removed from its barrier, underwent a pre-race veterinary examination and passed fit to start. Co-trainers, Mr C. Maher and Mr D. Eustace, were advised that a warning had been placed on the colt in relation to its barrier manners. Raced greenly in the straight. A post-race veterinary examination revealed the horse to be lame in the near hind leg. Co-trainers, Mr C. Maher and Mr D. Eustace, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

RACE 1: UBET TWO-YEAR-OLD PLATE - 1000 metres (cont'd)

CHOKITA (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

RACE 2: 36° SOUTH THREE-YEAR-OLD MAIDEN PLATE – 1250 metres

ALIRIS (R. Clark) – over-raced in the early stages of the event. Made the turn near the 900 metres very awkwardly, shifted taking REGALO DI GAETANO wider on the track and after being corrected shifted abruptly into the running line of KAMIEN, which was hampered resulting in that horse having to be restrained for several strides. A post-race veterinary examination revealed no visible abnormalities.

KAMIEN (S. Thornton) – awkward to begin. Near the 900 metres had to be restrained for several strides when hampered and awkwardly placed on the heels of ALIRIS, which shifted in abruptly. A post-race veterinary examination revealed no visible abnormalities.

REGALO DI GAETANO (P. Gatt) – taken wider near the 900 metres. Laid out in the straight.

SMART ALICK (J. Toeroek) – over-raced in the early and middle stages of the event. Inside the 600 metres raced in restricted room inside KENYAN WONDER, which shifted in slightly, resulting in SMART ALICK having to be restrained to avoid KENYAN WONDER's heels.

JETTY LANE (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

KENYAN WONDER (T. Pannell) – over-raced in the early stages of the event. Near the 600 metres shifted in slightly tightening SMART ALICK for several strides, resulting in that horse having to be restrained. Rider severely reprimanded and advised to take greater care when shifting ground in future.

MISS HARMONIUM (S. Fawke) – awkward to begin. Over-raced in the early stages of the event.

RACE 3: MYPUNTER.COM MAIDEN PLATE – 1400 metres

JOHN'S LAST SONG (S. Fawke) – awkward to begin. Laid out severely in the straight. A post-race veterinary examination revealed no visible abnormalities.

SCOUT'S HONOUR (E. Finnegan) – became awkwardly placed inside the heels of FOX BY ZERPRISE inside the 1000 metres for several strides.

IT'S MAGIC (J. Toeroek) – awkward to begin. Approaching the 100 metres laid out and shifted out.

VOSOTA (P. Gatt) – contacted at the start.

BIG TOP (J. Holder) – rider reported that in his opinion the mare jarred up in running. A post-race veterinary examination revealed no visible abnormalities.

LIBERTY LOVER (R. Clark) – shifted in at the start and contacted VOSOTA.

REBEL ROMANCE (J. Kah) – laid out in the straight.

RACE 4: AAMI HANDICAP - 1000 metres

HE IS GOLDEN (D. Tourneur) – slow into stride. Rider explained that he had no specific instructions; however, he considered that, having regard for the pace in the event and this horse's racing pattern, he would settle on pace; however, having regard for the manner in which the gelding began and its reluctance to stretch out shortly after the start, he was obliged to settle back.

THOMPSON'S REWARD (K. Crowther) – inconvenienced at the start. Rider explained that she had no specific instructions, but stated that she settled more forward than she had intended and would have preferred to have been one pair back in running, but owing to the manner in which THOMPSON'S REWARD raced in the early stages, that being keenly, she was unable to settle further back as intended.

AMATIVE (G. Cartwright) – shifted out at the start onto THOMPSON'S REWARD, which was hampered when taken out onto MINTRICE, which was inconvenienced.

MINTRICE (R. Sakai) – inconvenienced at the start. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: 13CABS HANDICAP - 1250 metres

ZALMONA (G. Cartwright) – had its head turned just before the gates were released and as a consequence was awkward and slow to begin. Over-raced in the early stages of the event and approaching the 1000 metres improved onto the heels of EMBECEEE LIL and became awkward for several strides and had to be restrained.

LORD TOPPER (D. Tourneur) – raced keenly in the early stages of the event. Laid out in the straight.

EMBECEEE LIL (T. Pannell) – rider reported that the mare travelled well early but failed to let down in the straight. A post-race veterinary examination revealed no visible abnormalities.

JUST A BIGGER DASH (J. Kah) – held up for clear running from the entrance to the straight until near the 100 metres when racing between LORD TOPPER and ARROW LANE, and as a consequence was only able to be tested inside the final 100 metres of the event.

TRUPT (J. Holder) – disappointed for clear running from near the entrance to the straight until approaching the 200 metres and thereafter shifted to the outside of JUST A BIGGER DASH to improve its position, but then became held up for clear running when racing outside JUST A BIGGER DASH and behind MYSTICANO and was unable to obtain clear running until near the 50 metres.

BWUVA (R. Sakai) – over-raced in the middle stages of the event. Unable to obtain clear running from shortly after the entrance to the straight until near the 200 metres. Laid out over the concluding stages of the event.

RACE 6: TERRY HOWE PRINTING HANDICAP - 1000 metres

ECLAIR CHOICE (D. Caboche) – laid in, in the straight. When questioned about his reaction to a call from J. Holder (REWARDING LAUGHTER) near the 700 metres, D. Caboche explained that he heard a call from J. Holder, to his outside, and in reaction to that call looked to his inside to ascertain if any riders to his inside had improved. D. Caboche further stated that notwithstanding the call from J. Holder, he considered that he had not shifted ground inwards to an extent to allow J. Holder not to be trapped wide without cover. Stewards also questioned J. Holder regarding a call made to D. Caboche near the 700 metres and confirmed that J. Holder had called to D. Caboche regarding ground available to the inside of that runner. In the circumstance Stewards were satisfied that D. Caboche had not ridden his mount in a manner that advantaged J. Holder.. A post-race veterinary examination revealed no visible abnormalities.

MYSTIFIED (P. Gatt) – trainer, Mr R. Balfour, was reprimanded for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards.

WING SNIPPER (A. Jordsjo) – raced ungenerously in the early stages. Approaching the 400 metres made the turn very awkwardly and became unbalanced for several strides. A post-race veterinary examination revealed no visible abnormalities.

RED DAZZLE (C. Caserta) – awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: HEINEKEN 3 HAPPY TRAILS SERIES FINAL – 1400 metres

LIFE OF WALDO (S. Thornton) – lost its near hind plate during the event.

LIKE TO THINK SO (H. Coffey) – near the 1000 metres shifted in to take up a position on the rail, crossed the running of PAMELA JOY, which was inconvenienced and had to be steadied. Rider severely reprimanded and advised to take greater care when shifting ground.

DEBT COLLECTOR (R. Clark) – rider explained that she had no specific instructions other than to allow the gelding to settle where comfortable. She added that due to a more favourable barrier draw and the pace in the early stages of the event the gelding settled more forward than usual.

MIDNIGHT STORM (G. Cartwright) – made the turn near the 900 metres very awkwardly. A post-race veterinary examination revealed no visible abnormalities.

TRIPLE DEEZ (J. Toeroek) – underwent a pre-race veterinary examination on arrival at the barriers and was declared a late scratching by order of Stewards acting on veterinary advice at 4.38 pm.

PAMELA JOY (D. Tourneur) – near the 1000 metres was inconvenienced and had to be steadied as LIKE TO THINK SO improved its position and crossed towards the rail. Rider pleaded guilty to a charge under AR91 for leaving the course after this event without Stewards permission and was fined \$200. Lost its off hind plate during the event.

TAHNEE TIARA (E. Finnegan) – trainer, Mr P. Hardacre, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle further back owing to the horse's wide barrier.

RACE 7: HEINEKEN 3 HAPPY TRAILS SERIES FINAL – 1400 metres (cont'd)

IMPULSE DIAVOLO (J. Holder) – near the 200 metres was inconvenienced and had to be steadied as **BROTHER DARKNESS** shifted in and away from the whip, and thereafter had difficulty obtaining clear running for a number of strides.

IRON MAX (C. Caserta) – slow to begin.

PALE ALE (K. Crowther) – over-raced in the early stages of the event.

BROTHER DARKNESS (A. Chan) – raced wide without cover in the middle stages of the event. Near the 200 metres shifted in and away from the whip and inconvenienced **IMPULSE DIAVOLO**, which had to be steadied.

MISS WAHOO (J. Kah) – a post-race veterinary examination revealed the mare to be lame in both forelegs. Trainer, Mr T. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future race start.

RACE 8: DAVID FAZAKERLEY FREEDOM FINALE CUP – 1400 metres

BURIED TREASURE (S. Thornton) – laid out in the straight. Lost its off hind plate during the event.

MARMAN (S. Fawke) – laid out severely from rounding the home turn.

PICTURE ME ROLLING (R. Clark) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

EL DESPERADO (K. Crowther) – laid out in the straight. Rider reported that the gelding jarred up in running. A post-race veterinary examination revealed no visible abnormalities.

REDEEM BOUNTY (P. Gatt) – inclined to lay out in the straight.

CONTAINMENT (G. Cartwright) – Laid in, in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

PARIS CRYSTAL (J. Kah) – rider reported the mare had every opportunity in the straight but did not finish the race off as expected and was disappointing over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

EXACTING (K. Bishop) – over-raced in the early stages of the event. Near the 1000 metres became very awkward for several strides when racing in restricted room between runners. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100. A post-race veterinary examination revealed no visible abnormalities.
