**RACE 1: WINNING EDGE PRESENTATIONS/SABOIS MAIDEN PLATE - 1300 metres**

**BIANZEDA** (A. Jordsjo) - jumped away awkwardly.

**SCALLYWAG** (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

**SHABO GOLD** (J. Lorensini) - jumped away awkwardly.

**JEWELLER'S CLUB** (S. Logan) - reared on jumping away. Laid in, in the straight.

**NOT TELLIN'** (J. Beriman) - laid out from the 400 metres.

**RACE 2: UBET/SABOIS MAIDEN PLATE - 1100 metres**

**FAITH IN GRACE** (K. Lau) - in the vicinity of the 600 metres shifted in and inconvenienced STAR MOOLA. Rider reminded of his obligations to take greater care when shifting ground in future. Rider reported the mare travelled fairly until placed under pressure inside the 300 metres and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

**WHEN IN VEGAS** (J. Potter) - laid out in the straight.

**TEATRO** (A. Jordsjo) - in the vicinity of the 600 metres shifted in and away from FAITH IN GRACE.

**RACE 3: PENOLA TWILIGHT MEETING 7<sup>TH</sup> DECEMBER / SABOIS MAIDEN PLATE - 1700 metres**

**LITTLE CRACKLES** (E. Boyd) - ride explained in the vicinity of the 1000 metres the gelding felt awkward in its action and for that reason eased the gelding out of the event. A post-race veterinary examination revealed no visible abnormalities.

**MYPO TIME** (K. Bishop) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3: PENOLA TWILIGHT MEETING 7<sup>TH</sup> DECEMBER / SABOIS MAIDEN PLATE**  
**- 1700 metres (Cont'd)**

**BLUE BALOONS** (K. Crowther) - raced keenly in the early and middle stages of the event.

**IRISH DELIGHT** (J. Beriman) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres improved onto the heels of AMERICAN BLUE and had to be restrained. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the mare performing satisfactorily in an Official Barrier Trial.

**JOMMADOSH** (J. Potter) - rider was found guilty under AR137A4(c) for using his whip when out of contention and was reprimanded.

**PLATINUM CHLOE** (R. Hurdle) - jumped away awkwardly.

**RACE 4: MAAOUE DISTRICT FARMERS BENCHMARK 60 HANDICAP - 1100 metres**

**DABAY** (K. Crowther) - laid out from the 400 metres until the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

**BROBAK** (P. Marks) - raced keenly in the middle stages of the event. In the vicinity of the 600 metres had to be restrained when improving onto the heels of GET IN THE BOWL.

**STRATEGIC SPICE** (R. Hurdle) - slow to begin.

**CASINO MAGIC** (K. Bishop) - laid in, in the straight.

**RACE 5: COOPERS BREWERY BENCHMARK 60 HANDICAP - 1700 metres**

**BRONSKI** (J. Lorensini) - raced keenly in the early and middle stages of the event. In the vicinity of the 50 metres shifted in tightening the running of FORCE OF THREE. Rider severely reprimanded under AR137(a) for shifting ground when insufficiently clear.

**CENTENARY SHOT** (R. Hurdle) - held up for clear running from the 500 metres until the 200 metres.

**ANYPORTINASTORM** (E. Finnegan) - laid in, in the straight.

**SIR CHARLESTON (NZ)** (S. Logan) - approaching the 1200 metres had to be eased to avoid the heels of CLAIBORNE KING, which shifted in.

**CLAIBORNE KING** (J. Maund) - approaching the 1200 metres shifted in when insufficiently clear of SIR CHARLESTON (NZ). Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 11 November and to conclude at midnight on Saturday, 17 November 2018: a period of three meetings.

**FORCE OF THREE** (E. Boyd) - approaching the 50 metres was disappointed for a run between BRONSKI, which shifted in and CLAIBORNE KING and was obliged to ease and shift out to avoid the heels of BRONSKI.

**RACE 6: REMEMBRANCE DAY, LEST WE FORGET BENCHMARK 72 HANDICAP - 1300 metres**

**HASTA LA THOMAS** (S. Cahill) - raced wide throughout the event.

**- 1300 metres (Cont'd)**

**DYAGILEV** (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

**COASTA LANTE** (D. Smith) - slow into stride. A post-race veterinary examination revealed no visible abnormalities.

**RACE 7: HYLAND FOX SIGNS BENCHMARK 56 HANDICAP - 1400 metres**

**POLAR VORTEX** (G. Lo) - approaching the finish shifted out abruptly and bumped **BEL MOSHE**.

**ARISTOCAT** (K. Bishop) - jumped away awkwardly, shifted out abruptly and tightened **MISTY HALO**.

**JACKTHEGIANTSLAYER** (D. Smith) - rider reported the gelding travelled well until the 400 metres however, when placed under pressure did not finish the race off as well as expected. A post-race veterinary examination revealed no visible abnormalities.

**DANNY WIZZ BANG (NZ)** (J. Potter) - underwent a pre-race veterinary examination as it was kicked by another runner behind the barriers and passed fit to race. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**BEL MOSHE** (E. Finnegan) - approaching the finish was bumped by **POLAR VORTEX**. A post-race veterinary examination revealed no visible abnormalities.

**HASTA LA BOUNTY** (P. Marks) - from in the vicinity of the 1200 metres raced with its head up for some distance when being restrained.

**MISTY HALO** (J. Maund) - tightened for room on jumping away and lost its position between **ARISTOCAT**, which shifted out abruptly and **FREE THE WIND**. Disappointed for clear running between the 300 metres and 200 metres.

**FREE THE WIND** (K. Crowther) - underwent a pre-race veterinary examination and passed fit to race. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.
