

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 8 December 2018

RACE 1: MYPUNTER.COM HANDICAP - 2600 metres

The start of this event was delayed approximately four minutes owing to heavy rain falling in the twenty minutes falling prior to the start time resulting in surface water being present on the crossing near the 2000 metres. Maintenance work had also been carried out on the crossing following morning rain. Stewards and senior riders inspected the area and deemed it safe for racing.

SHIMRANO (GER) (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

KELLSTORM (IRE) (H. Coffey) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

OLYMPIC ACADEMY (J. Toeroek) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

THE MIGHTY JROD (NZ) (C. Caserta) – stepped the crossing in the vicinity of the 2000 metres. Laid out over the concluding 600 metres. A post-race veterinary examination revealed no visible abnormalities.

EXALTED CRAFTSMAN (K. Bishop) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

HENRY THE DOLPHIN (S. Fawke) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.



RACE 2: TONY GRANTHAM'S 60TH HANDICAP - 1050 metres

HEAVEN'S DEAL (C. Caserta) – raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. Rider reported that the filly had been disappointing when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

BOOTS TARRINGTON (J. Lorensini) – laid out rounding the home turn.

YULONG MONOCEROS (H. Coffey) – on entering the straight attempted a run to the inside of CALIPARI and became disappointed when that gelding rolled in, resulting in the rider having to alter course to the outside of its heels to obtain clear ground.

CALIPARI (D. Tourneur) - rolled in, in the vicinity of the 300 metres.

MARTINIQUE (J. Holder) - raced keenly in the early and middle stages of the event.

RACE 3: HUGHES LIMOUSINES HANDICAP - 1500 metres

ICE GHOST (J. Holder) - laid in under pressure in the straight.

SHARK IN THE WATER (C. Parish) – scrambled on jumping away and shifted out onto SPLASH SOME CASH. Laid in under pressure in the straight.

TENDERLY (C. Caserta) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SPLASH SOME CASH (D. Tourneur) – inconvenienced on jumping away.

RACE 4: TERRY HOWE PRINTING HANDICAP - 1600 metres

HUSSYBAY (R. Hurdle) – in the vicinity of the 50 metres shifted out under riding into the running line of HIDATSA, which was forced to be checked. Rider pleaded guilty to a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence midnight Friday, 14 December 2018 and to conclude midnight Friday, 21 December 2018, a period of four race meetings. A post-race veterinary examination revealed no visible abnormalities.

ROYAL RUMBLE (J. Holder) – in the vicinity of the 50 metres had to be momentarily steadied when taken out onto the heels of BALF'S CHOICE by HIDATSA.

HIDATSA (D. Tourneur) – jumped away awkwardly. Raced keenly in the early and middle stages of the event. Had to be checked in the vicinity of the 50 metres when HUSSYBAY shifted out and was taken out onto ROYAL RUMBLE.

RACE 5: BAROSSA FINE FOODS HANDICAP - 1800 metres

SINGLE HANDED (T. Pannell) - laid out under pressure in the straight.

FRANKEL MY DEAR (D. Tourneur) – jumped away awkwardly.

WALTZING WODKA (E. Finnegan) - jumped away awkwardly and was slow into stride.

CENTRE DIVIDER (K. Bishop) – hung out rounding the home turn.



RACE 6: SERAFINO WINES HANDICAP - 1050 metres

TILDY LAD (A. Jordsjo) - laid out over the concluding 600 metres.

CASHED (G. Cartwright) – raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. Lost its near fore plate during the event. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

IRISH MINT (J. Toeroek) - rider reported that the gelding laid out under pressure.

RACE 7: SCHWEPPES CITY OF MARION STAKES - 1200 metres

CASINO WIZARD (E. Finnegan) - raced fiercely in the early and middle stages of the event.

LOPE DE CAPIO (D. Tourneur) – in the vicinity of the 900 metres improved onto the heels of KARLOVASI, and had to be steadied for a number of strides. Had difficulty obtaining clear ground from the 400 metres to the finish.

KARLOVASI (J. Toeroek) - dipped on jumping away.

PLATINUM ANGEL (H. Coffey) – slow to begin. Had difficulty obtaining clear ground from the vicinity of the 400 metres until near the 100 metres. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer, Mr D. Weir, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

SO YOU TOO (J. Holder) – jumped away awkwardly. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ONE MORE DAISY (C. Caserta) – in the vicinity of the 900 metres improved onto the heels of LOPE DE CAPIO and had to be steadied. Approaching the 100 metres attempted to shift out to obtain clear ground, brushed ARKHAM KNIGHT, and when unable to do so was forced to race in restricted room behind SO YOU TOO and inside ARKHAM KNIGHT.

NARIKO (C. Parish) – raced keenly in the early and middle stages of the event whilst being restrained.

RACE 8: THIRSTY CAMEL CUP LAWN PARTY- DEC 21 AT MORPHETTVILLE HANDICAP - 1200 metres

FRENCH ROCK (A. Darmanin) - a post-race veterinary examination revealed no visible abnormalities.

CHAROSSA (A. Jordsjo) - jumped away awkwardly. Shifted about under pressure in the straight.

LADY OF CREBILLY (C. Caserta) – reared over in the mounting yard dislodging its rider. C. Caserta was examined by the First Care Medical personnel and passed fit to fulfil his engagement. LADY OF CREBILLY was examined by the Club's Veterinary Surgeon who found the mare to be lame in the off hind leg. Acting on that advice Stewards withdrew LADY OF CREBILLY at 5.35 pm. Trainer, Mr P. Stokes, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

EXALTED LAURETTA (C. Parish) - slow to begin.

MAXSAMIA (K. Bishop) - jumped away awkwardly.
