Report on Race Meeting held at Morphettville Racecourse

**TRACK:** Soft 5 (Track with reasonable amount of five in it)  
Upgraded to a Good 4 at 11.45 am (Track with some give in it)

**RAIL:** Out 6 metres from 1200 metres to Winning Post, out 3 metres remainder. Sectional 608 metres.

**RACE 1: TRIPLE M HANDICAP - 1200 metres**

**BUNGALALLY BELLE** (E. Boyd) - jumped away awkwardly. A post-race veterinary examination revealed the mare to have atrial fibrillation and dysrhythmia. Trainer, Mr D. Dodson, was advised that the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the mare performing satisfactorily in an Official Barrier Trial.

**MIGHTY MOSHE** (N. Farley) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**MYOPIC** (D. Caboche) - laid in over the concluding 600 metres of the event.

**RACE 2: HOLDFAST INSURANCE / SABOIS 3YO COLTS & GELDINGS MAIDEN PLATE - 1050 metres**

**ABBI FEDE** (J. Holder) - inconvenienced on jumping away. Inconvenienced at the entrance to the straight.

**BAR GEM** (O. Ridge) - in the vicinity of the 200 metres shifted out to obtain clear ground and in doing so contacted EXALTED TRAIL taking that gelding wider.

**BROTHERHOOD OF MAN** (R. Hurdle) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**CALIPARI** (D. Tourneur) - jumped away awkwardly and shifted out onto ABBI FEDE. Raced keenly in the early and middle stages of the event.

**EXALTED TRAIL** (J. Potter) - inconvenienced in the vicinity of the 200 metres when taken wider by BAR GEM, which shifted out. Slipped behind on return to the mounting yard. A post-race veterinary examination revealed no visible abnormalities.

**GONE TO PRINT** (D. Caboche) - jumped away awkwardly and shortly afterwards was hampered when tightened between EXALTED TRAIL and PAPALET, which both shifted ground slightly. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

**PEARL BANDIT** (A. Jordsjo) - slow to begin.

**RIZSKI** (T. Pannell) - shifted out at the entrance to the straight inconveniencing ABBI FEDE.

**WHITE HEATH** (R. Clark) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3: DARLEY / SABOIS THREE-YEAR-OLD FILLIES MAIDEN PLATE - 1050 metres**

**BOTTLE AND BIRD** (T. Pannell) - in the vicinity of the 200 metres became held up when forced to race in restricted room between the heels of JAAMINT, which shifted in slightly at the same as MABEL JOSEPHINE shifted out slightly, and then became awkwardly placed on the heels of JAAMINT as that filly commenced to give ground approaching the finish. A post-race veterinary examination revealed no visible abnormalities.

**GENNIKAY** (D. Tourneur) - hung in for a number of strides at the entrance to the straight. Shifted in onto GRABBING GLORY approaching the 200 metres.

**LEONARDA** (E. Boyd) - jumped away awkwardly and was slow into stride. In the vicinity of the 500 metres improved onto the heels of PAM'S JOURNEY and had to be steadied. Had difficulty obtaining clear ground from the vicinity of the 400 metres and in the vicinity of the 200 metres had to alter course to the inside of SOPHINA DIVA, which shifted ground.

**NOW AND FOREVER** (J. Kah) - laid in under pressure in the straight. Lost its near fore plate during the event.

**PAM'S JOURNEY** (A. Chan) - inconvenienced shortly after the start. In the vicinity of the 500 metres improved onto the heels of TWICE FORGOTTEN and had to be steadied.

**SHINING BRIGHTLY** (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 3: DARLEY / SABOIS THREE-YEAR-OLD FILLIES MAIDEN PLATE – 1050 metres (cont'd)**

**SOPHINA DIVA** (J. Toeroek) – rolled in onto PAM'S JOURNEY shortly after the start. Raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight and in an attempt to improve shifted out in the vicinity of the 200 metres inconveniencing LEONARDA and GRABBING GLORY, which were both obliged to alter course. Rider reprimanded under AR137(a).

**TWICE FORGOTTEN** (A. Jordsjo) – rider reported that in her opinion the filly may have choked down during the event. A post-race veterinary examination revealed no visible abnormalities.

**GRABBING GLORY** (R. Clark) – approaching the 200 metres was taken in by GENNIKAY and shortly after was obliged to alter course to the inside of SOPHINA DIVA, which shifted ground, resulting in GRABBING GLORY being awkwardly placed between that filly's heels and LEONARDA for a number of strides.

**RACE 4: SCHWEPES HANDICAP - 1050 metres**

**ASCENDANCE** (J. Holder) – shifted in slightly on jumping away.

**EASY BEAST (NZ)** (M. Seidl) – inconvenienced shortly after the start when it rolled out slightly at the same time as ASCENDANCE rolled in slightly. In the vicinity of the 300 metres shifted out in an attempt to obtain clear ground and in doing so brushed STRAGUN. Rider explained after being inconvenienced shortly after the start the gelding had raced off the bit throughout the event and had only finished the race off fairly.

**STRAGUN** (J. Kah) – contacted in the vicinity of the 300 metres.

**CLASSY JACK** (R. Clark) – inclined to shift about in the early stages of the event. Rider explained that the gelding felt awkward in its action in the early stages and then again over the concluding 100 metres. A post-race veterinary examination revealed no visible abnormalities.

**RACE 5: TAB ADELAIDE CUP - MARCH 11 AT MORPHETTVILLE MAIDEN PLATE - 1200 metres**

**CHEEKYS BRO** (E. Boyd) – trainer fined \$100 under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified by records held by the Stewards. Raced wide without cover throughout the event. Laid out rounding the home turn and under pressure in the straight.

**ROCKWOOD BOY** (R. Hurdle) – on jumping away taken out across the heels of CHASE THE THRILLS and had to be checked and then became awkward in its action for a short distance.

**CHASE THE THRILLS** (D. Caboche) – shifted in on jumping away. Raced keenly in the early and middle stages of the event.

**MACSWEEN** (O Ridge) – shifted out on jumping away onto SURREAL IMAGE and then was slow into stride.

**SURREAL IMAGE** (J. Toeroek) – taken out on jumping away onto ROCKWOOD BOY. Raced keenly in the early and middle stages of the event. Laid out rounding the home turn.

**MIRUSIA** (N. Farley) – in the vicinity of the 150 metres was accidentally struck in the vicinity of the head by the whip of A. Chan. A post-race veterinary examination revealed the mare to be exhibiting signs of the 'thumps' and a poor recovery rate.

**LIS DE LUNE (NZ)** (A. Chan) – shifted about under pressure in the straight.

**RACE 6: 13CABS HANDICAP - 1800 metres**

**ANTIPAS** (A. Jordsjo) - raced wide without cover throughout the event.

**BUSKER'S BALLAD** (J. Kah) - had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

**AUTMED** (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

**REAL THINKER** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**EXALTED HONEY** (J. Holder) - slow to begin.

**DELLACQUA** (J. Toeroek) - held up from the entrance to the straight until the vicinity of the 100 metres.

**SYLVAN CREST** (A. Chan) - raced keenly in the early and middle stages of the event.

**EPERDUMENT** (J. Potter) - inconvenienced in the vicinity of the 200 metres when taken wider by SVETLANA'S ARROW.

**SVETLANA'S ARROW** (N. Farley) - shifted out in the vicinity of the 200 metres onto EPERDUMENT.

**RACE 7: ADELAIDE GALVANISING ALCOPOP SERIES FINAL - 1600 metres**

**SAVATAG (NZ)** (T. Pannell) - laid out over the concluding 800 metres of the event. A post-race veterinary examination revealed a poor recovery rate.

**CHAPEL CITY** (J. Holder) - held up from the entrance to the straight until the vicinity of the 200 metres.

**LITTLE AKIE** (J. Maund) - raced keenly in the early and middle stages of the event.

**BRAMFIELD** (D. Tourneur) - raced in restricted room over the concluding 100 metres when awkwardly placed between TSARITSYN and FULTON STREET, which had been taken in.

**ENKI** (A. Jordsjo) - raced fiercely in the early and middle stages of the event and in the vicinity of the 1400 metres had to be steadied momentarily when FULTON STREET shifted in.

**BILLET DOUX** - late scratching by order of Stewards at 3.00 pm owing to there being no rider available.

**FULTON STREET** (D. Caboche) - shifted in, in the vicinity of the 1400 metres onto ENKI. Rider reprimanded. Laid in under pressure in the straight. Taken in, in the vicinity of the 100 metres onto BRAMFIELD.

**EL DESPERADO** (A. Chan) - shifted out inside the 100 metres contacting PICTURE ME ROLLING.

**IMPULSE DIAVOLO** (E. Boyd) - laid out under pressure in the straight.

**SUPERVELOCE (NZ)** (M. Seidl) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. Inclined to lay in, in the middle stages of the event.

**JACKTHEGIANTSLAYER** (N. Farley) - jumped away awkwardly. In the vicinity of the 100 metres shifted in onto FULTON STREET, which was taken in onto PICTURE ME ROLLING. Rider severely reprimanded. Following the event N. Farley was reprimanded under AR91 for failing to seek Stewards' permission prior to leaving the course.

**RACE 7: ADELAIDE GALVANISING ALCOPOP SERIES FINAL - 1600 metres (cont'd)**

**TSARITSYN** (J. Toeroek) - jumped away awkwardly.

**PICTURE ME ROLLING** (D. Tootell) - shifted in, in the vicinity of the 100 metres and contacted EL DESPERADO.

**RACE 8: ADELAIDE GALVANISING HANDICAP - 1200 metres**

**REWARD THE DREAM** (N. Farley) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200 metres.

**TWO ODD SOX** (J. Holder) - shifted in on jumping away onto OUR BENEVENTO.

**SAND CAT** (A. Chan) - held up from the entrance to the straight until the vicinity of the 200 metres.

**TIARA STAR** (T. Pannell) - inclined to lay in under pressure in the straight.

**OUR BENEVENTO** (J. Kah) - shifted out on jumping away contacted EXALTED BLOOM and shortly after shifted back in onto TIARA STAR.

**RUSHWA** (D. Tourneur) - rider reported that in his opinion the gelding felt awkward in its action behind in the straight. A post-race veterinary examination revealed a minor laceration to the left hind fetlock.

**EXALTED BLOOM** (J. Potter) - contacted on jumping away.
